- **Background:** The Willaston Neighbourhood Development Plan was submitted to the Council in June 2017 and, following a statutory publicity period, proceeded to Independent Examination. The Examiner's report has now been received and recommends that, subject to some modifications, the Plan should now proceed to referendum.

The Council must now consider the recommendations of the Examiner and decide how to proceed.

The Council is committed to supporting neighbourhood planning in Cheshire East. It has a legal duty to provide advice and assistance on neighbourhood plans, to hold an independent examination on neighbourhood plans submitted to the Council and make arrangements for a referendum following a favourable Examiner's Report.
