Dear Madam/Sir

With regard to the Langley Cricket Club license renewal:

Having lived and worked in Sutton and Langley for the majority of my life Langley Cricket Club has always been a corner stone of our local community, like the Methodist Church, St. James Church, Sutton Post office and our local schools – of which Langley had once.

Now I am a local resident of Langley having lived in Sutton and attended Hollinhey Primary School. During those happy days we were often ferried up to the Cricket Club to enjoy local activities and sports days. It would be a terrible shame for these possibilities to come to an end and the building to fall into disrepute or at worse – developed into housing: open spaces and fresh air are essential for our children and community to relax in.

Having attended many social events at the club over the years and witnessed the course of investment which has substantially improved the club, it has never been my experience to have encountered disorder problems, drunkenness, or even violence. Living now as I do in Langley I have never been disrupted by any event to take place there: are we to stop fireworks because they light the sky momentarily, across fields and gardens?

When both my children were younger I took them to the club regularly to play cricket events and to relax and to allow them the space to run free knowing they were safe and always within sight, as I had a drink or two with friends. I never had any concerns for their safety other than it was my responsibility to care for them.

It is imperative that the club be granted the license. As it is a main source of income to keep the club going – which it has done since 1864 I believe.

Please help our community to maintain this very important venue for all the family by granting the license.

I am happy to add my voice to the campaign to support the application for a premises licence.

- I have lived in the village for 29 years, and I am a near neighbour to the ground. I am a trustee of the Village Hall and have been part of organising the Village Fete and other events throughout the time I have lived here;

- Whilst I have lived here, this village has seen its few amenities diminish: e.g. no shop any more; the education centre (previously used for field trips by CEC) sold as a private home; the pub (especially now) has been under intermittent threat; local community groups and activities struggle to maintain a viable level of interest.

- The viability of this valuable community resource is quite reasonably dependent (especially at this time) on being able to supplement revenues by using the amenities for events, in a properly controlled manner.

- Langley is not a sheltered housing scheme or a private development which exists for the enrichment of the residents via their house prices. It is, or should be, a living village, with old and young people living here, village based activities, a vibrant pub - and a good cricket club.

- There is no evidence for disorderly behaviour or undue drinking. Like any organisation, the club would be answerable if there were. I have attended games at the club and it has never been disorderly.

- The continued development of this club, with youth teams, women's teams and visible enthusiasm for training and inclusion of all should be the priority.

For these reasons I strongly support the application.

My wife and I are residents of Langley village, our property has a view from the garden that looks over to the Cricket ground. It was one of the reasons we purchased our property and to have the quintessential English village experience of the village pub close at hand and the sight and sound of leather being played off a willow bat is something we consider delightful.

We have met and visited the club and its members on many occasions and watched the membership grow particularly amongst the younger children who benefit from spending time learning new skills and making friendships that many will value for years to come. The younger team players are an essential part of the village community and are encouraged to develop into responsible young adults by their coaches and old team mentors.

The club has recently been skilfully renovated to enable it to raise funds to finance and cover the running cost incurred. It must be encouraged to use all its facilities to cover the considerable costs that are a part of running a sustainable cricket club. We attended a fund raising event at Christmas 2019 which was a total success. We did not witness any disruptive or drunken behaviour from people attending the function. I am writing to thank the Committee and yourself for the outstanding work done to keep the club afloat in these difficult times, and the professional manner in which the club has re-opened post-lockdown to offer a very welcome, and safe environment for the local community. I know how important the bar facility is, not only for the financial survival of the club, but also for the wider community of Langley and surrounding villages – so am writing to express my support for the upcoming licensing application.

My family lives reasonably close to the Clubhouse, and not being a particular follower of cricket was aware of the existence of the club, but never actually visited. In 2016 my then 13 year old son was invited to attend a free 'taster' session by the club. He thoroughly enjoyed the family atmosphere, and professional coaching that was offered, leading to him becoming a regular player for Langley CC. Over the years has hugely benefitted from the training, socialising and competitive nature of the sport that Langley CC offers. I would like to point out that there are very limited facilities, or activities organised for teenagers in this rural area of Cheshire, so to see 60 or so children enjoying training in a safe environment every Friday night is one of the highlights of my family's week.

Langley Cricket Club has become a great resource used not only by my son, but also many of his teenage friends, giving them something structured to do other than 'hang around' in a bus shelter, which could potentially lead to anti-social behaviour.

Other than watching cricket games and training, I have attended several fund raising functions organised by the club. Without fail each has been well organised, with fantastic catering and entertainment. The events are family-friendly, attended by people from a wide age range. Whilst these do continue later into the evening than a standard cricket game, there is minimal disturbance in this sparsely populated area of the village, and the behaviour of attendees, in all cases has been polite and convivial as you would expect from a community run club. I regularly attend similar events at the Ex-Serviceman's club, located in a more densely populated area in the neighbouring village of Sutton, the atmosphere, and noise levels are no different to the Cricket Club – so I see no reason why Langley should be discriminated against.

One final point I would like to make is that my frail 86 year old mother has been a resident, living close to the Club for well over 50 years. The events of 2020, including a lengthy self-isolation have been extremely difficult for her. Her release from lockdown coincided with the re-opening of the facility in Langley. As the club offers lots of outdoor space to socially distance, and has well organised and managed systems, this is the one place she feels safe to visit and 'socialise'. The players and helpers at the club should be commended for the way they have accepted and accommodated the older residents, moving furniture and making provision for them to enjoy meeting their friends and watching a game in a controlled and safe environment.

In summary I fully support the clubs licensing application The Club provides a much needed resource for the wider community, not just cricketers. It has a long and proud history of over 150 years in the village of Langley, and despite the current challenges presented by Covid, I

hope that the Club is granted the freedom to organise more family-friendly events to raise much needed club funds to allow it to continue for 150 more.

My children have played cricket at the club for the past 4 years, progressing from the AllStars scheme through the junior teams. I have also been a member of the women's cricket team for the past two seasons.

Junior cricket training has been such an important part of life for my children and my husband and I these past few years. Playing cricket in the community spirit that Langley creates means that children not only develop technically but also learn social skills improving their teamwork and growing in confidence in their interactions with adults as well as with children outside of their school bubbles. The health and well-being of young players is clearly at the heart of the coaching ethic and has never been more apparent than during the ongoing pandemic, when extensive measures were put in place to ensure ECB and government guidance was being followed or bettered, whilst making every effort to get activities back up and running when it was deemed safe. For many children who had been home schooled for months, the return to cricket training has made a colossal difference, a return to regular physical challenge, some normality and social interaction for children who had been isolated from their peers for so long.

In our experience, Langley is a very 'safe' and family spirited social setting. Aside from during the pandemic, we regularly stay after practice to enjoy a drink in the bar and are often joined by friends and grandparents. We have only ever witnessed people drinking responsibly and socialising is typically in small groups. It is lovely to see teenagers continuing to stay with the club and beginning to transition into the adult teams, mixing comfortably within this then familiar mixed-aged family-oriented social scene and keeping off the streets and away from games consoles as a result. It would be devastating if this wasn't an option for my children to continue to be part of. In my experience mixing in this way during these informative teenage years can make a massive difference to self confidence as well as learning appropriate attitudes towards responsible drinking and positive ways to socialise.

Having been actively involved in grass roots cricket for over 30 years I wanted to provide some input into the above application for a premise license.

Since the age of 13 I have been involved in grass roots club cricket, across various clubs in Northumberland, Hampshire and Cheshire, as a player, club Captain and Chairman, and based on that extensive history I have yet to come across a club with a more community centric approach than Langley Cricket Club.

As Chairman and Captain of a competing cricket club in Cheshire in the past I had a personal and professional envy of the way Langley was run at that time, especially around the junior cricket setup which provides for the future of the club and the sport in Macclesfield, and since I have more recently become involved with Langley as a player, husband of a player, and parent to two young players with the club I have been incredibly impressed with the professional way the Committee run the club, the support and expertise of the (unpaid) coaches, and the community feel of the club.

The 2020 season has been particularly challenging for all grass roots sports clubs, with CV19 severely limiting both the playing opportunities and the revenue making opportunities that the club has been able to provide, yet the committee have ensured that once training and playing was possible the adherence to the rules set out by central government and the ECB have been adhered to entirely, despite any potential financial impact that may have on the club.

Seeing my children back playing with the high quality of coaching and necessary equipment has been a joy to behold, and getting involved in the playing side of the game after a hiatus of 8 years has been extremely pleasurable despite the challenges CV19 rule adherence provides.

However, the club needs to create new revenue streams if it is to thrive and grow, which is incredibly important for the future of cricket in Macclesfield and Cheshire. Recent times have seen a significant drop off in terms of local teams participating in grass roots cricket, caused by financial pressures and the commercial value of green spaces for development. CV19 has only added to these already overwhelming pressures.

Despite this, Langley have continued to increase participation numbers across a diverse spectrum of teams – a full complement of junior teams, two senior league teams and a Sunday/Mid week team, and with the latest additions of both a girls and ladies team Langley really is the complete club. However, it will only be possible for this fantastic community club to continue to grow and thrive if their ambition is met by allowing the likes of the current application.

Having attended a number of events over the past 2 years, and having frequently spent time in the clubhouse I can confirm that the environment is one of family inclusion and fun, and when events go on into the evening there are reminders to contain any noise which may impact local residents, and where possible attendees are kept within the confines of the clubhouse with the doors closed.

In conclusion I would both recommend the club to anybody who wishes to be involved in cricket (and I regularly do) and request that the application under review be accepted to ensure that this vibrant grass roots cricket club be able to not only survive the current challenges presented by the CV19 pandemic, but be able to emerge into 2021 as a growing, thriving asset to the Langley and wider Macclesfield community.

He's now 31 years old. His father has played for LCC for over 30 years and is still now heavily involved in the club. I play for the women's team. And I hope that our future children can play for such a brilliant, welcoming, inclusive club.

LCC has recently undergone an extensive refurb which has extended our clubhouse and within that, installed a brand new bar. Covid compliant, the bar has an outdoor window hatch to serve friends and family of players. The bar and the events which are ran in the clubhouse are LCC's main source of income. This keeps the club afloat, and therefore keeps each cricket training session going and allowing games to be played. I spend most of my Saturdays (and sometimes Sundays) up at LCC within the bar area and pavilion, and have done for the past 7 years. We hope all residents and their families are keeping safe and well at this time.

For those who are not aware, Langley Cricket Club has been part of the village for 156 years. We are a true community club and facility, providing recreational and sporting opportunities for all age groups. We are the only Cricket Club in the local area, and we are very proud of the offering we provide to that area.

We have a Club House which provides refreshments for members and guests and we also carry out occasional events within our grounds. These events are vital in generating the revenue we need to continue to offer the sports facilities that we provide, and without them the future of the Club and the teams that play here would be in serious jeopardy.

I write further to a previous post in relation to concerns that some residents had raised with regards to noise coming from the Club during events.

As part of our response to these concerns, we made contact with Cheshire East Council Licensing to discuss various matters. One matter arising out of these discussions was that some tweaks would be necessary in relation to our Club Premises Certificate, namely to reflect the amendments made to the layout of the Club House since our Club Premises Certificate was granted, back in 2005.

Some of you may be aware that we attempted to lodge minor variation applications to address this, but that these have been refused by reason of objections being lodged against them. As such, we have taken advice with regards to the best next steps here, as we were not sure how best to proceed.

We understand that when objections are received to minor variations, this leads to automatic refusal. We need to address the matters contained within the minor variations, to regularise the layout, as this is something we have been advised by the Council to do.

Our options in order to address this are either to apply for a full variation of our Club Premises Certificate, or apply instead for a Premises Licence. We have determined that the latter is the best course of action, but we wanted to explain the reasons behind this to you so as not to cause alarm.

The purpose of a Club Premises Certificate is to provide licensable activities to club members and their guests. A Premises Licence allows provision of licensable activities to members of the public, something we have previously done (for example during the Winter Ball) through the use of Temporary Events Notices.

As such, we believe that a Premises Licence is more suitable for our purposes, and will mean that we do not need to go through the administrative process of applying for Temporary Events Notices every time we want to have one of these sorts of events going forward.

We would highlight that our current Club Premises Certificate does not contain any conditions restricting our operation, so the grant of the Premises Licence would mean imposing specific obligations on us which do not currently exist. We hope that this demonstrates to you our commitment to ensuring that we are good neighbours.

The Premises Licence Application will seek permission for licensable activities to the hours currently permitted by the Club Premises Certificate Sunday to Thursday, and slightly later on Friday, Saturday and Bank Holiday Sundays (to allow for the sorts of events I have detailed above). The hours we will seek will be until 11pm Monday – Thursday, midnight Friday, Saturday and Bank Holiday Sundays and 10.30pm on other Sundays (all plus 30 minutes dispersal).

We hope that this explanation will provide you with all the information you need in relation to this proposed application. However, if any residents have any queries, again please drop me an email. If anyone feels it would be beneficial to discuss this more generally, please also let me know and I would be happy to look into setting up a ‘virtual’ residents meeting. In usual times, I would have wanted to extend an open invite to the Club to explain the above in person and invite any questions, but obviously that is not possible in light of current circumstances.

#### **D) The Protection of Children From Harm**

1. A "Challenge 21" Policy shall be implemented in full and appropriate identification sought from any person who appears to be under the age of 21. The only acceptable forms of ID are photographic driving licences, passports, HM forces warrant cards, EU/EEA national ID card or similar document or a form of identification with the "PASS" hologram.
2. Staff training will include the Challenge 21 Policy and its operation. In particular, staff shall be trained to take such action as is necessary to prevent the sale of alcohol to persons over the age of 18 where those customers are engaged in the distribution of alcohol to persons under the age of 18. The training must be given to a new member of staff before they commence employment and all staff must receive refresher training every 6 months.
3. Notices advising what forms of ID are acceptable must be displayed.
4. Notices must be displayed in prominent positions indicating that the Challenge 21 policy is in force.

Thank you for your letter and the opportunity to view the amended Operating Schedule.

The amendments to the Operating Schedule are welcome, however they do not address my main concern which is that Langley Cricket Club has failed to enforce it's previous undertakings to reduce noise nuisance at outdoor events. The minor alteration to Paragraph C2 in the Operating Schedule does not, in my view, make a substantive difference to the undertakings that had previously been made and not delivered.

All the previous problems have arisen as a result of live or recorded music outdoors in a marquee i.e. not in the built premises. The alterations to Paragraph C7 are welcome but will not significantly change the problems caused by outdoor events. The application is for the provision of live and recorded music both indoors and outdoors. Removal of the outdoor element from the application would go much further in allaying my concerns.

You will be aware that Mr Stevens has previously written to me explaining that "These events are vital in generating the revenue we need". I note that the application states that the applicant is a recognised club but it seems that the issuing of this licence would lead to a change in function of the site from an area for outdoor sport (class F2(c)) to one for the performance of live music (class Sui Generis), with the aim of generating revenue while still potentially causing nuisance to the community it claims to serve. While I understand that change of function of the site is not a licencing issue, it seems to me, that it is inherent in the application. I am not aware of any planning permission to change the function of the site. My concerns might be eased if I knew that these issues had been addressed within Planning Regulations.

I am not sure what further discussion has to offer but of course if your client would like you to arrange a virtual meeting with residents I would be happy to participate. Unfortunately I am unavailable on Friday next week but other days are quite flexible for me at present.

I would highlight the following:

- My client would be legally obliged from the granting of this licence to carry out the noise monitoring detailed in condition C2. They of course cannot guarantee that absolutely nothing will ever be heard from outdoor events at the premises, but they have agreed to restrict occasions on which outdoor

events would take place later than 7pm to no more than 6 per year. They will monitor noise carefully on each of those 6 occasions.

- You mention that removal of any outdoor element would allay your concerns, but we would submit that the use of the outdoors beyond 7pm on 6 occasions per year is a very minimal use of that space.
- The issuing of the licence would not change the nature of the premises at all. The primary use would absolutely still be as a sports club, and this use is merely ancillary. As such, there are no planning implications.

Thank you for your letter and the opportunity to view the amended Operating Schedule.

Our objection to LCC premises licence application stands as per our representation. LCC have not previously adhered to licensing times and do cause distress due to excessive noise nuisance which led to a noise abatement order being served on the club, despite verbal agreements with residents and Environmental Health, nothing has changed since then.

Any extension to their licensing will only exacerbate the noise nuisance which we want to avoid. The fundamental principles of cricket being played have not been an issue for us over the past 30 plus years, it is the recent changes to the cricket club in expanding its social activities which have caused considerable noise nuisance particularly from the outdoor events having loud music from both within marquees and the use of outdoor speakers.

We do not feel further discussion necessary as LCC have already demonstrated that they are not willing to abide by their own written promises or Cheshire East Environmental Health guidelines.

Information of past incidents of noise nuisance have been documented in more detail in correspondence to Cheshire East Licensing and Environmental Health at the time of the incidents.

In my capacity as Clubs and Participation Manager for Cheshire Cricket Board, it has been pleasing to witness the rapid progress the club has made in recent years, both on and off the field.

Led by a strong and progressive committee with a clear vision, Langley is a cricket club at the heart of the local community. Membership numbers have increased considerably since 2017, including the formation of a new Women's team and the introduction of 'All Stars Cricket' for 5-8 year old boys and girls. Despite the significant challenges posed by Covid-19 this summer, the club have even managed to launch a new Academy Team, taking part in a series of Sunday friendly matches organised through the Cheshire Cricket Board 'Get the Game On' initiative.

As an (ECB) Clubmark accredited club, Langley have been certified by the game's governing body as "safe, effective and child friendly". The club were first accredited in 2017 and have completed several Annual Health Checks, reaffirming their commitment to good governance and strong child welfare practices. The next formal assessment is due in 2021.

As part of the Clubmark process, clubs are required to adopt and champion the ECB's Safe Hands policy, appointing two qualified Club Welfare Officers who have undergone Safe Hands training and hold up to date enhanced DBS certificates. All other volunteers working in close contact with children have been appropriately vetted. The club also have robust Codes of Conduct in place for players, members and guests and have also adopted the ECB Inclusion and Diversity policy, underlining their commitment to providing sporting opportunities for all.

With more than 100 junior members and competitive playing opportunities for boys, girls, men and women, Langley are one of Cheshire Cricket's most progressive clubs. The Cricket Board are fully supportive of the club's development aims and we trust this letter will assist those seeking greater understanding of the club, its leadership team and vision for the future.

**WITNESS STATEMENT OF MATTHEW STEVENS**

---

1. My name is Matthew Stevens and I am the Chairman of Langley Cricket Club. I make this statement in support of the application made by the Club for a new premises licence for the clubhouse and grounds; and in response to the representations received against this.

Background

2. I would firstly wish to give the Committee some brief background of the club's history, and then explain its current place within the Langley community.
3. Langley CC was founded in 1864, and the club played on a field set aside for that use by the owner of Langley Print Works, situated within the boundary of the factory grounds. The club become well known within the local area, and many of the factory employees and the villagers became members of the club. The club played their matches on this site for around 100 years.
4. In 1964 the factory closed and the club lost the use of its ground. As such, for the next nine years, they were forced to play away matches only, but managed to retain their players whilst doing so. Subsequently, in 1973, thanks to the hard work of the Committee at the time, and with the help of the people of the village and surrounding areas, the club moved to their present ground on Cock Hall Lane.
5. At the beginning, facilities were very sparse and with the absence of the support from the factory, all the funds required came from players and other friends of the club within the area. At this time, we changed in the village hall and travelled to the ground and had our teas in the local pub. All the cricket that was played at this time was on a friendly basis.

6. This changed in 1975 when Langley became founder members of the Cheshire Cricket Competition, playing against teams from Macclesfield, Congleton, Northwich and Hazel Grove. The club remains an integral part of the Cheshire pyramid system to this day.
7. In 2010 Langley applied to become a Community Amateur Sports Club (CASC). This was duly granted by HMRC and the club's constitution was updated accordingly.
8. By 2011 the club had reached a pivotal moment. Both adult teams were getting older and the need for investment back into the club was apparent. We received a grant to renovate the shower and toilet areas in line with new league guidelines and this was complete by the time the 2011 season started.
9. In 2012 Sport England were running a major grant funding initiative called Protecting Playing Fields, where funding could be directed into improving playing surfaces across many sports. The club applied and received a grant of £65,000 towards essential outfield drainage and playing surface improvements. The club also applied to and received £15,000 grant funding from the Landfill Tax Credit Scheme towards the outfield drainage. By 2013 the works were complete. These made an immeasurable difference to the ground. We installed a pedestrian entrance gate during this period which enabled the local community to come in and use our facilities all year round. This was very well received and to this day the community are able to use our facilities for general recreation throughout the year.
10. In 2014 discussions were taking place with the Parish Plan Steering Committee regarding a gap they had identified in the local area that the cricket club could potentially help with. Sally Hammill wrote:

*“The Parish Plan for the Parish of Sutton, Macclesfield, was published in October 2012. One of the major concerns of residents who completed the questionnaire (58% of residents returned completed questionnaires), was the lack of facilities & activities for children of the parish, especially in the 12-18 age group.*

*The Steering Group is working hard to finds way to improve play facilities for younger children as well as working with local groups to provide opportunities older groups. With this aim we intend to work closely with the Langley Cricket Club in their aim to provide coaching & sporting facilities available to all local children.*

*We are very happy to support the Cricket Club in their plans for future development and improvements as it will provide much needed opportunities for many of our children who need organised, structured play provision in a safe environment, close to their homes.”*

11. To fill this gap in local provision the club re-started a junior section in 2014. We applied for and successfully received £7,000 funding from Sport England towards junior equipment and invested in 2 volunteers to become qualified coaches to run the sessions. We also received grants from 3 different funders towards the installation of £7,800 artificial match pitch for training purposes. Our junior sessions started with 6 juniors and 2 volunteer coaches. Throughout the year and into the close season the club engaged with local schools and the numbers of children began to steadily increase. Indoor sessions over the winter and into 2016 also led to more volunteers wanting to become coaches.
12. Over the next 2 years the junior section grew to unprecedented levels. We created junior teams at under 9, 11, 13 and 15 levels and increased our number of volunteer coaches from 2 to 8. The numbers of juniors participating in training and games grew year on year and the cricket club was becoming a real central hub for the community. However, one thing letting the club down was the lack of a modern clubhouse to go with the wonderful setting.
13. In 2015 the club applied for and were awarded £8,500 towards new ground equipment so we could maintain the new outfield and playing surface using modern equipment. This made a terrific difference to the playing surface and our annual league pitch and outfield marks began to improve.
14. In 2016 a project to extend and modernise the clubhouse was started. One of the key aims of the project was to open our facilities up to use by the local community. We

had sent a survey out to the local community and 98% thought it was a good idea with 92% saying they would use the facility in the future. This was by far the biggest project the club had engaged in since the move to our Cock Hall Lane ground. We applied to and were successful with 5 funders and started the work in late 2016. The club also raised £20,000 towards the cost through organised events and fund raisers. The work was complete by the start of the 2017 season and it created:

- A new bar area with the ability to serve cask and barrelled beer
- A new kitchen facility
- A new junior equipment store
- A modernised club-house room
- Refurbished toilets with baby changing facilities
- An extended outdoor patio area

15. There is no doubt the extension and modernisation of our clubhouse led to a surge in people attending the club and participation levels across the juniors and adult teams. The Friday night junior training sessions were a focal point in the week for many local people, with new friendships made that are still going strong today.

16. In 2017 Langley Cricket Club were awarded ClubMark status for the very first time. Andrew Jackson, Macclesfield Cricket Development and Coaching Officer, commented:

*“The Cheshire County Manager reviewing the club’s documentation, policies and procedures had only minor changes to make which highlights the level of detail that the club has ensuring everything is run with due diligence – a brilliant remark considering how quickly you have got the junior section going.”*

17. In 2018 one of the volunteer coaches approached the club with the idea of creating a women’s team – a first in our 154 year history. This was universally greeted with excitement as women’s cricket is one of the fastest growing sports in the UK, and especially in the Cheshire region. Indoor training sessions were booked and the

response was fantastic. By 2019 the women's membership base had grown to 20 training and playing in softball tournaments on a regular basis.

18. In 2018 the club held its first firework display and this was very well attended by people in the community.
19. In 2019 the Cheshire Girls Under 13s team played a county game against Derbyshire Under 13s Girls at the club, and this was the first time the club had been asked to host a county organised event.
20. In late 2019 the club decide to start a girls' team with the ambition that the girls would start to integrate into the women's set-up and provide a constant stream of future cricketers. In 2020 the girls' and women's teams have entered into leagues and we played our first competitive games – again another first in our long history. We also started a 3<sup>rd</sup> team to give our juniors the chance to play senior cricket. With the help of the Cheshire Cricket Board we arranged fixtures and provided 18 of our juniors with regular senior cricket.
21. Our team of volunteers devote hours and hours of their free time to ensuring the club is run effectively and efficiently, providing opportunities and life long memories for children and young people and keeping the club's 156 history legacy going for many years to come. The club is looking to put itself in the best position to secure its future, whilst fulfilling the hopes and aspirations of people local and the surrounding areas.
22. To summarise, over the last few years, the club has achieved the following:
  - Over £200,000 in grant funding from 12 different funding bodies for key club projects over a period of 8 years.
  - ClubMark accredited.
  - 2 qualified volunteer Child Welfare Officers.
  - 12 volunteer ECB qualified coaches with a junior committee managing the section.

- Mixed junior teams at All Stars, under 9, 11, 13 and 15 age groups with over 100 children participating on a weekly basis throughout the cricket season.
- 3 senior adult teams.
- Women's team playing league cricket.
- Girls Under 13 team playing league cricket.
- More junior parents requesting to become volunteer coaches ready for the 2021 season.
- The prospect of our newly formed 3<sup>rd</sup> team playing league cricket in 2021.
- An opportunity for local children and young people to regularly participate in recreational and sporting activities whilst enhancing their social skills and making lifelong friends.
- The ability for friends and families of all ages to come together and socialise in a safe environment.
- An accessible large open space area available for use by everyone in the local community all year round.
- A fully modernised clubhouse with bar and catering facilities.
- A strong dedicated volunteer committee pulling in the same direction to provide Langley and the local areas with a unique and deserving facility that is available to everyone.

### Licence Application

23. I strongly believe that we are successful in achieving all of the above, whilst also being respectful of our neighbours and the local community at large. I am supported in that view by a large number of local residents and supporters from further afield. I attach support from local residents at Exhibit MS1 and support from further afield at Exhibit MS2.

24. However, I am of course aware that there are some local residents who disagree, and who have made complaints about the operation of the club both in the past and in relation to this application. These residents initially complained to us about noise emanating from some outdoor events we held, under temporary events notices.

25. We as a club consider ourselves to be a community asset, and as such, as soon as we received these complaints, we made a point of reaching out to the residents to discuss. We do not want to operate in such a way as to cause any issues to the local community.
26. I held a meeting with those who had complained in August 2019, and as part of our action points following this, assured them that we would contact Cheshire East Council to seek advice on managing noise levels at events. I should highlight that we are a cricket club, not an events venue, and this will continue to be the case. However, we hold events as ancillary to the cricket activity, and as a result of these complaints we have sought to educate ourselves further on managing these, both through liaison with the Council and through seeking legal advice. I believe that we have acted responsibly and appropriately in this regard.
27. On taking advice from the authority, one matter which arose was that some changes would be necessary in relation to our existing CPC – to reflect changes to layout that had been made in respect of the Club House since our CPC was originally granted.
28. As such, and as advised, we lodged a number of minor variations seeking to address this. These were refused by reason of representations submitted against them by the residents who had previously complained. It was at this point that we decided that it would be sensible for us to seek legal advice. When we did so, we discussed the options open to us, which included varying our CPC or applying for a new premises licence.
29. The reasons for our decision to apply for a premises licence were set out to the community at large, and to the residents who had previously complained, well in advance of us submitting our application, together with an invitation to speak to us with any concerns/queries.
30. The wording at Exhibit MS3 was posted on the village social media page, and the letter at Exhibit MS4 was sent to the group of residents who had previously complained. I would draw the Committee's attention to these, as they explain our motivations for this application.

31. We received a huge number of positive and supportive comments on our social media post. We received one direct contact from a member of the community, the landlady of a local pub, who was supportive but concerned to know whether this application would affect her rural rates relief. We undertook, through our solicitors, to make enquiries of a ratings expert to ensure that this would not be the case and provide her with that confirmation. Her relief is not affected because our licensable activities are purely ancillary to the use of the grounds for cricket activities.
32. We also sent details of our proposed application to Sutton Parish Council, and awaited lodging the application until after they had had the opportunity to consider this at their meeting on 23<sup>rd</sup> July 2020. They subsequently resolved that they were satisfied with the application subject to the limit of 8 external evening events that we had proposed.
33. As such, there was a significant period of time between us notifying the community of our proposals (in mid-June) and us lodging the application in early August 2020. We did not receive any direct responses or queries from the residents in that time.

#### Representations

34. During the consultation period, we received some correspondence from the Environmental Health Team at Cheshire East Council. We were happy to agree some amends/additions to our operating schedule to ensure that they were confident that our proposals were acceptable. For clarity, I attach at Exhibit MS5 a revised operating schedule which shows the agreed position we have reached.
35. Importantly, the amendments include:
- Reduction of the number of events which will take place externally beyond 7pm to 6 per year (from 8 as proposed in our application); and
  - Restriction of external licensable activities to 23:30 on any day.
36. We wrote (through our solicitors) to each of the residents who had made representations to explain these amendments and to invite them again to speak with us in advance of the hearing. I attach the correspondence we have had in relation to this



at Exhibit MS6. With the exception of Mr Gilbert, who was kind enough to join a 'Zoom' call to speak to us, we either have not received a response or have received a response indicating that there was no desire to discuss matters further with us.

### Licensing Objectives

37. As such, whilst these matters will be addressed in detail at Committee, I would like to take the opportunity to highlight that I believe we have policies, procedures and safeguards in place that will ensure that, should our licence be granted, the licensing objectives will be upheld.
38. There has never been any crime or disorder associated with the club or with any events, and there is no reason to believe that this will occur in the future. The sorts of events we are talking about are community focussed, and our clubhouse is simply used for members and families/friends for drinks around cricket activities. Our operation simply does not have the propensity to undermine this objective.
39. As a sports club we naturally have to be very conscious of public safety in terms of the way we operate, and this also extends to protecting children from harm. I am happy to discuss and explain the incident referred to in some of the representations when an air ambulance was called for a child during the course of the Committee hearing. However, in general what I would say is that we have an exemplary record in this regard as confirmed by the Cheshire Cricket Board Clubs & Participation Manager – correspondence from whom is at Exhibit MS7.
40. In terms of public nuisance, we are acutely aware of allegations that our operations have caused a nuisance, and are committed to ensuring that this is not the case. This is demonstrated by our commitment to seeking advice on this matter. We have invested in sound level monitors for external events, and have offered conditions that require these to be used when regulated entertainment is taking place externally. We have committed to licensable activities not taking place externally after 23:30.
41. Finally, and importantly, as noted above, we have committed to having no more than 6 events per year which carry on outside beyond 19:00. This means that the outside

area will only be used for licensable activities between 19:00 and 23:30 6 times a year – an average of once every 2 months.

42. We believe that this presents a sensible and reasonable compromise – it allows us to carry out the sorts of events we need to generate revenue whilst committing us to a very restrictive permitted usage of the outside space in the evenings.
43. We do need to be able to generate revenue from the bar sales within the clubhouse, and from a small number of events per year to allow us to cover the day to day running costs of the club. These are significant, but they allow us to provide the excellent community facilities detailed above. All funds raised by events and through sales in the club house go back into the club for continual improvements in provision, equipment and facilities.
44. As such, we need this licence to be able to continue and secure the long term future of the club. We are not asking for any more than what is necessary in order to do that – indeed, we have actively sought to restrict our licence as much as possible (e.g. by agreeing to this limit of 6) so as to be as neighbourly as we can be.
45. I hope that the Committee consider what we are proposing to be a reasonable and proportionate balance between these competing interests, and I am happy to assist with any further queries they may have during the course of the proceedings.
