**KEY ISSUES**

Further discussions have taken place with Environmental Health regarding the potential noise arising from the proposed use, particularly from the “Club RYZE” events for younger patrons to attend until Midnight on Friday and Saturdays. They note the proximity of residential dwellings to the West of the site, and the potential for noise from amplified music to cause disturbance, but do not propose to condition the application as there is other legislation to control noise. However they do advise that it would be prudent for the applicant to have a written noise management plan to ensure they effectively manage noise.

Whilst future noise issues could be addressed by Environmental Health under separate legislation, in order to ensure a satisfactory relationship with neighbouring properties for the purposes of the planning application, it is considered to be necessary to require a noise management plan to be submitted, which can be dealt with by condition.

**CONCLUSION**

As in the original report, it is recommended that the application is delegated to Planning and Enforcement Manager to approve subject to the conditions listed in the original report, and the additional condition below, to allow a press advert to be placed in the local newspaper.
