8 CALL IN OF CABINET DECISION - CE09/10-10 CAR PARKING CONTROL AND CHARGING IN THE AREA OF THE FORMER BOROUGH OF CONGLETON

The Committee reviewed the Cabinet decision of 16 June 2009 for car parking control and charging in the area of the former Borough of Congleton.

Councillor Baxendale attended the meeting to explain the reasons for the Call In. The Portfolio Holder, Head of Service for Safer and Stronger Communities, Parking Manager and Legal Consultant attended the meeting to explain the background to the decision and answer to any questions.

Councillors S Jones, L Gilbert, A Kolker, A Moran, B Moran and A Thwaite also attended the meeting to speak in respect of this item.

Members raised questions relating to the consultants report being flawed and inaccurate, the proposed parking charges, the number of car parks and parking spaces taken into account, the consultation process, residents parking schemes, civil enforcement and proposed tariff bands.

The Portfolio Holder confirmed that resident parking schemes would be considered for every town and that tariff bands were being developed in time for the 20010/11 budget.

Due to having a personal and prejudicial interest the Portfolio Holder withdrew from the room once he had explained the reasons for the decision and answered any questions.

Following detailed consideration of the explanations and reasons for the decision, the Committee decided to offer the following advice to Cabinet:

- 1. That Cabinet ensure that the facts and figures contained within the report are correct
- 2. That the charging policy be standardised across the Borough
- 3. That parking be free of charge for the first hour
- 4. That the consultation period for the off street car parking order be extended to two months
- 5. That the Council's Parking Strategy be adhered to.

Members also agreed that in future any policy issues should be submitted to the relevant Overview and Scrutiny Committee prior to Cabinet consideration.

- 1. Subject to statutory consultation, an amendment be made to the Borough of Crewe and Nantwich (General) (Off-Street Parking Places) (Consolidation) (Minor) Order 2008 to introduce a pay and display system of parking at Thomas Street Car Park, Crewe;
- 2. Charging be introduced at the Thomas Street Car Park at the level of charging existing in the said 2008 Order but with amendments as follows: Monday to Friday inclusive 8am to 5pm: Up to 1 hour = 70p; Up to 2hrs = £1.00; 2-4hrs = £1.50; 4 to 10hrs = £2.20; Saturday and Sunday: free parking. Season tickets will also be sold at a fee of £400 per annum, limited to a maximum of 50% of available bays;
- 3. The additional set-up costs referred to in the report be funded via the new income stream; and
- 4. The proposal be advertised for the statutory period of 21 days and any objections be considered by the Cabinet Member at a subsequent meeting.

Subject/Title: Introduction of Parking Charges on Thomas Street Car Park,

Crewe

1.0 Report Summary

1.1 The purpose of this report is to consider a proposed amendment to the Cheshire East Off-Street Parking Places Order (Crewe and Nantwich) to introduce a pay and display system of parking at Thomas Street Car Park, Crewe and to approve the proposal subject to the outcome of a further 21 day statutory period of public consultation.

2.0 Recommendations

That the Cabinet Member for Environmental Services approve

- (1) that subject to statutory consultation, an amendment be made to the Cheshire East Off-Street Parking Places Order (Crewe and Nantwich) to introduce a pay and display system of parking at Thomas Street Car Park, Crewe;
- (2) that the car park be brought in line with current charges at other car parks, but with amendments, as follows: Monday to Friday inclusive: 8am to 5pm: Up to 1 hour: 70p; Up to 2hrs = £1.00p; 2-4hrs = £1.50; 4 to 10hrs = £2.20; Saturday and Sunday: free parking. Season tickets will also be sold at a fee of £400 per annum, limited to a maximum of 50% available bays.
- (3) that the additional set-up costs referred to in paragraph 8.3 of the report be funded via the new income stream; and
- (4) that the proposal be advertised for the statutory period of 21 days and any objections be considered by the Cabinet Member at a subsequent meeting.

3.0 Reasons for Recommendations

3.1 Thomas Street Car Park meets Cheshire East Parking Strategy criteria for the introduction of charging in that it is close to town centre and retail outlets.

- 6.1 This proposal brings Thomas Street Car Park, Crewe into line with the car parking strategy and charging policy approved by the Cabinet. In addition, Improved control of traffic access and circulation may improve air quality.
- 7.0 Financial Implications for Transition Costs (Authorised by the Borough Treasurer)
- 7.1 None
- 8.0 Financial Implications 2009/10 and beyond (Authorised by the Borough Treasurer)
- 8.1 It is estimated that income of £68,000 p.a. should be achieved for the whole Thomas Street site.
- 8.2 Income in year 2009/10 of £45,000 is anticipated if charging commences in August. 2009.
- 8.3 In year 2009/10 estimated one-off expenditure of £8,000 is required to implement pay and display charging- ie. to install meters, signs and cover statutory advertising. Thereafter, additional annual expenditure specific to the site is estimated at £1,200 to cover meter maintenance, vandalism and cash collection.
- 9.0 Legal Implications (Authorised by the Borough Solicitor)
- 9.1 The charges can be imposed and regulations enforced on this car park within the existing terms of the Off Street Parking Places Order and under the provisions of the Traffic Management Act 2004. This is considered to be a "non-Key Decision " within the Cheshire East definition in that it affects one Ward only and is below £100,000 in financial effect and is therefore appropriate for Portfolio Holder decision.

10.0 Risk Management

10.1 In present economic circumstances there is considerable risk to original forecast income levels. However imposition of charges will allow some payback of refurbishment and operational costs to

begin.

11.0 Background

- 11.1 The former Crewe and Nantwich Borough Council and Local Joint Committee gave initial approval, subject to statutory consultation, to the proposal to introduce pay and display charging on this car park.
- 11.2 Thomas Street car park remains one of a few car parks near the town centre of Crewe with no pay and display charge regime. The proposal was initially approved by Board on the grounds that as demand for parking in the town increased, regulation of this car park would be necessary to improve space availability.
- 11.3 Owing to prevailing economic conditions, Crewe and Nantwich Borough Council then decided to defer a decision on this matter for review along with all other car park charges by Cheshire East Council after April 1st 2009.
- 11.4.1 This review has taken place and the Cabinet adopted a Car Parking Strategy at its April 16th meeting. This Strategy stipulated that in principle all car parks could be considered for charging subject to the fulfilment of criteria stated within the charging policy as follows:

1.1.1 **Charging Policy**

Policy: This Authority will in principle impose charges for parking at levels reflecting local pressures and needs. These may vary:

- as between the different towns and smaller centres
- as between zones within the larger towns

Car parks currently not having charges will be reviewed and the need for application for charges considered in the light of the criteria stated above. Any charges imposed will be designed to regulate use and improve availability as well as diverting long stay away from very central locations. Income earned should cover operating and maintenance costs and allow necessary improvements to the useability, environment and security of a number of these sites. The new authority has inherited a number of off street car parks for which there is no charge. It is intended that parking charges will be considered only on those sites for which a good case can be made under the above criteria.

The reason for the particular charge regime was to accommodate the needs of many community based users of the Cumberland Sports Track.

(Cabinet Member for Environmental Services 9th July 2009)

1. Introduction

- 1.1 The above Cabinet Member decision was called in for further consideration by the Environment & Prosperity Scrutiny Committee on 13th July 2009.
- 1.2 The reason for call-in, contained within the Notice, is;

"that the decision will have a detrimental effect on the income of the shop and office workers who are employed in the Town Centre of Crewe."

2. Response to the Reason for Call-In

2.1 The proposed charges for Thomas Street Car Park are in-line with Cheshire East's Car Parking Strategy agreed at Cabinet on 21st April 2009. The Charging Policy contained within this Strategy states that;

<u>" 5.0 Local Parking Policy</u>

5.1 Charging Policy

Policy: This Authority will in principle impose charges for parking at levels reflecting local pressures and needs. These may vary:

- as between the different towns and smaller centres
- as between zones within the larger towns

Car parks currently not having charges will be reviewed and the need for application for charges considered in the light of the criteria stated above.

Any charges imposed will be designed to regulate use and improve availability as well as diverting long stay away from very central locations.

The new authority has inherited a number of off street car parks for which there is no charge. It is intended that parking charges will be considered only on those sites for which a good case can be made under the above criteria.

- 2.2 Thomas Street Car Park is located close to the Town Centre (approx ¼ mile from Marks & Spencer store). All other Town Centre Car Parks within that radius (and beyond) are already charged.
- 2.3 Civil Enforcement of on-street parking has led to increased occupancy of Crewe's Town Centre Car Parks. There is a greater need to regulate this through the introduction of a charging regime in Thomas Street.
- 2.4 Thomas Street Car Park will now be patrolled and enforced by Civil Enforcement Officers. Their increased presence will have a beneficial effect on crime reduction and prevention and improve the security of vehicles parked there.
- 2.5 The costs of improvement works, operational costs and regular maintenance will now be borne by the users of the facilities rather than the Council Tax Payers as a whole. The planned improvements works (£90k capital investment) will not go ahead unless charging is introduced to recover these costs. (A £120k scheme has already been undertaken at this site).
- 2.6 The proposed order will amend the Borough of Crewe and Nantwich (General) (Off Street Parking Places) Order to introduce a pay and display system of car parking on Thomas Street East and West Car Parks, restrict waiting as indicated in the report and introduce further restrictions to ensure its proper management and use.
- 2.7 The hours of charging have already been adjusted to allow for the frequent use of the car park by users of the leisure and sports facilities at Cumberland Track. This concession has been made owing to the unique position of this car park in this respect and in recognition of the needs of leisure users following previous consultations.
- 2.8 The improved control of parking which should result from charging would benefit the economies of the town centre, as the principle is to remove long stay parking from very central locations, freeing up spaces for shorter stay customers and visitors. This also discourages non-essential car use in general.
- 2.9 The former Crewe & Nantwich Borough Council and Local Joint Highways Committee gave initial approval, subject to statutory consultation, to introduce Pay & Display charging on Thomas St. Car Park.
- 2.10 The forthcoming development of Lyceum Square will see a reduction of 11 shoppers spaces. Regulation of this car park is therefore necessary to improve space availability in the Town Centre.
