PROCEDURE FOR HEARINGS - LICENSING ACT 2003

The Licensing Committee

The full Licensing Committee consists of fifteen elected Members of the Council. From this full Committee will be drawn sub-committees of three members to deal with licensing functions under the Licensing Act 2003. The Chairman and Vice Chairman of the Licensing Committee shall have the discretion to refer a matter up to a hearing of the full Licensing Committee.

Officers at Hearings

- The Committee Officer introduces all parties and records the proceedings
- **The Legal Adviser** provides independent advice to the Members on legal matters and procedure.
- **The Licensing Officer** will introduce the matter and outline the application; the officer will also answer any questions Members may have.

PROCEDURE

NOTE: If the Sub-Committee has not already elected a Chairman, that will be the first item of business.

1	Chairman	The Chairman will: (i) call the matter to be considered; (ii) call for any declarations of interest; (iii) ask all parties to introduce themselves; (iv) summarise the procedure to be followed at the hearing; (v) will consider any request made by a party for another person to appear at the hearing; (v) will advise the parties of any maximum period of time in which it has to present its case (if a maximum is imposed this shall be equal for all parties).
2	Licensing Officer	Will introduce and summarise the application, highlighting areas of contention or dispute.
3	Committee Members	May ask questions of the Licensing Officer
4	Applicant	Will present his/her case, calling witnesses, as appropriate. (If necessary, applicant will produce any notices required by law. Legal Adviser will draw attention to this if required.)
5	Responsible Authorities (who have made representations)	Each in turn may ask <u>questions</u> of the applicant, by way of clarification.

<u>Notes</u>

- 1. The hearing shall normally be held in public. There may be occasions on which the Committee find it necessary to exclude members of the press and public; any such decision will be taken on the basis that the public interest in doing so outweighs the public interest in the hearing, or that part of the hearing taking place in public.
- 2. The Chairman may require any person behaving in a disruptive manner to leave the hearing and may (a) refuse to permit that person to return, or (b) permit him/her to return only on such conditions as the authority may specify, but any such person may submit in writing any information which they would have been entitled to provide orally if they had not been required to leave.
- 3. Prior to the hearing each party shall have given notification and served documentation (eg statements of witnesses or reports of experts) as required. Late representations and evidence will only be considered with the agreement of all parties.
- 4. Anyone entitled to be heard may be represented by any person, whether or not that person is legally qualified.
- 5. Hearsay will be permitted but the Sub-Committee will be reminded to give it appropriate weight.
- 6. Due note shall be taken of the provisions of the Hearings Regulations 2005.
- 7. The Chair may, in the interests of expediency or convenience of the parties, vary the procedure from time to time, provided notice is given to the parties and the rules of natural justice are observed.

- 12 Committee/Sub-Committee returns to announce its decision to all present.

Responsible Authorities

11.6.1 The Police state in their response: Application received 7 December 2009 for the Variation of Premises Licence which relates to the premises presently known as No 15 Wine Bar, 15 London Road, Alderley Edge.

The premises are currently closed and undergoing comprehensive restoration with a new Premises Licence being issued in July 2009 following the previous owners of the property going into liquidation. The Premises Licence was subsequently (in November 2009) transferred to the present leaseholders – Magnolia Bell Limited – who have taken out a 25 year lease on the property. Part of the Living ventures group the operators are seeking to extend the hours for the sale of Alcohol & Provision of Regulated Entertainment on Thursdays until 0200 and on Friday & Saturday until 0300 plus extending the hours for the same activities on non standard timing dates as listed in the application.

I initially had concerns in relation to the 3.am. finish times at weekends etc., but the operation will still be essentially restaurant led with music in the form of solo/duo/trio singers or musicians from 9.pm. until around midnight with a disco thereafter.

Good quality digital CCTV will be installed and it is already company policy to employ Registered Door Staff at their premises and this will be no exception.

I understand Environmental Health have requested that certain time restrictions are agreed in relation to the use of the rear garden area and first floor balcony.

I understand also that the DPS or deputy will be encouraged to attend any local Alderley Edge Pub Watch Meetings.

Subject to agreement that the following 'Conditions' are placed on the new Premises Licence there are No further Police representations:

- 1. That SIA Registered Door Security are employed at the premises onthose nights when the premises operate until 2 & 3.am. and on other nights when it is deemed practical due to non standard timings being used.
- 2. CCTV to be installed at the premises and digital records kept for evidential purposes for a minimum of 28 days and made accessible to Police or Local Authority Officers.

The premises are likely to re-open in mid to late 2010.

11.6.2 The Environmental Health Officer states in his response: Subject: Premises Licence Variation: 013822 No.15 Wine Bar, London Road, Alderley Edge

Further to the above application to vary the licence, I can report as follows:

Page 9

The Environmental Health Service has no record of complaints from local residents / businesses in connection with public nuisance problems emanating from operations at the No.15 Wine Bar under the existing licence reference:PR/062.

The existing licence facilitated a termination of opening hours of 00.30 Sunday to Thursday and 01.30 hours on Fridays and Saturdays. The application to vary seeks an increase in opening hours proposing a terminating time of 02.30 on a Thursday and 03.30 hours on Fridays and Saturdays. I have no evidence to support an objection to this proposal, since as stated the Environmental Health Service has no record of Public Nuisance problems.

That said, I am concerned that the premises have an outdoor rear garden area and a first floor rear balcony which although not currently regulated could in my opinion conceivably generate noise and disturbance problems to local residents caused by customer activities in the external environment at sensitive times. This matter was discussed on site with Mr. Jeremy Roberts who is understood to be the applicant and acting Designated Premises Supervisor for the existing licence on the 30th January 2009. Mr. Roberts was agreeable to a condition to restrict the use of the outside rear garden and first floor rear balcony such that the rear exterior licenced areas shall not be used after 22.00 hours.

I therefore have no objections to the application subject to this agreed condition and a further condition requiring all rear doors and rear windows to be closed whilst regulated entertainment is being carried out.

I understand that the premises will be 'food led' during the day and early evenings and that a significant refurbishment of the premises is planned (including sound proofing) to be carried out in the new year. I am not of the opinion that live and recorded music will cause a problem, since I am informed that the music is intended to compliment dining and may be considered to be 'low key' such as the use of acoustic instruments and jazz type trio's.In addition, it is proposed that customers who need to smoke after 22.00 hours may do so at the front entrance and I am not of the opinion that this will cause public nuisance, in view of the site location.

In conclusion and in view of the foregoing, I have no objections to this application subject to the following conditions:

- 1. The use of the rear external licenced garden area and the rear external licenced first floor balcony shall only be used between the hours of 09.00 and 22.00 hours.
- 2. All rear doors and rear windows shall be kept closed whilst regulated musical entertainment is being carried out.

Dear Sir/Madam,

We are writing to object to the proposed change of opening hours and sale of alcohol to the above premises. As a resident of Clifton Street, which is directly behind the premises in question, we feel the proposed new extended opening hours and extension of a late licence from 11am to 2am Thursdays, 11am to 3am Friday, Saturdays and Sundays will be completely disruptive to local residents. I find this proposal totally unacceptable for the following reasons:

- 1. Ruin of personal enjoyment of our quiet residential street, due to noise levels, which has been exacerbated recently by the building of the new Tesco store.
- 2. Noise pollution from people leaving at 3am as they may park or walk down our street, therefore disrupting our enjoyment of the street.
- 3. Safety issues of increased volume of people on our street at such anti-social times.
- 4. Potential for alcohol and drug abuse and such safety concerns these issues carry with them.
- 5. The number of late licensed premises already in the village. For such a small village we do not have a need to have any more late venues.

We hope that you take our concerns on board and do not grant permission of the late hours and extended alcohol licence for the above venue. As residents of Clifton Street we have had enough disruption over the past 20+ months and feel this will only add greatly to the disruption and safety concerns on our street.

I'm writing to object to the application to extend the license for the No. 15 wine bar on London Road, Alderley Edge SK9 7JT

They are applying to stay open until 3am or 2am every night instead of the current 11pm, a huge extension. They also wish to play loud music in the middle of the night in a far from soundproof building adjacent to people's houses. If permitted this would create a noise nuance for people who live nearby, particularly as people don't stay inside a bar anymore. The hang around outside so they can smoke.

There is hardly any parking space on London Road so many of the customers of the bars and restaurants on London Road park in nearby residential streets, such as Clifton Street around the corner from the bar, where I live. Some of them make a great deal of noise as they leave between 11pm and midnight. This would be much worse if it was after 3am. After leaving somewhere loud, even the people who think they're being quiet are loud. This is also the case for people leaving on foot.

This is not appropriate so close to housing in a village with no police to deal with any trouble.

Please reject the application.

Dear Sir or Madam

I am a long-time resident of Alderley Edge, I am writing to express my concern about recent Application from Magnolia Bell Limited to extend the licensing hours at 15 London Road, Alderley Edge.

As a resident who lives less than 300 yards from the premises, I am strongly objecting that the extended licence be refused.

It is clear from the details posted on the door of the restaurant and not sent to local residents that the premises application constitutes a change of use from a restaurant premises to a late night bar/night club with music etc indoors and possibly outdoors in the garden to the rear of the premises until 2am on a Thursday and 3am on a Friday and Saturday 52 weeks a year and bank holiday Sundays.

My wife and I are objecting to the grant of a licence extension on the following grounds.

1, Prevention of Crime and Disorder.

There is almost a constant low level of crime in Alderley edge already. This manifests itself in people urinating and vomiting in the street, smashing bottles and glasses, shouting and swearing etc. Having a further late licensed premise will only exacerbate this already unacceptable situation.

2, Public Safety

You will already be aware that the garden to the rear of the property is very close to the residents of Clifton Street and Tyler Mews. There is a footpath/ Alley way to the rear of the proposed Tesco site that is next door to 15 London Road. This already attracts local and youths from out of the area to congregate and could be a magnet for anti social behaviour, drug and alcohol abuse. Conversion from a family restaurant to a late night drinking venue will only encourage anti social behaviour to the residents of Clifton Street further. The Local police force is already stretched by covering Wilmslow and Alderley edge.

3, Prevention of Public Nuisance

It is my understanding that the council have to prevent public nuisance and having a late night bar so close to us will inevitably cause a public nuisance to the residents by being kept awake at night by creating noise from revilers walking down or who have parked on Clifton Street

4, Protecting Children from Harm.

I am already concerned by the increase in underage drinking, both locally and nationally and feel that we already have enough late night drinking venues in Alderley Edge and i am sure that whilst Magnolia Bell Limited will put safeguards at the venue, it is known that underage drinkers drink in bars in the village already. By allowing a further late night bar/ night club will look like Cheshire East Council licensing department are promoting this social epidemic.

APPENDIX - 3

As a property professional a late licence in my opinion leads to visitation to the village and inward employment from people outside the area, it would not cause local employment and will increase traffic into the village.

I am writing to object most strongly against the late alcohol and music licence application for number 15 London Road in the above development.

I object for the following reasons.

- Loss of amenity parking and noise along Clifton Street will be chaotic
- Safety drunken youths and others walking along Clifton Street and London Road.
- Inappropriateness this is a village, Alderley Edge already has far too many late licenses. Another 3 am license is totally at odds with the village setting
- Unfairness probably not a common reason but the residents of Clifton Street are starting to feel besieged by big retailers and developers. And the council are doing little to support our enjoyment of our amenity. Granting this late license will further prejudice the residents of Clifton Street
- Noise will be a key issue; music, taxis waiting down Clifton Street as they do
 opposite the Bubble Room on London Road, smokers standing in the garden to the
 rear of the premises and revellers, especially during summer.

I most strongly urge that the council does all in its power to refuse a license at this development. It will be a gross dereliction of duty to do so and a lack of duty of care.

Objection to Sale of Alcohol Licence at No. 15., London Road, Alderley Edge.

I and my family have lived on Trafford Road (opposite Clifton Street exit) for 20 years and have witnessed many occasions of antisocial behaviour from late-night revellers as they spill from bars/clubs, hunt for taxis, shout drunken obscenities, vomit in the streets and occasionally damage property. These people are often from outside the area patronising the late-opening bars and club in the Village.

When operating as a Wine Bar, No 15 attracted a reasonably civilised clientele and its operating hours were not intrusive. Indeed the establishment was a longstanding asset to the Village.

Whilst we have no reason to object to reinstatement of previous trading conditions under the new operator, we believe the application for licence to sell alcohol until 3am Thurs – Sunday inclusive is totally inappropriate and unacceptable to nearby residents. In particular:-

- The property backs on to a residential area and designated Conservation Area in which
 residents' 'quiet enjoyment' should be preserved. The night-time activity will result in
 noise nuisance and antisocial behaviour, potentially involving the Police.



My family and I have lived on Trafford Road (opposite Clifton Street exit) for 20 years and have witnessed many occasions of antisocial behaviour resulting from alcohol abuse - people shouting drunken obscenities, vomiting/urinating in the streets and occasionally damaging property.

There are already sufficient off-licence and on-licence outlets in the Village to satisfy need and adding another will only aggravate an existing problem.

I am writing to object most strongly to the alcohol licence application for the Tesco Express in the above development.

I object for the following reasons.

- Loss of amenity parking along Clifton Street will be chaotic as it is at weekends
 already due to shoppers pulling up on to the pavements to go to Weinholts etc,
 already a significant problem to us the residents.
- Safety drunken youths walking along Clifton Street and London Road. It is well-documented that Tesco Expresses across the country cause such problems with cheap discounted alcohol. Such problems at the Tesco Express in Wilmslow are also documented including yobbish behaviour and this would have a significant impact on the residents of Clifton street.
- Inappropriateness this is a village, early and late sales of alcohol are totally inappropriate in a residential setting and just not required.
- Existing outlets. The closed off-licences will re-open. Any argument citing the closure
 as a reason for replacement is a spurious red herring that only the most gullible and
 inept would accept. This will mean FIVE off-licence retailers in a single small village
 which is clearly unnecessary.
- · Litter and rubbish including broken glass, especially along Clifton Street
- Cheap alcohol causing further problems in the Park. Youths will be only steps away from a cheap discounting retailer. Alcohol abuse in Alderley Park is well known and takes up valuable Police resources that are already stretched between Wilmslow and Alderley Edge. Whilst Tesco adopt to the policy "do you look 21" it is known that youths do have fake IDs and that they do purchase alchohol from Tescos stores. "The sale of Alcohol is likely to cause public nuisance or a threat to public safety" Section 17(12(c). As residents we deeply concerned for our safety and our right to live in our quiet street that has already suffered major upheaval caused by the contractors and the landlord whilst building this development.

 Alcohol retailing and government guidelines favour the restriction off sales and discounted alcohol – this application flies in the face of such initiatives

If for some spurious political reason a licence is granted, this should be within reasonable opening hours, i.e. exactly the same as the Cooperative store across the road, to allow fair trading.

I most strongly urge that the Council does all in its power to refuse a licence at this development. It will be a gross dereliction of duty to do so and a lack of duty of care.
