1 DECLARATIONS OF INTEREST

5 LOCAL AUTHORITY APPOINTMENTS TO SCHOOL GOVERNING BODIES

The Local Authority School Governor Appointments Panel considered the report of the Strategic Director – People, which informed Members of the current Authority Governor (the new legal term replacing "Local Education Authority Governor") vacancies within Cheshire East maintained schools, in the context of vacancies at a national level, and recommended individuals for appointment and reappointment to identified posts.

Additional information in respect of three new appointments and one reappointment was tabled at the meeting.

There were 359 Authority Governor positions across Cheshire East's 150 maintained schools. Currently 70 (19.5%) of these positions were vacant. The latest national benchmarking information (2009) showed that 10.1% of all Authority Governor positions to be vacant and 10.8% of all governor positions (of all categories) to be vacant, nationally. If the Panel were to confirm all appointments/re-appointments proposed in the report, the current number of vacancies would reduce to 53 (14.8%).

In line with agreed procedures, nominations to the vacant positions had been invited from schools and from local Members. Any individuals who had approached the School Governance Services directly, or via the School Governors One-Stop Shop (SGOSS) had also been considered against appropriate vacancies. In accordance with the agreed procedure, nominations received from local Members were given priority..
