## PROCEDURE FOR HEARINGS – LICENSING ACT 2003

The Licensing Committee

The full Licensing Committee consists of fifteen elected Members of the Council. From this full Committee will be drawn sub-committees of three members to deal with licensing functions under the Licensing Act 2003. The Chairman and Vice Chairman of the Licensing Committee shall have the discretion to refer a matter up to a hearing of the full Licensing Committee.

Officers at Hearings

- **The Committee Officer** introduces all parties and records the proceedings
- **The Legal Adviser** provides independent advice to the Members on legal matters and procedure.
- **The Licensing Officer** will introduce the matter and outline the application; the officer will also answer any questions Members may have.

PROCEDURE

**NOTE: If the Sub-Committee has not already elected a Chairman, that will be the first item of business.**

1	<b>Chairman</b>	The Chairman will: (i) call the matter to be considered; (ii) call for any declarations of interest; (iii) ask all parties to introduce themselves; (iv) summarise the procedure to be followed at the hearing; (v) will consider any request made by a party for another person to appear at the hearing; (v) will advise the parties of any maximum period of time in which it has to present its case (if a maximum is imposed this shall be equal for all parties).
2	<b>Licensing Officer</b>	Will introduce and summarise the application, highlighting areas of contention or dispute.
3	<b>Committee Members</b>	May ask questions of the Licensing Officer
4	<b>Applicant</b>	Will present his/her case, calling witnesses, as appropriate.  <i>(If necessary, applicant will produce any notices required by law. Legal Adviser will draw attention to this if required.)</i>
5	<b>Responsible Authorities (who have made representations)</b>	Each in turn may ask <u>questions</u> of the applicant, by way of clarification.

6	<b>Local residents</b> (ie. defined as “interested parties”)	To be invited to ask <u>questions</u> of the applicant, by way of clarification.  <i>It is normal practice for a spokesperson only to speak on behalf of a group of residents.</i>
7	<b>Committee Members</b>	Each in turn may ask <u>questions</u> of the applicant.
8	<b>Applicant</b>	May make a <u>statement</u> or ask his witnesses to clarify any matters which he feels are unclear, or may have been misunderstood.
9	<b>Responsible Authorities</b>	Will make their representations.
10	<b>Applicant</b>	Or his representative or witnesses to ask <u>questions</u> of Responsible Authorities represented at the meeting, by way of clarification.
11	<b>Local residents</b> (ie. defined as “interested parties”)	May ask <u>questions</u> of the Responsible Authorities represented at the meeting, by way of clarification.  <b>(Note: This is not the point at which local residents should be stating their objections.)</b>
12	<b>Committee Members</b>	May ask <u>questions</u> of the Responsible Authorities represented at the meeting
13	<b>Local residents</b> (ie. defined as “interested parties”)	The local residents who are objecting to the application will be invited <b><u>to make observations on the application</u></b> and present the bases of their objections.
15	<b>Applicant</b>	Or his representative or witnesses may ask <u>questions</u> of the Local Residents, by way of clarification.
16	<b>Committee Members</b>	May ask <u>questions</u> of the Local Residents.
17	<b>Chairman</b>	To invite both <b>Responsible Authorities</b> and <b>Local Residents</b> to make their closing addresses.
18	<b>Applicant</b>	Or his representative will <u>briefly summarise the application</u> and comment on the observations and any suggested conditions.
19	<b>Committee</b>	<u>Will retire</u> to consider the application. The Committee may request the Legal Advisor to advise on legal issues.
20	<b>Committee</b>	Will return to <u>give its decision</u> , with reasons, which will be announced by the Chairman and subsequently confirmed in writing to the applicant and to all the parties that made representations.

		In cases where a decision cannot be given at the end of the hearing, parties will be advised of the decision within five working days.

**Notes**

1. The hearing shall normally be held in public. There may be occasions on which the Committee find it necessary to exclude members of the press and public; any such decision will be taken on the basis that the public interest in doing so outweighs the public interest in the hearing, or that part of the hearing taking place in public.
2. The Chairman may require any person behaving in a disruptive manner to leave the hearing and may (a) refuse to permit that person to return, or (b) permit him/her to return only on such conditions as the authority may specify, but any such person may submit in writing any information which they would have been entitled to provide orally if they had not been required to leave.
3. Prior to the hearing each party shall have given notification and served documentation (eg statements of witnesses or reports of experts) as required. Late representations and evidence will only be considered with the agreement of all parties.
4. Anyone entitled to be heard may be represented by any person, whether or not that person is legally qualified.
5. Hearsay will be permitted but the Sub-Committee will be reminded to give it appropriate weight.
6. Due note shall be taken of the provisions of the Hearings Regulations 2005.
7. The Chair may, in the interests of expediency or convenience of the parties, vary the procedure from time to time, provided notice is given to the parties and the rules of natural justice are observed.

**SUMMARY OF PROCEDURE**

- 1 Chairman appointed (if this has not been done previously).
- 2 Chairman to call for declarations of interest and request that all parties introduce themselves.
- 3 Chairman summarises the procedure for the hearing
- 4 The Licensing Officer summarises the application
- 5 Applicant to present his/her case.
- 6 Applicant to be questioned by all parties (to clarify points only) following which, he/she can clarify any other matters which he/she feels may have been misunderstood when the application was presented.
- 7 Applicant to be questioned by the Committee.
- 8 Responsible Authorities to make their representations following which they can be questioned by all parties by way of clarification.
- 9 **Local residents** (defined as interested parties) will be invited to present the bases of their objections, following which they can be questioned by all parties by way of clarification.
- 10 The applicant will be invited to sum up his/her case
- 11 Committee/Sub-Committee withdraws to make its decision
- 12 Committee/Sub-Committee returns to announce its decision to all present.

- 8.1 In accordance with the provisions of section 18 of the Licensing Act 2003 the Licensing Authority must, having regard to the representations, take such steps (if any) as it considers necessary for the promotion of the licensing objectives. Section 18(4) provides that the authority may (a) grant the licence subject to conditions; (b) exclude from the scope of the licence any of the licensable activities to which the

application relates; (c) to refuse to specify a person in the licence as the premises supervisor; or (d) to reject the application.

## **9.0 Risk Management**

9.1 Section 181 and Schedule 5 of the Licensing Act 2003 make provision for appeal to the Magistrates' Court of any decision made by the Licensing Authority.

## **10.0 Background and Options**

10.1 The application is for Premises Licence under section 17 of the Licensing Act 2003.

10.2 The operating schedule indicates that the relevant licensable activities applied for are:  
Sale and supply of alcohol for consumption off the premises only.

10.3 The hours applied for are as follows:  
Monday to Saturday 08.00 to 22.00  
Sunday 08.00 to 21.00

The opening hours of the premises as as follows:  
Monday to Saturday 08.00 to 22.00  
Sunday 08.00 to 21.00

10.4 Designated Premises Supervisor: Mr Noaman Malik

10.5 The operating schedule includes the following steps to promote the licensing objectives:

(a) Prevention of crime and disorder

There shall be CCTV cameras inside and outside the premises.

The Challenge 25 policy shall be adhered to and highlighted by posters.

(a) Public safety

There shall be fire extinguishers on site.

(b) Prevention of public nuisance

2 members of staff shall be available during busy times.

Police assistance shall be sought if required.

(c) Protection of children from harm

There shall be a refusals log in operation at the premises.

(d) General – all four licensing objectives

Staff shall be trained in the Licensing Objectives.

Staff shall be familiarised with the refusals procedure.

10.6 Relevant Representations:

The premises are situated in a small shopping parade on the outskirts of the town. The premises Licence is for the sale and supply of alcohol only from 08:00 to 22:00 hours Monday to Saturday and 08:00 to 21:00 Sunday

I visited the premises on Thursday 18th August 2011, and observed the Blue Notices were correctly displayed. I took pictures which I can produce if required.

The operating schedule states the applicant will operate a Challenge 21 Policy. In line with Cheshire East and national Trading Standards policy, would request that a Challenge 25 policy is adopted in relation to the Protection of Children from harm in order to prevent underage sales of alcohol, this has been agreed with the applicant

The named Mr Malik is, I believe, the shop leaseholder, but he never seems to be at the premises, nor available for contact. There has been a succession of people running this shop since it re-opened as a Best-One food store, and it seems to operate on a 'one man all day' basis. I do not personally feel that an additional licensed premises is required here, particularly as this is a residential area, and there are also a few residential and care homes nearby. An increase in alcohol related activity in and around the shop area would not be welcome, and could instigate additional public disorder and anti-social behaviour. I strongly object to the proposed premises licence being granted, and I am available for contact should you wish to discuss matter further.

This is not only on the grounds of conflict of interest, but I also have an impeccable record with the Police department and local residents regarding responsible operation of this licensed premises. Under the current climate of actions to reduce under age alcohol consumption, etc., I feel that an additional outlet so close, in an estate/residential environment, would actually contravene efforts in this direction. We have a strong community liaison with our customers, and we work together to try to prevent alcohol products being purchased by, or purchased for, under age persons. There is also a residential care home in the next building to the Best-One shop, and additional gatherings of youngsters should be discouraged where possible. I would strongly recommend that you view the actual Best-One premises, as well as the local situation here, prior to making your decision on this application.

#### **1.0 Report Summary**

1.1 The purpose of the report is to provide details of an application for the variation of an existing Premises Licence under section 34 of the Licensing Act 2003 ('the 2003 Act'). It outlines the current licence authorisations together with the evidence presented by the parties in relation to the application.

8.1 Where relevant representations are received in relation to an application for the variation of a Premises Licence under section 34, the Licensing Authority must hold a hearing within 20 working days (of the end of the consultation period) to consider both the application and the relevant representations.

8.2 Section 35 of the 2003 Act provides that before determining the application, the authority must hold a hearing to consider it and any relevant representations. In accordance with the provisions of section 35 of the 2003 Act, the authority must, having regard to the application and any relevant representations, take such of the steps mentioned in subsection (4) (if any) as it considers necessary for the promotion of the licensing objectives. Sub-section 35(4) provides that the authority may: (a) modify the conditions of the licence; or (b) reject the whole or part of the application;

## **9.0 Risk Assessment**

9.1 Section 181 and Schedule 5 of the 2003 Act make provision for appeal to the Magistrates' Court of any decision made by the Licensing Authority.

## **10.0 Background and Options**

10.1 On 4<sup>th</sup> August 2011 Mr Atif Arslan Mirza made application to vary the Premises Licence relating to premises known as Hotspot, 11 High Street, Sandbach. The variation application seeks authorisation for extended hours in relation to both recorded music and late night refreshment, to enable these licensable activities to be provided until 03.30 on Fridays and Saturdays. The application also seeks an extension of the hours of opening until 03.30 on Fridays and Saturdays.

10.2 The Premises Licence, a copy of which is attached as **Appendix A**, currently authorises the provision of recorded music and late night refreshment for the following hours:

### Recorded music

Sunday to Thursday 11:00 – 01:00  
Friday and Saturday 11:00 – 02:30

### Late night refreshment

Sunday to Thursday 23:00 – 01:00  
Friday and Saturday 23:00 – 02:30

10.3 The Premises Licence Holder is Mr Atif Arslan Mirza

10.4 The application states that the following steps will be taken to promote the four licensing objectives as a result of the proposed variation:

10.4.1 General – all four licensing objectives

1. We will implement policies that will promote the prevention of crime and disorder;
2. Public safety will be paramount;
3. Anyone who becomes a public nuisance will be asked to leave quietly;
4. We would ask children to be accompanied by adults.

10.4.2 The prevention of crime and disorder

1. Our premises is alarmed and all our external doors are fitted with security locks;
2. We also have CCTV which is recorded to HDD.

10.4.3 Public safety

1. We have our electricity and gas equipment maintained on legal service schedules, also operate Health and Safety;
2. We have public liability insurance;
3. Our premises is in excellent condition and all glass is safety glass. Everything is recorded to CCTV.

10.4.4 The prevention of public nuisance

1. To provide litter bins for our customers to use.
2. Our premises is clearly marked indicating CCTV coverage on the premises.

10.4.5 The protection of children from harm

1. Children are always accompanied by an adult, early evening. Late nights we don't get any children.

10.5 Within the prescribed consultation period in relation to the application, the Licensing Authority received fifteen letters of representation from interested parties; copies of the letters received are attached to the report (**Appendix B 1 to 15**)

10.6 During the consultation period a representation was also received from Mr David Smethurst, Police Licensing Officer (**Appendix C**). No other representations have been received from any of the other responsible authorities.

10.7 A location plan is also attached (**Appendix D**) showing Hotspot in Sandbach.

10.8 In determining the application, the Licensing Act Sub-Committee must have regard to representations made by the applicant and any representations received from responsible authorities or interested parties. The Sub-Committee

is required to take such steps (if any) as it considers necessary for the promotion of the licensing objectives.

- 1 A CCTV system will be installed at the premises to the satisfaction of the Police Licensing Officer. It will record continuously during all hours that the premises are open to the public and unedited images will be securely stored for a period of at least 28 days. Copies from the CCTV system will be made freely available upon request to a constable or an employee of the Police Authority or Local Authority.
- 2 There shall be placed at all exits from the premises in a place where they can be seen and easily read by the public notices requiring customers to leave the premises and the area quietly.
- 3 Where the premises provide food for consumption off the premises, the public area immediately surrounding the premises shall be cleared of waste food, food containers, wrapping etc regularly during the stated operating hours and at the end of trading on each day. Such refuse shall be placed in a container designed for the storage and disposal of refuse and waste foods which shall be constructed, maintained and located so that access to it by vermin and unauthorised persons is prevented and arrangements shall be made for the regular lawful disposal of their contents.
- 4 No nuisance shall be caused by noise coming from the premises.





To whom it may Concern

I would like to object to the application made by The Hot Spot on High Street for later opening hours to 3.30am. As a local resident I find this time far too late, we have already had to suffer unacceptable levels of noise, Anti Social Behaviour and violent disorder due to drunken patrons frequenting the fast food venue. The thought of having to suffer it for longer is awful.
