#### 1.0 Report Summary

1.1 The report provides details of an application for the Renewal of a Sexual Entertainment Venue Licence together with information as to a representation received from the Police in relation to the application.

#### 3.0 Reasons for Recommendations

3.1 In accordance with the Council's Constitution, the General Licensing Sub-Committee has the delegated authority to determine this application in accordance with the provisions of Schedule 3 to the Local Government (Miscellaneous Provisions) Act 1982.

#### 6.0 Policy Implications

6.1 The Council has adopted the amendments to Schedule 3 of the Local Government (Miscellaneous Provisions) Act 1982 ('the 1982 Act') made by section 27 of the Policing and Crime Act 2009.

6.2 The Council has adopted a policy in relation to the licensing of sexual entertainment venues; a copy of this policy is attached as Appendix 1.

# 7.0 Financial Implications (Authorised by the Director of Finance and Business Services)

7.1 Not applicable.

#### 8.0 Legal Implications (Authorised by the Borough Solicitor)

- 8.1 On 24<sup>th</sup> February 2011 the Council resolved that the provisions of Schedule 3 of the Local Government (Miscellaneous Provisions) Act 1982, as amended by section 27 of the Policing and Crime Act 2009, be adopted and shall apply within the Borough of Cheshire East with effect from 4<sup>th</sup> April 2011.
- 8.2 'Sexual Entertainment Venue' is defined within Schedule 3 of the Local Government (Miscellaneous Provisions) Act 1982 (as amended) ('the 1982 Act') as "any premises at which relevant entertainment is provided before a live audience for the financial gain of the organiser or the entertainer." 'Relevant Entertainment' means "any live performance or live display of nudity which is of such a nature that, ignoring financial gain, it must reasonably be assumed to be provided solely or principally for the purpose of sexually stimulating any member of an audience (whether by verbal or other means)."
- 8.3 Paragraph 12 of Schedule 3 to the 1982 Act prescribes that a licence for a sexual entertainment venue shall not be granted to:
  - (a) a person under the age of 18; or

(b) to a person who is for the time being disqualified under paragraph 17(3) of the Schedule; or

(c) to a person, other than a body corporate, who is not resident in an EEA state, or was not so resident throughout the period of six months immediately preceding the date when the application was made; or

(d) to a body corporate which is not incorporated in an EEA state; or

(e) to a person who had, within a period of twelve months immediately preceding the date when the application was made, been refused the grant or renewal of a licence for the premises, vehicle, vessel or stall in respect of which the application is made, unless the refusal has been reversed on appeal.

8.4 Paragraph 12 of Schedule 3 also provides that the authority may refuse (i) an application for the grant or renewal of a licence on one or more of the grounds listed at (a) to (d) below; and (ii) an application for a transfer on either or both of the grounds at (a) and (b):

(a) that the applicant is unsuitable to hold the licence by reason of having been convicted of an offence or for any other reason;

(b) that if the licence were to be granted, renewed or transferred the business to which it relates would be managed by or carried on for the benefit of a person, other

than the applicant, who would be refused the grant, renewal or transfer of such a licence if he made the application himself;

(c) that the number of sex establishments, or of sex establishments of a particular kind, in the relevant locality at the time the application is made is equal to or exceeds the number which the authority consider is appropriate for that locality;

- (d) that the grant or renewal of the licence would be inappropriate, having regard
   (i) to the character of the relevant locality; or
  - (ii) to the use to which any premises in the vicinity are put; or
  - (iii) to the layout, character or condition of the premises, vehicle, vessel or stall in respect of which the application is made.
- 8.5 Paragraph 8 of Schedule 3 provides that the Council may grant a licence for the use of premises as a sex establishment 'on such terms and conditions and subject to such restrictions as may be so specified.' (subject to the requirement that conditions may not duplicate requirements or prohibition which are, or could be, imposed under the Regulatory Reform (Fire Safety) Order 2005). Paragraph 13 of Schedule 3 provides the Council with the power to prescribe standard conditions applicable to licences for sex establishments. The Council had prescribed a set of standard conditions in relation to sexual entertainment venues; these are set out within Appendix 3 of the Council's policy (attached as Appendix 1 to this report). Where the Council has determined a set of standard conditions, every such licence granted by the authority shall be presumed to have been granted subject to the standard conditions unless they have been expressly excluded or varied. As is recognised by Home Office Guidance, issued in March 2010 (paragraph 3.42) in cases where a sexual entertainment venue also holds a licence under the Licensing Act 2003. local authorities should avoid duplicating licence conditions and should ensure that conditions imposed on each licence are relevant to the activities authorised by that licence. Whilst not a statutory requirement, local authorities have been encouraged by the Home Office to have regard to the guidance when exercising their functions.
- 8.6 The Provision of Services Regulations 2009 state that the local authority must provide the applicant with the reasons for the decision in writing if the authority refuses an application for the renewal of a licence. With the exception of a decision to refuse an application on a ground specified in paragraph 12(3)(c) or (d) (see paragraph 8.4 above), an applicant for the grant of a licence whose application is refused has the right to appeal the decision to a magistrates' court within twenty-one days.
- 8.7 When making a decision consideration must be given to the applicant's rights under the European Convention on Human Rights. Article 1 of the First Protocol (peaceful enjoyment of possessions) and Article 10 (freedom of expression) are rights which may be relevant. The Home Office guidance suggests that 'local authorities would be well advised to consider whether any interference with the applicant's rights under Article 10 or Article 1, Protocol 1 of the European Convention on Human Rights is necessary and proportionate for the prevention of crime and disorder, for the protection of health or morals or for the protection of the rights and freedoms of others or, in the case of Article 1, Protocol 1, can be justified in the general interest." In addition Article 6 will be relevant to the hearing of the case, i.e. right to a fair hearing.

8.8 The Council has exercised its discretion and has determined to provide objectors to the application the opportunity to speak at the hearing.

#### 9.0 Risk Management

9.1 The legal risks are set out within paragraph 8.0 above.

#### **10.0 Background and Options**

- 10.1 The application for Renewal of a Sexual Entertainment Venue Licence in relation to premises known as Manhattan, 35-37 High Street, Crewe, CW2 7BL, was received by the Council on 3<sup>rd</sup> April 2013.
- 10.2 In accordance with paragraph 10(8) of Schedule 3 of the 1982 Act, a notice of the application was published in a local newspaper circulating in the Council's area within seven days of the date of the application. In addition, a site notice was displayed at the premises in accordance with paragraph 10(10).
- 10.3 The application is to renew the existing Sexual Entertainment Venue Licence to provide the following forms of 'relevant entertainment' with full nudity, i.e. lap dancing, pole dancing and strip shows. The hours applied for are the same as the existing Sexual Entertainment Venue Licence, as follows:

Monday to Sunday 19.00hrs to 05.30hrs

A copy of the application form is attached at Appendix 3 of this report.

- 10.4 The Applicant has held a Sexual Entertainment Venue Licence for one year. Prior to that, a Premises Licence under the Licensing Act 2003 has been in place in relation to the premises since 30<sup>th</sup> August 2006 to permit the sale of alcohol, regulated entertainment and the provision of late night refreshment. The Premises Licence is subject to a number of conditions in relation to the provision of adult entertainment. A copy of the Premises Licence Summary and the conditions attached to the licence are attached at Appendix 5 of this report.
- 10.5 In accordance with paragraph 10(14) of Schedule 3 to the 1982 Act, a copy of the application was sent to the Police. A representation in relation to the application has been provided to the Council by the Police. A copy of the representation from the Police is attached at Appendix 2 of this report.
- 10.6 The Council has not received any representations from any other persons in relation to the application within the twenty-eight day consultation period.
- 10.7 In accordance with paragraph 10(18) of Schedule 3, in considering any application for the grant of a licence the Council is required to have regard to any observations submitted to it by the Police and any objections of which notice has been sent to it under sub-paragraph 10(15).
- 10.8 The options which are available to the General Licensing Sub-Committee when considering this application are as follows:
- 10.8.1 to grant the Renewal of the Sexual Entertainment Venue Licence subject to the standard conditions prescribed by the Council;

- 10.8.2 to grant the Renewal of the Sexual Entertainment Venue Licence subject to the standard conditions prescribed by the Council as varied by the Sub-Committee;
- 10.8.3 to grant the Renewal of the Sexual Entertainment Venue Licence subject to the standard conditions prescribed by the Council (whether varied or not) and subject to further additional express condition(s);
- 10.8.4 to grant the Renewal of the Sexual Entertainment Venue Licence subject to express condition(s) determined by the Sub-Committee (i.e. the prescribed standard conditions are expressly excluded).
- 10.8.5 to refuse the grant of the Renewal of the Sexual Entertainment Venue Licence.

## POLICY ON THE LICENSING OF SEXUAL ENTERTAINMENT VENUES

Schedule 3, Local Government (Miscellaneous Provisions) Act 1982 (as amended)

#### 1.0 PREFACE

- 1.1 On 24<sup>th</sup> February 2011 Cheshire East Borough Council resolved to adopt the amendments to Schedule 3 of the Local Government (Miscellaneous Provisions) Act 1982 ('the 1982 Act') by section 27 of the Policing and Crime Act 2009 with effect from 4<sup>th</sup> April 2011.
- 1.2 Any person wishing to operate a Sexual Entertainment Venue as defined by Schedule 3 requires a licence, unless the requirement for a licence has been waived by the Council. This document sets out the Council's policy in relation to the licensing of Sexual Entertainment Venues within its administrative area.
- 1.3 A consultation on this policy was undertaken between October 2010 and February 2011 and was formally adopted on 7<sup>th</sup> March 2011.
- 1.4 This policy will be kept under review and amendments proposed in the light of any changes in the relevant legislative provisions.

#### 2.0 INTRODUCTION

- 2.1 It is intended that this policy will be a guide for both applicants and those other parties who have an interest in the licensing of sexual entertainment venues. Whilst the policy provides framework guidance, the Council, as the Licensing Authority, will ultimately determine each individual application on its own merits.
- 2.2 Cheshire East has a population of 358,900 and covers an area of 116,638 hectares. Cheshire East's administrative area contains the industrial town of Crewe, the old mill towns of Macclesfield, Bollington and Congleton, the market towns of Nantwich, Knutsford and Sandbach, the salt town of Middlewich, the town of Wilmslow as well as the smaller settlements of Holmes Chapel, Alsager and Poynton.

#### 3.0 POLICY

#### 3.1 Meaning of 'Sexual Entertainment Venue'

'Sexual Entertainment Venue' is defined within Schedule 3 of the Local Government (Miscellaneous Provisions) Act 1982 (as amended) ('the Act') as "any premises at which relevant entertainment is provided before a live audience for the financial gain of the organiser or the entertainer." The following are not Sexual Entertainment Venues for the purpose of Schedule 3 of the Act (a) sex cinemas and sex shops;

(b) premises at which the provision of relevant entertainment as mentioned in sub-paragraph (1) is such that, at the time in question and including any relevant entertainment which is being so provided at that time—

(i) there have not been more than eleven occasions on which relevant entertainment has been so provided which fall (wholly or partly) within the period of 12 months ending with that time;

(ii) no such occasion has lasted for more than 24 hours; and

(iii) no such occasion has begun within the period of one month beginning with the end of any previous occasion on which relevant entertainment has been so provided (whether or not that previous occasion falls within the 12 month period mentioned in subparagraph (i));

#### 3.2 **Relevant Entertainment**

'Relevant Entertainment' means "any live performance or live display of nudity which is of such a nature that, ignoring financial gain, it must reasonably be assumed to be provided solely or principally for the purpose of sexually stimulating any member of an audience (whether by verbal or other means)."

In accordance with the Guidance from the Home Office, the Council expects that 'Relevant Entertainment' will generally apply to the following types of activity:

- Lap dancing;
- Pole dancing;
- Table dancing;
- Strip shows;
- Peep shows;
- Live sex shows

However this list is not exhaustive and, taking into account that the exact nature of these descriptions may vary, each case will have to be dealt with on its own merits.

#### 3.4 Mandatory grounds for refusal

Paragraph 12 of Schedule 3 to the 1982 Act prescribes that a licence for a sexual entertainment venue shall <u>not</u> be granted to:

(a) a person under the age of 18; or

(b) to a person who is for the time being disqualified under paragraph 17(3) of the Schedule; or

(c) to a person, other than a body corporate, who is not resident in the United Kingdom, or was not so resident throughout the period of six months immediately preceding the date when the application was made; or

(d) to a body corporate which is not incorporated in the United Kingdom; or

(e) to a person who had, within a period of twelve months immediately preceding the date when the application was made, been refused the grant or renewal of a licence for the premises, vehicle, vessel or stall in respect of which the application is made, unless the refusal has been reversed on appeal.

The application form, a copy of which is attached at Appendix 1 asks questions in relation to the above issues.

#### 3.5 **Discretionary grounds for refusal**

Paragraph 12 of Schedule 3 also provides that the authority <u>may</u> refuse (i) an application for the grant or renewal of a licence on one or more of the grounds listed at (a) to (d) below; and (ii) an application for a transfer on either or both of the grounds at (a) and (b):

(a) that the applicant is unsuitable to hold the licence by reason of having been convicted of an offence or for any other reason;

(b) that if the licence were to be granted, renewed or transferred the business to which it relates would be managed by or carried on for the benefit of a person, other than the applicant, who would be refused the grant, renewal or transfer of such a licence if he made the application himself;

(c) that the number of sex establishments in the <u>relevant locality</u> at the time the application is made is equal to or exceeds the number which the authority consider is appropriate for that locality;

(d) that the grant or renewal of the licence would be inappropriate, having regard –

(i) to the character of the <u>relevant locality</u>; or

(ii) to the use to which any premises in the vicinity are put; or (iii) to the layout, character or condition of the premises, vehicle, vessel or stall in respect of which the application is made.

#### 3.6 Relevant locality

'Relevant locality' for the purposes of paragraph 12 of Schedule 3 of the Act means:

- (i) in relation to the premises, the locality where they are situated; and
- (ii) in relation to a vehicle, vessel or stall, any locality where it is desired to use it as a sex establishment.

The Council will consider the extent of the locality on a case by case basis taking into account the particular circumstances of each case. However, the Council will not seek to define 'locality' as the whole of the Council's administrative area.

#### 3.7 Relevant number

As set out within paragraph 3.5 above paragraph 12 of Schedule 3 provides that a local authority may refuse an application if it is satisfied that the number of sex establishments in the relevant locality at the time the application is made is equal to or exceeds the number which the authority consider is appropriate for that locality.

The Council does not seek within this policy to place a figure on the number of sexual entertainment venues which it considers appropriate in any locality within the Council's administrative area.

Consideration will be given to the locality in each case and to the number of Sexual Entertainment Venues suitable for that locality.

The Council is able to determine that the appropriate number for a locality is nil.

#### 3.8 **Character of relevant locality and uses of premises in the vicinity**

When considering whether it would be appropriate to grant the licence the Council will take into consideration factors such as:

- the uses to which premises in the vicinity are put, for example whether they are commercial, industrial or residential;
- the users of premises in the area;

Whilst each application will be determined on its own individual merits, the grant of a licence will generally be considered inappropriate where the characteristics of the locality include the following sensitive uses:

- (a) an area predominantly comprising residential accommodation;
- (b) parks and children's play areas;
- (c) schools and youth centres;

- (d) places of worship; and
- (e) community facilities.

#### 3.8 **Duration of licence**

Unless previously cancelled or revoked a licence will remain in force for twelve months or such shorter period specified in the licence as the Council determines is fit.

#### 3.9 **Conditions**

Where a licence is granted the standard conditions attached at Appendix 3 will be attached.

Where it is reasonable and proportionate to do so, additional conditions may be imposed on a licence.

#### 3.10 **Waiver**

The Act makes provision for the Council to grant a waiver from the requirement to hold a Sexual Entertainment Licence in any case where it considers that to require a licence would be unreasonable or inappropriate. A waiver may be for such period as the Council thinks fit.

The Council may at any time give a person who would require a licence but for a waiver, notice that the waiver is to terminate on a date not less than 28 days from the date the notice is given.

Whilst each application will be considered on its own merits, in light of the exemption in relation to the provision of relevant entertainment on an infrequent basis<sup>1</sup>, the Council takes the view that waivers are unlikely to be appropriate in relation to Relevant Entertainment and would only be considered in exceptional circumstances.

The Council will require applicants to supply all of the information required within the application form at Appendix 1 in relation to a waiver application. The Council will consult the Police as part of its decision-making process in relation to waivers.

#### 4.0 APPLICATION PROCESS

#### 4.1 **Submission of application**

The Council's application form in relation to Sexual Entertainment Venues is attached as Appendix 1. The following must be submitted with the completed application form in order to form a valid application:

- a scale plan of the Premises which should be large enough to be easily read (which must show the layout of the Premises including:

   performer's changing facilities;
   those areas to which the public are to be admitted (shown outlined in red);
   toilets;
   toilets;
   entrances and exits from the premises (including emergency exits);
   any stage area (including an annotation as to the height of the stage);
   the location of any fixed structures (such as the bar area, fixed tables/seating or private booths);
- The Licence Fee<sup>2</sup>
- A copy of the completed notice to be displayed on the Premises (see notification requirements below);
- A basic CRB disclosure [note 'where the applicant is an individual' deleted and replaced with] from the applicant (including each of the directors/the company secretary where the applicant is a company and each of the partners if the applicant is a partnership).
- A copy of the management operation manual and club rules (see condition 16 at Appendix 3)

Applicants are reminded that any person who, in connection with an application for the grant, renewal or transfer of a sexual entertainment venue licence makes a false statement which he knows to be false in any material respect or which he does not believe to be true, is guilty of an offence and liable on summary conviction to a fine not exceeding twenty thousand pounds.

A copy of the application must also be served on the Chief Officer of Police:

(a) in a case where the application is made by means of a 'relevant electronic facility'<sup>3</sup>, by the appropriate authority not later than 7 days after the date the application is received by the authority;

(b) in any other case, by the applicant not later than 7 days after the date of the application.

Applicants are reminded that the grant of a licence in relation to a sexual entertainment venue under the 1982 Act does not provide authorisation under any other statutory regime, and separate permissions may be required e.g. planning permission.

#### 4.2 **Renewal applications**

Where, before the date of expiry of a licence, an application has been made for its renewal, it shall be deemed to remain in force until the withdrawal of the application or its determination by the Council.

#### 4.3 Variations

The Council's conditions provide that applications for the variation of the terms, conditions or restrictions on or subject to which a sexual entertainment venue licence is held is subject to the same application and advertising requirements as applications for the grant of a licence.

#### 4.4 Advertising requirements

In accordance with paragraph 10 of the Schedule, applicants for the grant, renewal or transfer of a licence are required to give public notice of the application. Notice shall be given:

• by displaying a notice in a prescribed form (see Appendix 2), with text in black in a minimum font size of 16 on white paper of a size no smaller than A4, on or near the Premises in a place where the notice can be conveniently read by the public for a period of at least 21 days beginning with the date on which the application was made to the Council; and • by publishing an advertisement (in the form prescribed) in a local newspaper circulating in the Council's area not later than 7 days after the date the application was made to the Council.

Applicants are requested to: (i) send a copy of the completed notice to the Council with the application form; and (ii) to notify the Council of the name of the newspaper in which the advertisement is to appear together with the date of publication.

#### 4.5 **Objections**

Objections to an application for the grant, renewal or transfer of a Licence must be made in writing stating in general terms the grounds of the objection. Objections should be made not later than 28 days after the date of the application.

Any person can object to an application but the objection should be relevant to the grounds set out within paragraph 12 of Schedule 3 for refusing a licence. Objections should not be based on moral grounds/values and local authorities are not in a position to consider objections which are not relevant to the grounds set out in paragraph 12.

Where objections in relation to an application for the grant, renewal or transfer of a licence are received by the Council, copies of the objections will be provided to the Applicant. However, the name and address of an objector will not be disclosed to the Applicant without the consent of the objector to such disclosure.

#### 4.6 **Determination of applications**

In cases where objections have been made (other than objections which are outside the remit of the 1982 Act) the determination of applications will be referred to a meeting of the Council's Licensing Committee or Licensing Sub-Committee.

#### 4.7 Hearing procedure

A Committee or Sub-Committee determining an application in relation to a Sexual Entertainment Venue will follow the hearing procedure set out at Appendix 4. A copy of the hearing procedure will be sent to the relevant parties when they are notified of the date of the meeting.

#### 4.8 **Tacit authorisation**

The Council has determined that tacit authorisation (for the purposes of the Provision of Services Regulations 2009) is not to apply to applications for Sexual Entertainment Venue Licences. In making this

decision the Council has considered the public interest inherent in ensuring that applications are fully considered before a licence is granted, particularly in the light of the potential significant adverse impact on local communities of inappropriately located or inadequately managed premises.

#### 4.9 Appeals

In cases where the Council refuses an application for the grant, renewal or transfer of a Sexual Entertainment Venue licence the applicant may appeal the decision to the Magistrates' Court within 21 days (of the date when the applicant is notified of the decision), unless:

(1) the application was refused under the grounds in paragraph 12(3)(c) or (d) in which case the applicant can only challenge the refusal by way of judicial review; or

(2) the application was refused on any of the grounds specified in paragraph 12(1) of Schedule 3 of the 1982 Act, in which case the applicant shall not have a right of appeal unless he seeks to show that the ground did not apply to him.

	'Premises' means any premises within the Council's area licensed as a Sexual Entertainment Venue
	'Relevant Entertainment' shall have the meaning given within paragraph 2A of Schedule 3 of the 1982 Act.
	'Sexual Entertainment Venue' has the meaning set out within Schedule 3 of the 1982 Act.

The register shall be available at all times for inspection by the Police or an authorised officer of the Council.
	8. Where the Licence Holder is a body corporate or

	an unincorporated body any change of director, company secretary or other person responsible for the control or management of the body is to be notified in writing to the Council within 14 days of such change and such written details as the Council may require in respect of any new director secretary or manager are to be furnished within 14 days of a request in writing from the Council.

Conduct of the premises	10. Relevant Entertainment shall be produced and approved by Cheshire Police. This document shall be on-going and under constant review. (b) The Premises must provide a copy of its club rules to the Council and Cheshire Police. The club rules should be always available for public inspection and the first version should be publicly available for scrutiny with the application for a licence.

I wish to enter the following representation, on behalf of the Chief Officer of Police, in respect of the application from Sylvan Austin Salmon to renew the Sexual Entertainment Venue Licence at Manhattan, 35-37 High Street, Crewe, CW2 6JF.

The police have been contacted on four occasions in the last twelve months in connection with crime or disorder reported at Manhattan.

- 01/06/2012 at 23:45 hours a 21 year old male reported being assaulted by two door supervisors at the premises. There was a counter allegation from a door supervisor of racist language from the male being directed towards the door staff. It was alleged by the door staff that the male was drunk and had been refused entry. When police enquiries were completed there was no action taken against anyone.
- 2. 26/11/2012 at 13:31 hours a report was made that an unattended mobile phone had been stolen the night before from off the bar of Manhattan.
- 3. 27/01/2013 at 00:27 hours a 29 year old male was reported to be unconscious at Manhattan. It was alleged that as he was in the process of entering the premises someone spat on the floor and as a result the two door supervisors refused him entry and the next thing the male remembered was waking up on the floor. It was alleged by the male's friend that Austin Salmon had punched his friend once to the head knocking him unconscious in an unprovoked attack. There were counter allegations of racist language directed towards the door staff and police officers who attended were unable to establish definitively what had actually happened as the CCTV system was not working. Mainly due to lack of corroborative evidence there was no action taken against any parties. Follow up visits were made to establish that the CCTV system had been repaired and was operational.
- 4. 28/04/2013 at 01:27 a 21 year old female caused criminal damage to the ladies toilets by smashing windows and damaging a toilet seat.

In addition on Friday 19th April 2013 I attended, by appointment, at Manhattan and saw Sylvan Austin Salmon. As a result of that visit I sent a letter to Sylvan Austin Salmon, a copy of which I attach to this email, which outlined areas of concern relating to CCTV and non compliance with conditions on his Sexual Entertainment Venue Licence. Those areas of non compliance which came to light during my visit were so fundamental to the safe operation of these premises that I do not feel the applicant can be trusted to operate a Sexual Entertainment Venue in compliance with its licence in the future and the police therefore object to the issue of the licence to the applicant.

Please let me know when and where the hearing to determine these matters will take place and I will amplify my objection at that time.

Dear Austin,

Thank you for making time to meet with me at Manhattan on Friday 19<sup>th</sup> April 2013 in order for me to see your CCTV system and assess its compliance with your Sexual Entertainment Venue Licence. In essence I do not consider that a system with only eight cameras, which generate grainy images is 'fit for purpose' in Manhattan with its many different rooms and areas. However whilst your current application for renewal of your Sexual Entertainment Venue Licence still awaits determination I do not intend to press you to invest money into improving your existing CCTV system. However please take note that if your licence is renewed I will soon after revisit and expect to see you co-operate with substantial improvements to the CCTV.

I would also like to make mention of certain other matters which arose during my visit and our consequential conversations. There are of course a significant number of conditions on your Sexual Entertainment Venue Licence, but because the purpose of my visit was primarily to examine your CCTV I was not equipped at that time to examine your compliance with all of those conditions. However I did question you about your compliance with some of those which came to my mind and it was concerning to find non compliance with some significant ones. For example:

- you do not maintain separate entrances for customers and performers to use,
- you do not maintain a satisfactory register of performers with the level of detail required and nor do you check on the age of performers to ensure they are over 18,
- you do not maintain a register of SIA staff working at your premises,
- you do not ensure a nominated female chaperone oversees female performers.

Frankly I suspect that this is the tip of the iceberg and should a more structured examination of your compliance take place I think you may well be found wanting. This situation is almost certainly not helped by the fact that you are rarely present when the premises are open and also by the very difficult financial climate in which you are operating. Probably of most concern with the matters mentioned above is that these conditions should be complied with to ensure the safety of the performers and so that people under 18 do not find themselves trafficked into prostitution or other unsuitable positions for children.

Variation	42. An application to vary the terms, conditions or restrictions on or subject to which the licence is held must comply with the same application and advertising requirements as applications for the grant of a sexual entertainment venue licence.
CCTV	42. A CCTV system will be installed at the premises to the satisfaction of the Police Licensing Officer and it must record at all times the Premises are open to the public. Unedited images must be retained for at least 31 days and copies made freely available upon request to the Police or an authorised officer of the Council.
	43. At all times the Premises are open to the public there will be a member of staff on duty who is competent to operate the CCTV system and to provide any copies requested.
Business title	44. The Licence Holder must obtain the consent of the Council for the business or trading title to be used in relation to the Premises. An application must be made to the Council to change the business or trading title and the Council shall have the discretion to allow or refuse such a change.

- 1. No nuisance shall be caused by noise coming from the premises or by vibration transmitted through the structure of the building.
- 2. Refuse such as bottles shall be disposed of from the premises at a time (i.e between 8:00am to 8:00pm) when it is not likely to cause a disturbance to residents in the vicinity of the premises.
- 3 At all times the premises are open to the public there shall be on duty an adequate number of door supervisors who are registered with the Security Industry authority (SIA), the actual number decided by a written risk assessment which must be retained. Their details shall be recorded in a register which is retained for a minimum of 12 months and made available for inspection by an employee of the following organisations:- Police authority, Licensing Authority or SIA.
- 4. A tamper proof CCTV system shall be installed at the premises and be used to continuously record all areas inside and outside the premises.

- 5 Images from the CCTV system shall be retained for a minimum of 31 days and copies made freely available on request to an employee of the following organisations:-Police Authority, Licensing Authority, Fire Authority, SIA.
- 6. CCTV equipment must be maintained in good working order in accordance with the manufacturers instructions.
- 7. The Premises Licence Holder and/or the Designated Premises Supervisor or a person nominated by them shall be a member of and regularly attend at the meetings of the Pubwatch scheme for the area within which the premises is located.
- 8. The proof of age scheme " Challenge 21" will be operated for all sales of alcohol.
- 9. There shall be placed at all exits from the premises, in a place where they can be seen and easily read by the public, notices requiring customers to leave the premises and the area quietly.
- 10 No licensable activities shall be visible from outside the premises.
- 11 All external doors and windows shall be kept closed, except in so far as is necessary to allow people access or egress in the event of an emergency.
- 12 Notices shall be displayed at appropriate positions advising patrons not to open windows or doors except in an emergency.
- 13 All fire doors shall be fitted with an alarm to ensure they are kept closed other than during an emergency.

# SPECIAL CONDITIONS FOR LAP DANCING, STRIPTEASE AND RELATED ENTERTAINMENTS.

- 14 Only entertainment, which has been specifically agreed in writing between the Premises Licence Holder and the Licensing Authority, shall take place.
- 15 There shall be no private performances of entertainment of an adult nature.
- 16 There shall be no performances of entertainment of an adult nature in any area other than agreed with the Licensing Authority.
- 17 . No person under 18 years of age shall be allowed to enter or remain on the premises at any time.
- 18. A notice stating " no persons under 18 will be admitted" shall be displayed prominently at the entrance to the premises.

- Dressing rooms with adequate changing and washing facilities shall be provided . The Premises Licence Holder/Designated Premises Supervisor shall ensure that these area are not accessible by the Public at any time.
- 20. The Premises Licence holder/ Designated Premises Supervisor shall take all reasonable precautions and exercise due diligence to ensure the safety of the performers whilst on the premises and when leaving.
- 21. Adult themed entertainment shall only be given by the performers and no audience participation shall be permitted. In particular the performers **shall not:-**

i Touch customers or be touched by customers in any way.ii Approach closer than 30 cms (12 inches)iii Perform with another dancer; oriv Simulate sex acts

The Premises Licence holder/ Designated Premises Supervisor shall ensure that notices are clearly displayed in prominent positions showing condition (i) of the above.

- 22. Performers shall not take from or give to members of the public, telephone numbers, addresses or business cards, nor shall they solicit or make arrangements to meet members of the public.
- 23. Any person who touches or attempts to touch a performer or directs lewd, vulgar or obscene language or gestures therto shall be immediately removed from the premises.
- 24. The performers shall be fully dressed at all times when not taking part in the entertainment.
- 25. Any person who can be observed from outside the premises must be properly and decently dressed. Scantily clad individuals must not exhibit in the entrance way, windows or in the area surrounding the premises.
- 26. The Premises Licence Holder/ Designated Premises Supervisor must NOT display outside the premises any advertising material, photographs or other images that indicate and suggest that erotic dancing takes place on the premises.
- 27. The Premises Licence Holder/ Designated Premises Supervisor or Nominated Person agreed in writing with the Local Authority will be on the premises during any performance of an adult nature to ensure that these conditions are adhered to. A nominated female should be present to oversee the activities of the female performers and likewise a nominated male will be present to oversee the activities of any male performers.

- 28. A register of all performers including their names and addresses shall be maintained on the premises .The performers should sign to say that they have read and understood the conditions. The register shall also record the Premises Licence Holder/ Designated Premises Supervisor or Nominated Person who was on duty during the times that a performance of an adult nature took place. This register should be maintained for a period of 12 months and should be available for inspection by an employee of the following organisations;- Police Authority, Licensing Authority.
- 29. No use on the premises of cameras or camera phones.
