Procedure for Hearings – Licensing Act 2003

The Licensing Committee

The full Licensing Committee consists of fifteen elected Members of the Council. From this full Committee will be drawn sub-committees of three members to deal with licensing functions under the Licensing Act 2003. The Chairman and Vice Chairman of the Licensing Committee shall have the discretion to refer a matter up to a hearing of the full Licensing Committee.

Officers at Hearings

- The Committee Officer introduces all parties and records the proceedings
- The Legal Adviser provides independent advice to the Members on legal matters and procedure.
- The Licensing Officer will introduce the matter and outline the application; the officer will also answer any questions Members may have.

PROCEDURE

NOTE: If the Sub-Committee has not already elected a Chairman, that will be the first item of business.

1	Chairman	The Chairman will: (i) call the matter to be considered (ii) call for any declarations of interest (iii) ask all parties to introduce themselves (iv) summarise the procedure to be followed at the hearing (v) will consider any request made by a party for another person to appear at the hearing (v) will advise the parties of any maximum period of time in which it has to present its case (if a maximum is imposed this shall be equal for all parties)
2	Licensing Officer	Will introduce and summarise the application, highlighting areas of contention or dispute.

Notes

- The hearing shall normally be held in public. There may be occasions on which the Committee find it necessary to exclude members of the press and public; any such decision will be taken on the basis that the public interest in doing so outweighs the public interest in the hearing, or that part of the hearing taking place in public.
- 2. The Chairman may require any person behaving in a disruptive manner to leave the hearing and may (a) refuse to permit that person to return, or (b) permit him/her to return only on such conditions as the authority may specify, but any such person may submit in writing any information which they would have been entitled to provide orally if they had not been required to leave.
- Prior to the hearing each party shall have given notification and served documentation (eg statements of witnesses or reports of experts) as required. Late representations and evidence will only be considered with the agreement of all parties.
- 4. Anyone entitled to be heard may be represented by any person, whether or not that person is legally qualified.
- 5. Hearsay will be permitted but the Sub-Committee will be reminded to give it appropriate weight.
- 6. Due note shall be taken of the provisions of the Hearings Regulations 2005.
- 7. The Chair may, in the interests of expediency or convenience of the parties, vary the procedure from time to time, provided notice is given to the parties and the rules of natural justice are observed.

Summary of Procedure

- 1. Chairman appointed (if this has not been done previously).
- 2. Chairman to call for declarations of interest and request that all parties introduce themselves.
- 3. Chairman summarises the procedure for the hearing
- 4. The Licensing Officer summarises the application
- 5. Applicant to present his/her case.
- 6. Applicant to be questioned by all parties (to clarify points only) following which, he/she can clarify any other matters which he/she feels may have been misunderstood when the application was presented.
- 7. Applicant to be questioned by the Committee.
- 8. Responsible Authorities to make their representations following which they can be questioned by all parties by way of clarification.
- 9. Other Persons will be invited to present the bases of their objections, following which they can be questioned by all parties by way of clarification.
- 10. The applicant will be invited to sum up his/her case
- 11. Committee/Sub-Committee withdraws to make its decision
- 12. Committee/Sub-Committee returns to announce its decision to all present.

1. Report Summary

1.1. The report provides details of an application for a Premises Licence, under section 17 of the Licensing Act 2003 and outlines the evidence presented by the parties in relation to the new grant application.

2. Recommendations

2.1. The Licensing Act Sub-Committee is requested to determine the application for a Premises Licence by VC Law Limited on behalf of Venue Catering and Events Limited, in respect of:

> Combermere Abbey Wedding Venue Combermere Park Drive Nantwich SY13 4AJ

- 2.2. The Licensing Act Sub-Committee is requested to consider the application and any relevant representations and determine what steps, if any, it considers are appropriate to promote the Licensing Objectives.
- 2.3. Acting in the capacity of the Licensing Authority, Members must seek to promote the Licensing Objectives and where Members consider that matters have engaged one or more of the Objectives, they may exercise their discretion. The Licensing Objectives are:

- a) The prevention of crime and disorder
- b) Public Safety
- c) The prevention of public nuisance
- d) The protection of children from harm
- 2.4. Members of the Licensing Sub-Committee are reminded that they may not exercise discretion in any case, merely because it considers it desirable to do so. Careful consideration should be given to the application and the evidence presented by the parties in relation to the application.
- 2.5. Finally, Members are also reminded that in determining the application, consideration also needs to be given to:
 - a) The rules of natural justice;
 - b) The provisions of the Human Rights Act 1998.

3. Reasons for Recommendations

3.1. The Licensing Act Sub-Committee has the power to determine this application in accordance with the provisions of the Licensing Act 2003 and the Council's Constitution.

4. Other Options Considered

4.1. Not applicable.

5. Background

- 5.1. On 22nd March 2022 an application was received by the Licensing Team for the grant of a Premises Licence. The application was then distributed to the Responsible Authorities for consultation.
- 5.2. During the consultation period, the application was advertised on the Council's website and the notices required to be displayed at the premises were inspected on 24/03/2022 The last date for representations to be made was 18th April 2022. The Licensing Team have also confirmed that the newspaper notice was published in accordance with the legislative requirements.
- 5.3. A copy of the full application and plan is attached to this report at **Appendix** 1.
- 5.4. A map of the area in which the premises is located is attached to this report at **Appendix 5.**

- 5.5. The operating schedule indicates that the relevant licensable activities applied for are:
 - Provision of plays (indoors and outdoors)
 - Provision of films (indoors and outdoors)
 - Provision of live music (indoors and outdoors)
 - Provision of recorded music (indoors and outdoors)
 - Provision of performance of dance (indoors and outdoors)
 - Provision of any similar to live music, recorded music and performance of dance (indoors and outdoors)
 - Provision of Late Night Refreshment (indoors and outdoors)
 - Provision of the Supply of alcohol (for consumption on and off the premises)
- 5.6. The hours applied for are as followed:

5.6.1. Standard days and timings

Provision of plays (indoors and outdoors), films (indoors and outdoors)
 live music (indoors and outdoors), recorded music (indoors and
 outdoors), performance of dance (indoors and outdoors), Supply of
 alcohol (for consumption on and off the premises)

Monday to Sunday - 08:00 to 00:30

Provision of late night refreshment (indoors and outdoors)

Monday to Sunday - 23:00 to 00:30

5.6.2. Non Standard timings

- All outside areas, as outlined within the submitted plans, shall have a daily finish time of 21:00 (save for any late night refreshment and any supply of alcohol).
- New Years Eve into New Year's Day, the finish time shall be 02:00 for permitted activities (close at 02:30).
- 5.7. The operating schedule indicates that the hours the premises are open to the public are:
 - Monday to Sunday 07:00 to 01:00
 - Non-Standard Timings to be those set out in paragraph 5.4.2 above.

- 5.8. The premises currently benefits from an existing premises licence, a copy of which is attached to this report at **Appendix 2.**
- 5.9. Responsible Authorities:
 - 5.9.1. The Licensing Authority has not received representations from any of the responsible authorities, however Cheshire Police have proposed conditions which have been agreed to by the applicant, the conditions are attached at **Appendix 3.**

5.10. Other Persons:

5.10.1. The Council has received 20 representations against the application from members of the public. Copies of the representations are attached to this report at **Appendix 4**.

6. Implications of the Recommendations

6.1. Legal Implications

- 6.1.1 The Sub Committee must determine this application in accordance with S.18 of the Licensing Act 2003. To do so otherwise would render its determination unlawful and invalid.
- 6.1.2 In accordance with the provisions of section 18(3)(b) of the Licensing Act 2003 the Licensing Authority Sub Committee must, having regard to the representations, made in this application take such steps (if any) as it considers appropriate for the promotion of the licensing objectives.
- 6.1.3. Section 18(4) provides that the authority may:
 - a) Grant the licence subject to conditions as are consistent with the operating schedule accompanying the application, modified to such extent as the authority considers appropriate for the promotion of the licensing objectives and any mandatory conditions that much be included on the licence in accordance with the Licensing Act 2003;
 - b) Exclude from the scope of the licence any of the Licensable Activities to which the application relates;
 - c) Refuse to specify a person in the licence as the Premises Supervisor;
 - d) Reject the application.

Members are reminded that should any conditions be added, they should be practical, enforceable and appropriate to promote the Licensing Objectives.

- 6.1.4. Members are also reminded of the statutory obligation placed on the Local Authority under section 17 of the Crime and Disorder Act 1998 to through all of its various functions, and Licensing is one of those functions to do all that it can to prevent Crime and disorder, Anti-social Behaviour, behaviour adversely affecting the environment and reoffending.
- 6.1.5. Members must give reasons for their determination and notice of it must be communicated to the parties to this application.

6.2. Finance Implications

6.2.1. There are no financial implications.

6.3. Policy Implications

- 6.3.1. The Licensing Authority has adopted a Statement of Licensing Policy in accordance with section 5 of the Licensing Act 2003.

A CCTV system shall be used and shall be designed and installed in accordance with the Cheshire Constabulary's CCTV guidance document called 'CCTV in Licensed Premises – An Operational Requirement'. This system shall be in operation at all times when licensable activities are taking place.

Recorded CCTV images will be maintained and stored for a period of twenty-eight days.

A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises are open to the public. This staff member shall be able to provide a Police officer or an authorised officer of the licensing authority data or footage upon request. All requests for footage are to be provided within a reasonable time scale.

Designated supervisors will need to demonstrate that their CCTV system complies with their Operational requirements. They will need to be able to demonstrate the following:-

- · Recordings are fit for their intended purpose,
- Good quality images are presented to the officer in a format that can be replayed on a standard computer
- The supervisor has an understanding of the equipment/training,
- Management records are kept,
- · Maintenance agreements and records are maintained,
- Data Protection principles and signage are in place.

A "Challenge 25" policy shall be operated at the premises at all times.

The only forms of ID that shall be accepted (at the discretion of the Management) as proof of age are a valid passport, a valid photographic driving licence, a PASS approved proof of age card, HM Services Warrant Card or other reliable photo ID (that has been approved for acceptance by the Police or an Officer of the Local Authority)

Publicity materials notifying customers of the operation of the "Challenge 25" scheme shall be displayed at the premises.

The Designated Premises Supervisor or Premises Licence Holder shall operate and maintain an up-to-date Register of Refusals of Sale of Alcohol, indicating the date, time and reason for refusal which shall be made available for inspection by Local Authority Officers and the Police.

The DPS or other responsible person shall check and sign the register once a week.

Alternatively an electronic point of sale refusals log shall be kept.

A documented training programme shall be introduced for all staff in a position to sell, serve or deliver alcohol. 

I wish to make a Representation in reference to an application for a premises license applied for by Venue Catering and Events Limited in respect of the premises known as Combernere Abbey Wedding Venue, Combernere Park Drive, SY13 4AJ.

The licensable activities that I am concerned with are for plays, films, live music, recorded music, performance of dance and anything of a similar description both indoor and outdoor Monday to Sundays 08.00 to 00.30 each day.

I believe my representation is relevant to one of the four licensing objectives: The prevention of public nuisance with the specific issue of noise. My family and I would favour a change to the timings of these activities so they may end with a half hour leeway from 23.30 to ensure the party has ended by 00.00

is 500 metres due west of the wedding venue, situated on a hill beyond the Mere, with no obstruction other than a few trees and a walled perimeter of the venue's garden. The noise is very audible, especially from live music and recorded music from outdoor and indoor. Sound amplifies when travelling across water. The windows actually vibrate to the bass.

Evidence is based on living close to the weddings venue in the last 10 years. We made representations to the management in person and by phone. They did cooperate by ending the noise around 00.00 on most occasions. We also received emails warning us about fireworks. But there was no evidence of a noise management plan and little attempt at noise mitigation other than ending near 00.00.

These weddings have had a significant effect on our lives at home, while relaxing, watching TV, and while trying to sleep. The current Application offers no mention of noise mitigation between 08.00 and 00.30, other than a proposal" to have no amplified music to be played outside after 21.00". In section M of the application, when asked to promote the four licensing objectives under Public Nuisance, all it says is "The applicant welcomes any communications from any interested party concerning the operation of the premises". There is no mention of noise mitigation. Music, both Live and recorded, is

as loud from inside as it is outside a marquee. I have been told that the present marquee will be replaced by another next year but I doubt if there will be any significant abatement of the noise. I would therefore ask for a potential noise assessment, and a licence that requires some noise testing during events after 21.00.

I understand that this wedding venue is a standalone, by a historic house with few residents. It still makes our case important as it causes mental stress, discomfort, severe anxiety and when you consider the fact that we are quite isolated, these problems are magnified due our senses being used to quiet rural surroundings. The new events management will have in excess of one hundred weddings a year, if not more for years to come.

I came across this application with a notice on the entrance gates to Combermere inviting representation before the deadline of 18th April 2022. It is a freehold property owned by myself in the middle of Combermere Park. I pay the Council tax to Cheshire East. This noise affects the property, as this pollution is a major factor in any sale evaluation. As a grade 2 historic building it has windows that are difficult to double-glaze, especially those facing the venue.

On the application there is no person to contact, no telephone number, and when I did my research I found that Artemis, based in Surrey, are the Holding Group of a Company that owns Venue Catering and Events Limited. So even trying to get in touch as neighbours is a laborious process. They did approach us, but only after the owner of the site put us in touch following my request. Their Group Operations Manager, assured me in writing that future weddings will end at 23.30, with a few exceptions, hence the need to ask for 00.30. All we ask is to end music at 23.30 on most days and 00.00 on exceptions.

I have kept copies of the emails with both our neighbour at Combermere Abbey and Artemis. I have had no contact with Venue Catering and Events Limited's General Manager at Combermere Weddings as yet.

I represent Evans House Limited t/a Marbury Camp and Lodge, which operates a 'quiet camping' and glamping business situated directly to the north of the Premises. I also live on our Site with my wife and infant son and have done so for 5 years now.

Objection

In respect of the Applicant's application to hold events comprising:

- Plays, films, live music, recorded music, performance of dance and anything of a similar description to that falling within live music, recorded music or performance of dance (all indoors and outdoors) Monday to Sunday 08:00 - 00:30 each day;
- 2. Late night refreshment indoors and outdoors Monday to Sunday 23:00 00:30 each day; and
- 3. Supply of alcohol on and off the premises Monday to Sunday 08:00 00:30 each day

I (for and on behalf of my business and household) specifically wish to object to a licence being granted to the extent detailed above.

Reason for objection

In consideration of the 4 licencing objectives, I consider the application fails, in its current form, because:

• the prevention of crime and disorder

o The Premises is situated in a dark, rural environment with little or no transport links, pavements or other means of getting to the adjoining towns. Promoting the sale of alcohol for 16.5 hours a day 7 days a week is statistically bound to increase the risk of drink driving and accidents both on site and off site. It is also statistically bound to increase the risk of alcohol-related disorder. The hours requested are excessive and disproportionate to the commercial aims of the Applicant.

public safety

As stated above, the main risk associated with public safety is the access and egress to the Premises operating such long hours with alcohol involved throughout the day. I assume the Applicant might suggest that they can facilitate guests staying on the Premises to negate the risk of harm arising from access and egress. It should however be noted that guests do not all stay on the Premises and we often host guests for Combermere Abbey weddings at our Site. It should also be assumed that other guests are staying off the Premises at other accommodation provider sites. This means that a proportion of all guests who have attended events where alcohol is served all day are driving several miles down dark, unlit lanes late in the evening. It should also be noted that having lived in Whitchurch for 5 years, we have found only one single taxi company (a married couple) to be reliable. The use of taxis cannot therefore reliably alleviate the risk of harm of all the guests accessing and egressing the Premises.

• the prevention of public nuisance

- o The issue concerning access and egress above is repeated. The poor transport links are bound to increase the risk of intoxicated event guests leaving the Premises by foot down a fast main road with no footpath. This is statistically likely to cause incidents of public nuisance and road traffic incidents along the highway.
- Further, our central concern is public nuisance caused by noise. Our Site is situated directly between the Grange Barn Wedding Venue and the Applicant's Premises. Having started our own business, we are perfectly content with a reasonable amount of noise from time to time from neighbouring businesses. Our main issue is that in the 5 years we have lived here, there has been a lot of noise from weddings and events at

the Applicant's site. It is often so loud that we have complained to the venue direct, but received no response. We have also contacted them on social media quoting the lyrics to the song being played (which is quite something considering the distance between our sites and the forest in between). We have also previously submitted noise complaints to Cheshire East Council. By way of example, last night (16 April) we had friends over for an evening meal and listened to dance music from the Premises. Our friends commented that "it sounds like a rave." We have no wish for this to continue unabated indoors and outdoors 16.5 hours a day from the Premises (disregarding for the moment, the noise from Grange Barn as well). It should also be noted that our business depends upon the quiet countryside. We are classed as a 'quiet site' and insist on low noise from our campers at all times and no noise after 10pm. This is not a requirement of our licence, but our own standard. We have built a reputation and our business is based upon this. I am strongly concerned that the noise from the Premises up to 16.5 hours daily would destroy our business in which we have invested so much personally and financially. I will happily submit evidence from our customers to the effect that they would not choose to stay at our Site if noise pollution became an issue.

the protection of children from harm

Following on from the above, it should be noted that on several occasions my infant son has been woken by the noise (music and fireworks) from the Premises. From memory this is what caused us to log a complaint with Cheshire East Council previously. Considering my son sleeps in a room with double glazing, blinds, curtains and a 'rain noise machine' that illustrates how loud the events can be. Developmentally, sleep is essential to a young child's wellbeing. I submit that 'round the clock' daily events including music and alcohol will not only affect my child's development, but also the other young children that live within earshot of the Premises.

For the above reasons I respectfully submit that the application be withdrawn and/or rejected in its current form and perhaps be limited to 6.00pm to 10:30pm on Fridays and Saturdays. I would also strongly suggest a transport plan be implemented by the Applicant to address the risks identified above. Finally, it would be prudent to impose an acceptable noise level (say 70-80dB) to be monitored at all times.

For your information, we will now commence a log of all the noise that we can hear from the Premises, should a licencing hearing become necessary and evidence is to be given.

- Residents are already plagued by noise from the Grange Barn Wedding Venue on a regular basis, despite promises of keeping noise contained; last Saturday's wedding event was the noisiest ever for the neighbouring houses.
- That the Full New Premises Licence to be opposed.
- A number of residents find it appalling that neighbouring councils and residents are not notified directly of such applications; I think the only requirement is that it is posted in the local press.
- The application for plays, films and music, to be extended to Monday to Sunday 08:00 to 00:30 hrs (close at 01:00) should be totally

refused. Since Marbury is only 2.07miles as the crow flies such an extension would give carte blanche permission to create an intolerable noise nuisance to a wide area, not just Marbury.



I would like to register my family's representation to the application for the new premises licence at Combermere Abbey Wedding Venue, SY13 4AJ.

We live 2km (in a straight line) from the venue but regularly are kept awake at night through the summer given the excessive noise from Combermere Abbey often on successive weekends, late into the night. The music emanating from the site has regularly caused many of the nearby village residents of Aston, Marbury and Wrenbury to voice their concerns on social media over the last few years as the development continues to grow. The business already poses a public nuisance, but the thought of this premises being able to play loud music from 8am to past midnight (16.5 hours) every day of the week is simply excessive, unjustified, out of keeping with the rural setting and significantly detracts from local residents' incidental enjoyment of their own property.

A reasonable proposal would be a licence the premises from 7pm to 11pm every other Friday and Saturday, but conditions should be applied to ensure that mitigation measures (e.g. shutting all windows/doors etc of the premises) are in place to reduce noise to the surrounding area.

Given that the estate has attracted significant public funding in recent years, developed an unwanted housing estate in Aston, and imposes such noise on the area on a regular basis it would be a nice gesture for the owners to give something back to the community on a regular basis too...even if it were simply an annual free open day for local residents. Many of us have lived in the area our entire lives and have never been granted the opportunity to view the property for which we have all indirectly contributed.

Please note, it is of concern that the only place that this is advertised is on telegraph poles between the Abbey entrance and Sound School - a very busy road that is hard to stop and view the notices. No notices have been posted within the community centres of Marbury, Wrenbury, Aston or further to the west into Shropshire (who may not be in Cheshire East, but will be affected). To my knowledge the local Parish Councils of Wrenbury, Marbury and Aston, whose boundaries adjoin the estate, have not been consulted, nor have the people of these communities. It is also frustrating that the application and relevant information is not available for viewing online. The above severely limits the numbers of people who would otherwise take issue with this application.

Just the very shock of the noise can cause them to abort and/or stampede and cause damage to themselves and fences etc. We breed Shire and Clydesdale horses which are normally placid animals but are very dangerous to themselves and our workers if frightened.

We have complained multiple times without any response whatsoever.

We wish to object, most strongly, to the application for a Full New Premises Licence for Combermere Abbey Wedding Venue.

Previous events have caused disturbance to ourselves and other nearby residents (Marbury) when loud, persistent music can be heard throughout the evening and night. There are also many occasions when massive noisy firework displays have taken place; these frighten and harm the wildlife in the area and cause our own animals and pets extreme distress.

The area surrounding Combermere Abbey is rural, a mix of pasture and woodland, and scattered housing.
