

Brief Description of Decision	<p>Being satisfied that traffic should be prohibited to facilitate works, to give public notice of and make a temporary road closure order under s14 of the Road Traffic Regulation Act 1984, as amended, and all other enabling powers to prohibit traffic on Wrenbury Road/Station Road, Wrenbury from the junction of Pinsley Green Road to the junction with Nantwich Road for a period of 18 months or until the works have been completed, whichever is the sooner.</p>	
Reasons for the Decision and alternatives considered	<p>For works to the level crossing to be carried out it is necessary to close Wrenbury Road/Station Road, Wrenbury from the junction of Pinsley Green Road to the junction with Nantwich Road.</p>
