Purpose of Report

- 1 The Cared for Children and Care Leaver Committee Annual Report 2024-25 at Appendix 1 sets out the work of the committee and progress against the Cared for Children and Care Leavers Strategy since April 2024.
- This report supports the work of the committee in achieving the aim in the council's Corporate Plan to 'be the best corporate parents to our children in care.'

Executive Summary

The purpose of the Cared for Children and Care Leaver Committee as an advisory committee to the Children and Families Committee is to ensure that the Council effectively discharges its role as corporate parent for all children and young people in care and care leavers from 0-25 years of age and holds partners to account for the discharge of their responsibilities.

Background

- The Cared for Children and Care Leaver Committee Annual Report details the progress and achievements over 2024-25 against the six pledges the Council has made to cared for children and care leavers in the Cared for Children and Care Leavers Strategy.
- Key stakeholders, including cared for children and young people and care leavers, are regularly consulted on the work of the Cared for Children and Care Leaver Committee and Council and partner services. The six pledges within the Cared for Children and Care Leavers Strategy are based on what young people told us matters most to them.
- As an advisory committee to the Children and Families Committee, one of the roles of the Cared for Children and Care Leaver Committee is to act as advocate for cared for children and care leavers, ensuring that their needs are addressed through key plans, policies and strategies throughout the Council and its commissioned services.

13 Cared for children and care leavers are a vulnerable group for whom there are a number of risks, including poor outcomes in education and training, health, safeguarding and transition into adulthood. The Cared for Children and Care Leavers Strategy outlines plans to mitigate these risks.
