Title: Cabinet Procedure Rules

### 1.0 Purpose of Report

1.1 To report to the Committee upon the subject matter of this report and to inform the Committee of the recommendations of Cabinet, which met on 6<sup>th</sup> January 2009.

### 2.0 Decision Required

2.1 That the Committee consider the issues raised in the Cabinet report, and the recommendations of Cabinet, in order to make its recommendations to Council.

### 7.0 Background and Options

7.1 On 6<sup>th</sup> January 2009, the Cabinet considered a report which now forms the Appendix to this report.

- 7.2 The substantive issues are contained in the Cabinet report, and Cabinet has subsequently made recommendations to the Governance and Constitution Committee, which ask the Committee to make recommendations to Council. These are set out in paragraph 8 of this report, in draft form (as the minutes were not formally approved at the time of preparation of this report).
- 7.3 The recommendations of the Governance and Constitution Committee will be reported to Council at its meeting on 24<sup>th</sup> February, following which the decision of Council will be embodied into the Council's Constitution Committee, which will take effect on Vesting Day.

#### 8.0 Draft recommendation of Cabinet

- (1) That the Governance and Constitution Committee recommend to Council:
  - a. That the Cabinet Procedure Rules appended to the report should be adopted by the Council with effect from Vesting Day.
  - b. That the issues identified in Appendix A to the report be noted and that the Council shall have a Leader and Cabinet form of executive arrangements, these to include the "Strong Leader" model.
  - c. That a 3 working day notice period be required in respect of any question which is to be asked at Cabinet by a member of the public.
- (2) That a further report be made to members upon the practical arrangements for individual Cabinet Member decision-making.

#### 9.0 Reasons for Recommendation

9.1 In order for the Council's Constitutional and decision-making arrangements to be agreed prior to Vesting Day.
