

On arrival there was a large group with raised voices	in the backyard are	ea of the pu	ıb, it wasn	't

inside the pub the door supervisor had been struck at	some point and the	ere were by	the time o	of our
arrival about 20 people screaming, shouting and point	ting at each other.			
At this point I requested that other patrols should atter	nd the pub due to t	he number	of people	
inside, which was over 100 people several of whom v	vere volatile. Num	nerous mino	or argumen	nts
and scuffles were happening around us and I spoke w	ith the owner and t	told him to	request	
everyone to leave. At this point I became aware of a c	lrunken more matu	ire woman	who I now	V
know to be seemed to be with	another female w	ho would s	eem to be	her
daughter, I recognised her as being one of the group v	who had been outsi	ide shouting	g, inside th	ne

pub she was very unsteady on her feet, she had difficulty focusing her eyes and was slurring her speech, she was obviously very drunk. I heard her shouting at another blonde woman inside the pub it was apparent that she was very argumentative; she was repeatedly heard to say "FUCK OFF!" She was told to leave the pub numerous times, eventually the door supervisor escorted her to the door area, she fell to the floor and seemed to struggle to get to her feet, she was wearing high heeled boots. Whilst sat in the doorway she shouted "FUCKING GET OFF ME! YOU CAN'T FUCKING DO THIS I'M 50 YEARS OLD." She was told numerous times by myself to calm down and stop swearing. Once outside she was strongly advised to leave the area and go home but she insisted on staying outside the pub and continued to shout obscenities at others outside. There were 20 - 30 people outside, approximately 10 of whom were very volatile. was again told to leave the area but refused to co-operate, stating "I'M A FUCKING 50 YEAR OLD WOMAN AND I HAVEN'T BEEN OUT FOR NEARLY A YEAR, THIS IS ALL FUCKING BOLLOCKS!" I then warned her that her behaviour was out of order, that she was aggravating an already volatile situation which was being further inflamed by her shouting and swearing. There were numerous members of public who were present in the street at this time, watching the chaos in the street. I then again saw stood near to by the Police Car, I could hear that he was also warning her about her conduct, as I walked over to him, I saw that had gently to guide her away from the area, she took offence to this lunged toward PC with her hands raised to push him back shouting "FUCK OFF I'M GOING put his hands up to push and keep NOWHERE!" Due to her confrontational manner her back, with this she stumbled backwards and fell over, at this point a group of about 5 others

approached aggressively and had to be pushed back and eventually restrained by other officers who had arrived at the scene. was pulled to her feet and appeared uninjured, once stood up she again started to swear, shouting "YOU CAN'T FUCKING DO THIS TO ME, I'VE DONE FUCK ALL WRONG, IT'S A LOAD OF SHIT." At 11.55pm that same night, I then placed handcuffs on her to the front; she continued to swear and be argumentative throughout the whole process, due to her demeanour I informed her she was under arrest but did not caution her at that time. The arrest being necessary for a prompt and effective investigation. She was taken to Nantwich Police Station where the reasons for her arrest were properly outlined to her and she was cautioned to which she replied "IT'S ALL A FUCKING LOAD OF BOLLOCKS" She was searched at Nantwich Police Station, her jewellery was removed and all her property bagged and recorded accordingly. was unco-operative, continuing to use foul language but less aggressive at Nantwich Police Station and numerous times asked why she had been arrested as she had done nothing wrong. Despite being told why she had been arrested she seemed oblivious to what had been said. was handed to Reliance who assisted in her transportation to

Middlewich Custody where her detention was authorised.

the two males were separated, the	pub had approximately twenty people inside, most of
which were shouting. A male mem	ber of staff then shouted for everyone to leave the
pub, the pub is closed.	
Before any further details could be	taken of the two males, I was made aware of a further

hostile and had the potential to cause a large scale disorder.


