I wish to make representation of my objection to the application for a Liquor and music Licence proposed by Tabley House Tea Room Ltd.

The Tearooms lead directly through to the 16th Century consecrated Chapel which has always been a sanctuary for those seeking peace after visiting sick and elderly relatives in the adjacent Tabley Care Home.

Likewise, the Tearooms have providing refreshment for the family to 'meet up' after those visits.

I wish to register my concerns regarding the application by Tabley Tearoom Limited for a new licence to provide recorded music and sale/supply of alcohol, Monday to Sunday 11.00 to 22.00.

Whilst not wishing to be obstructive to the notion of a 'glass of wine with afternoon tea', I'm afraid that the extent of this application (year long, morning to night), by a commercial trading company, raises issues of public nuisance, safety, crime and disorder.

#### **Public Nuisance**

Within a few meters of the tearooms are 22 private homes and the dementia wing of an old people's nursing home. Access to a chapel is also made via the tearooms. The unrestrained extent of this application means that there is great potential for public nuisance in a quiet, rural location. I believe that the tearoom has traditionally opened only during the opening hours of the museum, namely April – October, 2 – 5pm. Implicit in this application, is the establishment of a venue that can open year round for day and evening functions, including weddings, thereby creating noise and disturbance whenever and as often as the licensee wishes.

#### **Public safety**

Access to the tearoom is off a busy main road (A5033), via a private, long, single track road which is jointly maintained by Crown Properties, the residents and Cygnet Healthcare. There are current issues around over-usage and the poor state of the access, including broken stone setts and cattle grid. The road is unlit. Game shoots are scheduled throughout the season when users and residents are warned to be extra vigilant. Additional traffic will greatly increase the risk of accident.

#### Prevention of crime and disorder

'The Stables' (21 properties) and 'The Old Laundry' are adjacent to the chapel and tearoom. It is a remote location, with no stewardship, and the gardens and private grounds are easily accessed by people wandering around. I am concerned that regular evening use, especially with alcohol involved, will increase the risk of trespass and littering; and at worse, expose the residents to potential theft of property and break-in.

I trust that the Licensing Committee will consider these objections and reject this application in its current form.



"Provision of Recorded Music and Sale and Supply of Alcohol – Monday to Sunday 11.00 to 22.00."

In connection with the above application I hereby wish to register my representations (objections) as explained in your "Guidance on Making a Representation".

## 1) The prevention of crime and disorder.

"The Stables" (21 properties) and "The Old Laundry" are only yards away from the Tearoom. These are set in a remote location and would allow any visiting opportunist to see how vulnerable .... houses are to break-ins etc.

### 2) Public safety.

Access to the Tearoom is off the busy main road (A5033) via. a single track road and, even with the existing amount of traffic creates difficulty. Any additional traffic would greatly increase the possibility of a road traffic accident. There is no form of lighting on this road at all.

### 3) The prevention of public nuisance.

Apart from the noise from the recorded music our peace and quiet could be disturbed when people are leaving the venue. Next door to the Tearoom is the EMI (elderly, mentally, infirm) unit run by Tabley Nursing home also the main house is partly used as a Nursing Home and they would also incur the same problems. In the past, when functions have taken place in and around Tabley House, people have been trespassing on our private land, leaving empty glasses, vomit, and signs where people have been urinating around our properties.

These Tearooms have been operating without the need for a Licence for almost 20 years and there has been minimal disruption to our homes during this period. Opening times are in tandem with the Museum from April to October between 2 and 5pm. There is direct access from the Tearoom to the consecrated Chapel where people sit and reflect in the serenity. If this Licence is approved it would be detrimental to this sanctuary, the value of our homes, and the end to the lifestyle we have been accustomed to.

Tabley House buildings are Grade 1, and The Stables are Grade 2 listed buildings. The web page for Weddings at Tabley House states: - "Due to the unique nature of Tabley House we are unable to provide wedding breakfasts or evening receptions". Surely these are further reasons for not issuing the Premises Licence.

Another comment is that the days and times requested in their Licence Application are not the same as the Tearoom opening schodule. When querying this we were informed, by Tabley House Collection Trust, "There is no variation to this licence; it is a case of one size fits all".

In connection with the above application I hereby wish to register my representations (objections) as explained in your "Guidance on Making a Representation".

# 1) The prevention of crime and disorder

The possibility (and fear) of problems arising if the licensing hours extend to 22.00 hours Monday to Sunday throughout the year, because Residents adjacent to the Tearoom have already experienced trespassing and unacceptable drunken behaviour from visitors to events in the vicinity in the past. The security of our homes would be jeopardised.

# 2) Public safety

The area is dark and surfaces slippery so use in the hours of darkness and during the Winter months would be dangerous.

# 3) The prevention of public nuisance

The level of noise from recorded music and from wandering drinkers around the area, also people and vehicles leaving the premises at night, is a definite concern for residents.

I do understand that to be competitive, it would be beneficial to the Tabley Tea Room to serve glasses of wine or beer with lunches and the fashionable 'Prosecco Afternoon Teas' during British Summertime from 12 noon to 15.30 hours on Thursday, Friday, Saturday and Sunday (when Tabley House is open to the public) with quiet recorded music playing and the occasional extra event, and I have no problem with this. I do however object to a full licence to include spirits to be served at night all year round, not necessarily accompanied by food. This is entirely unsuitable in the setting of the Tabley Tea Room.

It appears that the licence applied for is to cover the Tea Room as a premises rather than to have a specified individual as a responsible licensee, and I think that could prove to be problematic, as whoever is in charge at any one time could have different views on level of music played and may not have the ability to curb undesirable behaviour which can arise when alcohol is available. Often there is only one person on duty in the Tea Room and they could be taken advantage of, with no one nearby to give support.

There is also local concern that the Tea Room gives access to a consecrated Chapel which is open to the Public as a sacred space. It is also adjacent to Tabley House Nursing Home where elderly people are living, although I hear that their Matron

believes that the licence would be handled sensibly. Noise and too many visitors is stressful to the animals and wildlife surrounding the Tabley Tea Room, quite apart from us neighbours who have moved into the Grade I listed park for peace and tranquility. Obviously we do not wish our homes to be devalued, which they would be by an all day, all year alcohol licence.
