#### 1.0 Report Summary

1.1 The purpose of this report is to inform the Portfolio Holder of the intention to dispose of former Highways land at The Bield, The Green, Nantwich. The land is shown hatched on the attached plan for identification purposes and is adjacent to an area of land recently stopped up in accordance with Section 116 of the Highways Act 1980.

#### 2.0 Decision Requested

2.1 That approval is given for the proposed land disposal in favour of Mr and Mrs Banks upon terms to be formalised by the Assets Manager & the Borough Solicitor.

#### 3.0 Reasons for Recommendations

3.1 The area of land is considered surplus to Cheshire East Borough Council requirements. The land originally formed part of the A51 until the construction of the Nantwich ByPass in the early 1990's. Since the opening of the Bypass in 1991, the land has been used soley as the vehicular access to The Bield and has been subject to occasional fly tipping.

#### 11.0 Background and Options

- 11.1 An application was originally received from Mr and Mrs Banks, The Green, Reaseheath to stop up an area of Highway land adjacent to their dwelling in 2008. Worleston and District Parish Council fully supported the proposal and believed that it would prevent fly tipping and help keep the Parish tidy. The stopping up order was subsequently granted by the Magistrates Court on the 25 November 2009.
- 11.2.1 Mr and Mrs Banks have made an approach to The Borough Council with a request to purchase a small plot of land which is located immediately adjacent to the stopped up land. It would not be appropriate to advertise the land on the market due to its location within the middle of the former highway. Once authority has been granted to proceed then negotiations will be progressed with Mr and Mrs Banks.
