Section 1: Introduction

Background and methodology

Between November 2019 and January 2020 Cheshire East residents and other stakeholders were invited to provide their comments and views on the councils pre-budget report 2020-24 which included details of proposals related to each Outcome within the Corporate Plan, from each service area. This report provides a summary of the responses received during this time.

The online survey was promoted via a media release, on the councils website and on social media platforms. Members of our digital influence panel (residents of Cheshire East who have signed up to receive digital consultation/ survey requests) were also sent a direct link to the survey and staff members were encouraged to have their say/ provide their suggestions. Paper copies were sent to libraries and key contact centres and various engagement events were held. Details of key engagement events can be found in section 8 of this report. A summary of results from the 'Save us Money' internal staff survey is included in this document.

This specific consultation activity resulted in around103 general, specific or grouped responses. The online survey was viewed around 1,780 times - whilst we cannot detect if this was by separate individuals it still indicates that engagement was reasonable. A total of 99 valid responses were received for the online/postal survey. 2 further responses was received via e-mail and 2 other group responses were obtained during engagement events. Some of the responses were from elected representatives or from organised groups however the majority were from residents of Cheshire East.

The asset is not the Council's to sell as it is operated under a 99 year non-transferable lease from the National Trust. Tatton's annual operational costs are approximately eight times the net operating cost. Previous discussions with the National Trust have indicated that they would require significantly more than the net operating budget every year from the Council as part of any settlement, while lease conditions on the Council would remain in place for the duration of its term. Operation by the Council is therefore more cost-effective while retaining control over decisions relating to the property (eg affecting its wider contribution to the Cheshire East economy).

A local Resident	Whilst it brings culture to the area is it not capable of sustaining itself	Tatton contributes a net of around £5.32m GVA, (SQW 2017), to the local economy every year attracting visitors and providing a cultural and tourism destination. In addition it has significant environmental, social and cultural value to the area. It was transferred without any endowment, was isolated from the rents and land assets that would have originally funded the estate and does not receive operational funding from the National Trust. Tatton's annual operational costs are approximately eight times the net operating budget. As a result of an effective and efficient operation Tatton is successful in earning income to sustain over 87% of the operating costs while also making a significant contribution to the local economy. The park does not have access to income from what was originally a wider estate that would have sustained the costs through rents and other income sources as those assets are now privately owned. Tatton Park is therefore reliant upon its earned income from visitors, having already significantly reduced its reliance on Council funding to the current level.

There is no evidence that a preferential scheme for residents for Tatton Park increase revenue. However, Tatton Park will be undertaking a review of pricing strategy to look at options for differential pricing in order to ascertain whether income can be optimised through different mechanisms. Any changes that may result would not come in until 2021 if the evidence-based changes are recommended. In the meantime Tatton park already operates promotional schemes via website offers and via its e-newsletter. These promotions have included a summer car entry pass for £10 and currently a Jan/Feb. offer for 50% car and free gardens entry. In addition, Tatton Park normally takes part in the Cheshire-wide 'Residents festival' promoted by Marketing Cheshire to celebrate 'Tourism week' in March, which includes promotional offers for residents.

Responses have been collated against each comment below, and will be reflected, where appropriate, in any recommended amendments to the proposals currently being put forward.
