Prevention of Crime and Disorder

1. In the event of any misbehaviour there is a comprehensive disciplinary procedure in place.
2. There shall be alarms in all areas of the premises, except the changing facilities, which are linked to the Police.

Public Safety

3. A common sense approach shall be applied to maximum numbers attending functions.
4. All fire exits shall be clearly labelled and kept clear at all times.
5. There shall be signs displayed detailing what to do in the event of discovering a fire.

Prevention of Public Nuisance

6. In the event of public nuisance by one of the members, this will be dealt with under the disciplinary code.
7. Members shall be requested to leave the premises quietly.

Protection of Children from Harm

8. Children may only use the clubs facilities under the supervision of an adult.

General – All Licensing Objectives

9. Health and safety and fire regulations shall be adhered to at all times.
