Thank you for the information.

With this i would like to clarify my position.

With regards to point 1. The extension of drinking in their smoking yard to 2:30 will only encourage more people to go out there and stay out there as there is no reason to go back inside. They can socialise out there and others wanting to smoke will join them leading to more noise as more people are out there. It should remain as it is to keep the number of people outside at 11pm with the purpose of smoking then returning inside. The extension of them wanting to allow customers into the garden until 1am is outrageous and they have the nerve to suggest on the application that this is to aid licensing objectives. This would bring nothing but nuisance and antisocial behaviour to an unreasonable hour. So they wish to allow their customers free reign of the garden until 1am.

With regards to point 2.

They want to reduce the number of supervisors (i presume they mean security) to lower numbers yet they are asking to increase the area in which they control. Don't they have like 4 areas inside. How can they manage with 4. Allowing them to reduce would just mean things will be under less control than what they are. Look at the amount of times police come down to here.

With regards to point 3. They want to extend the time in which customers that are too drunk can come down the street to cause more nuisance.

It's good to know that after 1am, the worst has happened with noise. But now this will be extended at all ends if this is passed.
