Members are reminded that, in accordance with governance procedure rule at Part 3 paragraph 2.6, Panel Members, or their constituent authority, may nominate substitute members of the Panel in the event that the appointed representative(s) is/are unable to attend the meeting. Advance notice of substitution should be given to the host authority wherever possible. Members are encouraged wherever possible to secure the attendance of a substitute if they are unable to be present.

2. Code of Conduct - Declaration of Interests. Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012

Members are reminded of their responsibility to declare any disclosable pecuniary or non-pecuniary interest which they have in any item of business on the agenda no later than when the item is reached.

3. **Public Participation**

To receive questions from members of the public. A total period of 15 minutes will be allocated for members of the public to speak at Panel meetings. Each member of the public shall be limited to a period of up to 5 minutes speaking. At the Chair's discretion the period made available for questions and statements may be extended.

In order that an appropriate answer to the questions can be given, the deadline for indicating a wish to speak or for submission of questions is 3 clear working days

before a meeting of the Panel. The Chair has the discretion to waive the 3-day rule for issues deemed to be urgent.

In response to questions or statements the Panel may choose to agree to either provide an agreed verbal response, that will be minuted or to provide a written reply to a questioners chosen address.

A list of those speaking or asking questions at a meeting of the Panel will be drawn up by the Panel's Secretariat in order of receipt. Copies will also be available on the Police and Crime Panel's page of the Cheshire East Council website.

Nobody may submit more than one question or make more than one statement at the same meeting, but a supplementary question, related to the subject raised in the question /statement, will be permitted for clarification at the discretion of the Chair.

Those speaking or asking questions will not be permitted to address any issue that is the subject of a current or proposed complaint by them against the Police and Crime Commissioner. They are also advised that reference to an issue that could become the subject of a future complaint by them could prejudice the Panel's consideration of that complaint.

The Panel will not accept a question or statement if:

There is insufficient detail to enable a proper response to be provided.

It is not about a matter for which the Police and Crime Panel has responsibility.

It is potentially defamatory, frivolous or offensive against named individuals.

It is substantially the same question which has been put at a meeting of the Police and Crime Panel in the last six months.

It requires the disclosure of confidential or exempt information.

1. APOLOGIES

Subject: Dates and timings of Panel Meetings

1. Report Summary

1.1 This report requests that the Panel consider the dates and timings of future meetings.

2. Recommendation

- 2.1 The Panel is recommended to:
 - (i) Consider a programme of meetings for the municipal year 2025 26.
 - (ii) Confirm that unless there are issues of room availably, or operational reasons meaning an alternative venue would be more appropriate, the Panel will hold its meetings at Ellesmere Port Library.

3. Programme and timing of Meetings

3.1 Since its creation the Panel has followed a consistent pattern of regular, programmed meetings, with additional meetings being added to the diary when necessary. Following the practice of recent years of Panel meetings normally being held on a Friday, a day when the four Cheshire Councils have few public meetings, a suggested programme of meetings (with all meetings commencing at 10.00am) for the forthcoming municipal year is:

20th June 2025 (AGM)

12th September 2025

21st November 2025

6th February 2026

20th February 2026 (reserve date, should meeting be necessary)

10th April 2026. (This date will need to be kept under review, should Mayoral elections take place in May 2026).

- 3.2 The meeting room at Ellesmere Port Library is the only location where Panel meetings can be live video webcast, something which in the past, Panel members have requested.
- 3.3 The suggested programme of meetings is broadly similar to that adopted by the Panel in previous years.
- 3.4 A meeting on Friday 6th February 2026 would fit in with the statutory timetable for the consideration of the Police precept. A meeting on 20th February 2026 would only be necessary should the Panel veto the Commissioner's proposed precept at its meeting on 6th February.

Cheshire Police and Crime Panel

Questions to the Police and Crime Commissioner, May 2025

- (1) Nationally the Police Federation have raised profound concerns regarding the wellbeing of Officers, with 69 percent of Officers reporting high levels of fatigue and 28.9 percent saying that they had extremely high levels of fatigue. It is recognised that these are national figures and that the position in Cheshire may be different, but could the Commissioner outline the steps he is taking to ensure that the Chief Constable has the policies in place to mitigate such levels of fatigue, and the stress faced by Offices undertaking their day to day duties?
- (2) Commissioner, at the last meeting the Panel approved your precept, with the recommendation that the Panel receive quarterly performance reports. I recognise that we are only in the first quarter of the financial year, but could you give the Panel some indication of what data will be included in these regular reports?
- (3) Commissioner, the Citizen's Assemblies are welcome, can I ask whether they will prompt changes to this year's crime and policing plan, or are intended to shape next year's plan?
- (4) What attempts have been made to access views of hard-to-reach communities outside of the Citizen's assemblies?
