In his introductory comments the Commissioner congratulated the Constabulary on the excellent work that it had done in relation to Operation Hummingbird, which had led to the successful prosecution, at Manchester Crown Court, of Lucy Letby. The trial had lasted for almost a year and the case had been one of the most complex criminal investigations in history.

The Commissioner also briefed the Panel on a number of other issues, including pensions forfeiture, road safety and a bid for funding in the fifth round of the Safer Streets programme.

The Chair added his own, and the Panel's congratulations to the Police, for the work undertaking in relation to Operation Hummingbird.
