# Shavington, Rope

# Shavington and Rope: matters to decide

Whether this area should have a two-Member ward, or two single-Member wards.

In the map on the next slide, the different colour shadings indicate the areas that each potential ward would cover:

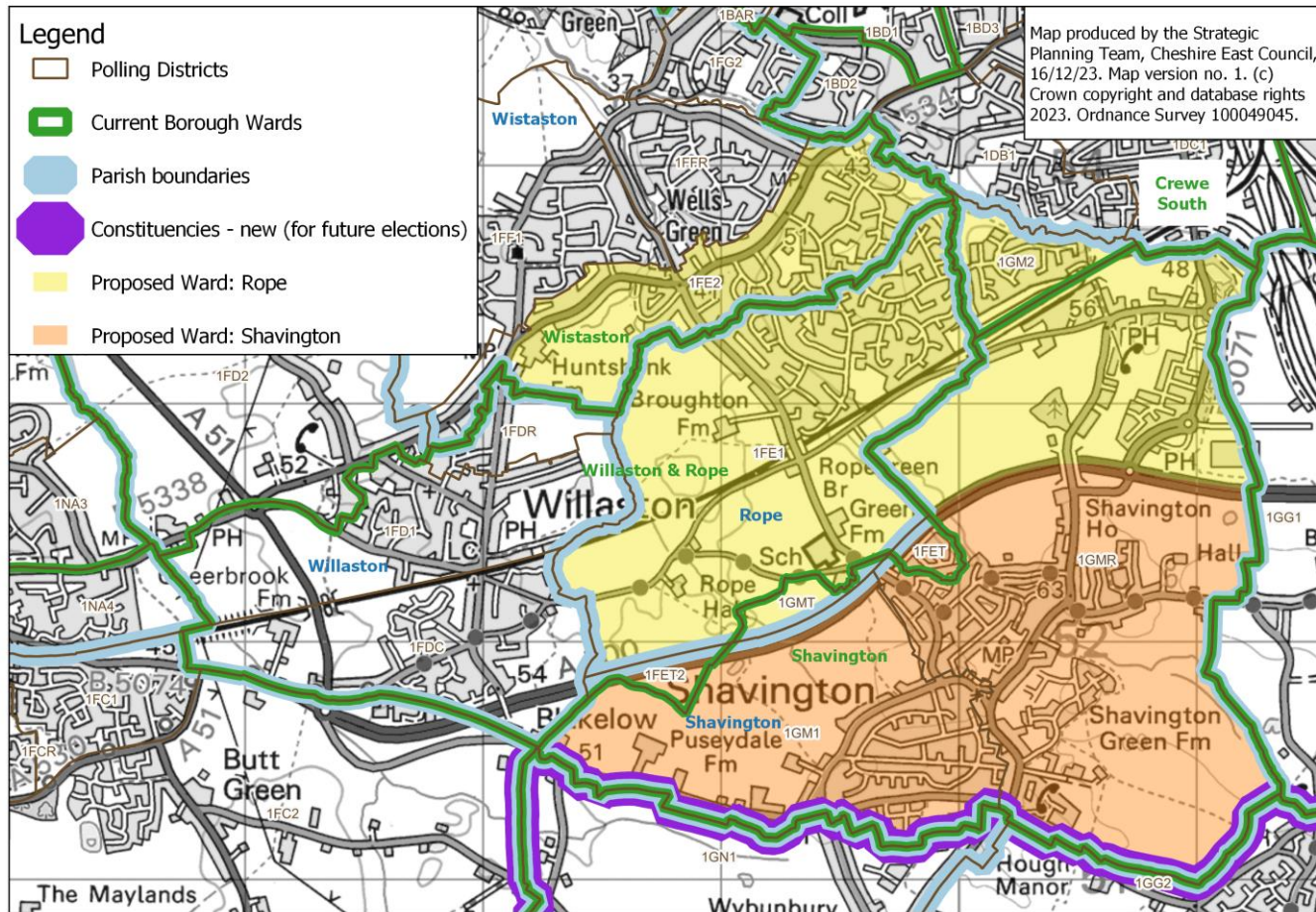
- The yellow shading shows the area of a would-be single-Member 'Rope & Gresty' ward.
- The orange shading shows the area of a would-be single-Member 'Shavington' ward.
- The yellow and orange shading collectively shows the full extent of a would-be two-Member ward, which would be called 'Shavington'.



# Shavington/ Rope\* ward area extent and potential division (shown by the different colour shadings) into two single-Member wards

\*Note: It is proposed that, if split into single-Member wards, the northern (yellow shaded) ward would be called 'Rope & Gresty'.

# Matters to decide

The Sub-Committee has already decided on the boundaries of the wards that would surround Congleton, and that the Congleton wards collectively will have 6 Members. However, the names and number of Congleton wards, and the boundaries between now, still need to be agreed.

2 options below presented :

- A division into two wards, with three Members each.
- A division into three wards, with two Members each.

Both options would bring the Kestrel Close estate (Local Plan site LPS 32) entirely within Congleton East. The estate is currently split between Congleton's two existing wards and between the COC1 and COS4 polling districts. The three-ward arrangement takes the LPS 32 boundary as the new ward boundary line in this location, but the two-ward option (to achieve a more even number of electors in each ward) would transfer a larger area of COC1 (not just its LPS 32 part) to the East ward.

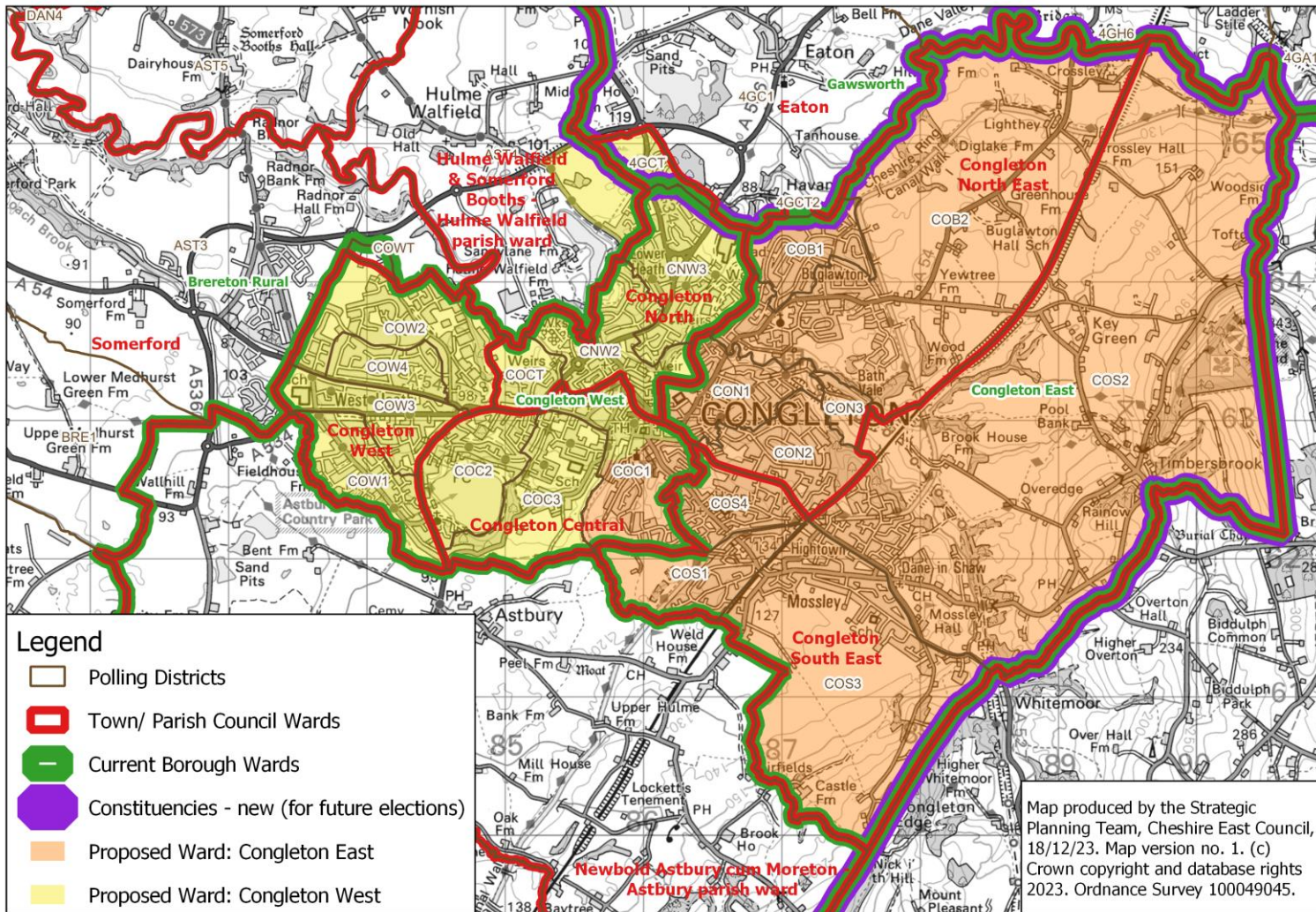

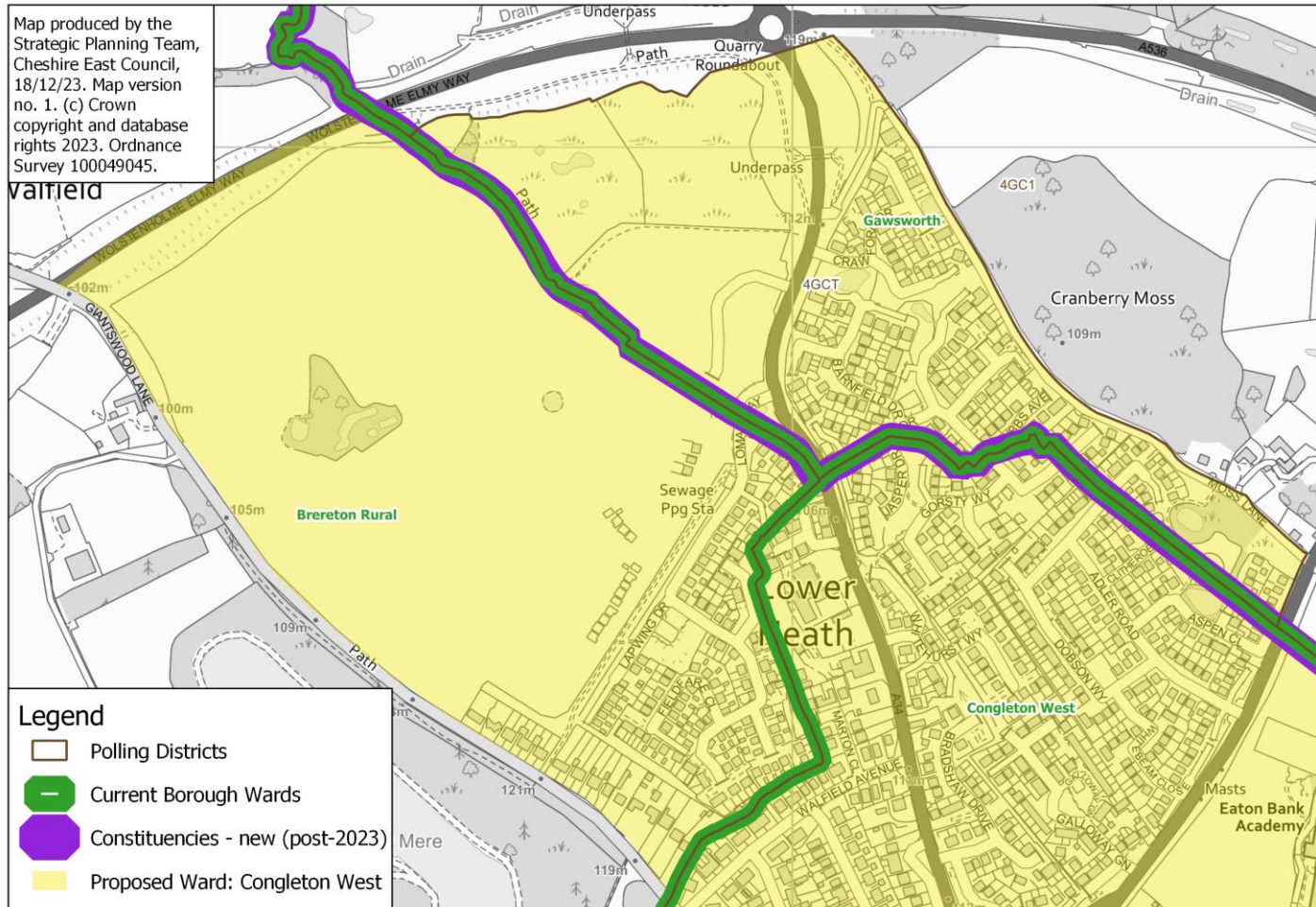




## Congleton: 2-ward option – close-up of Link Road area\*

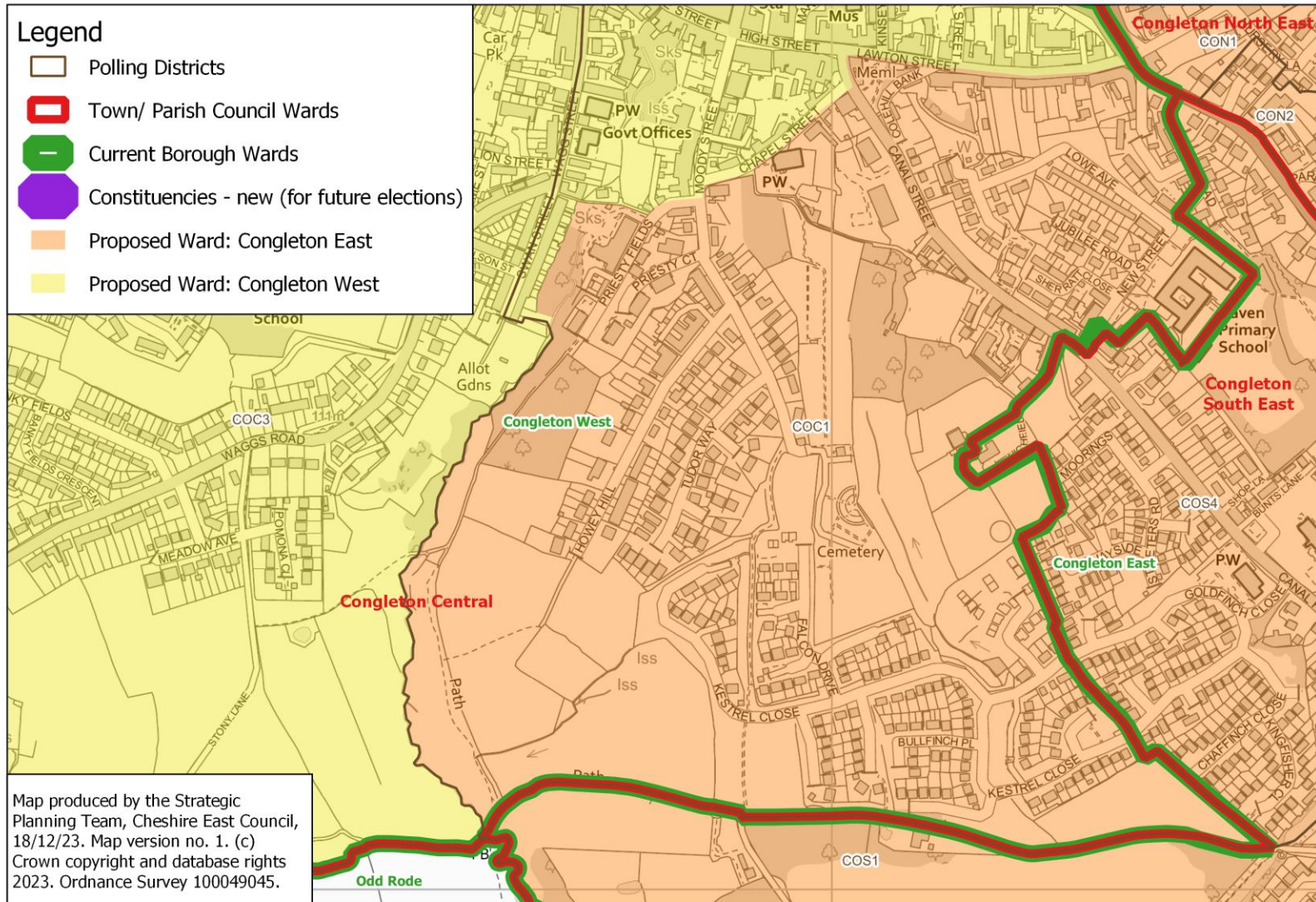

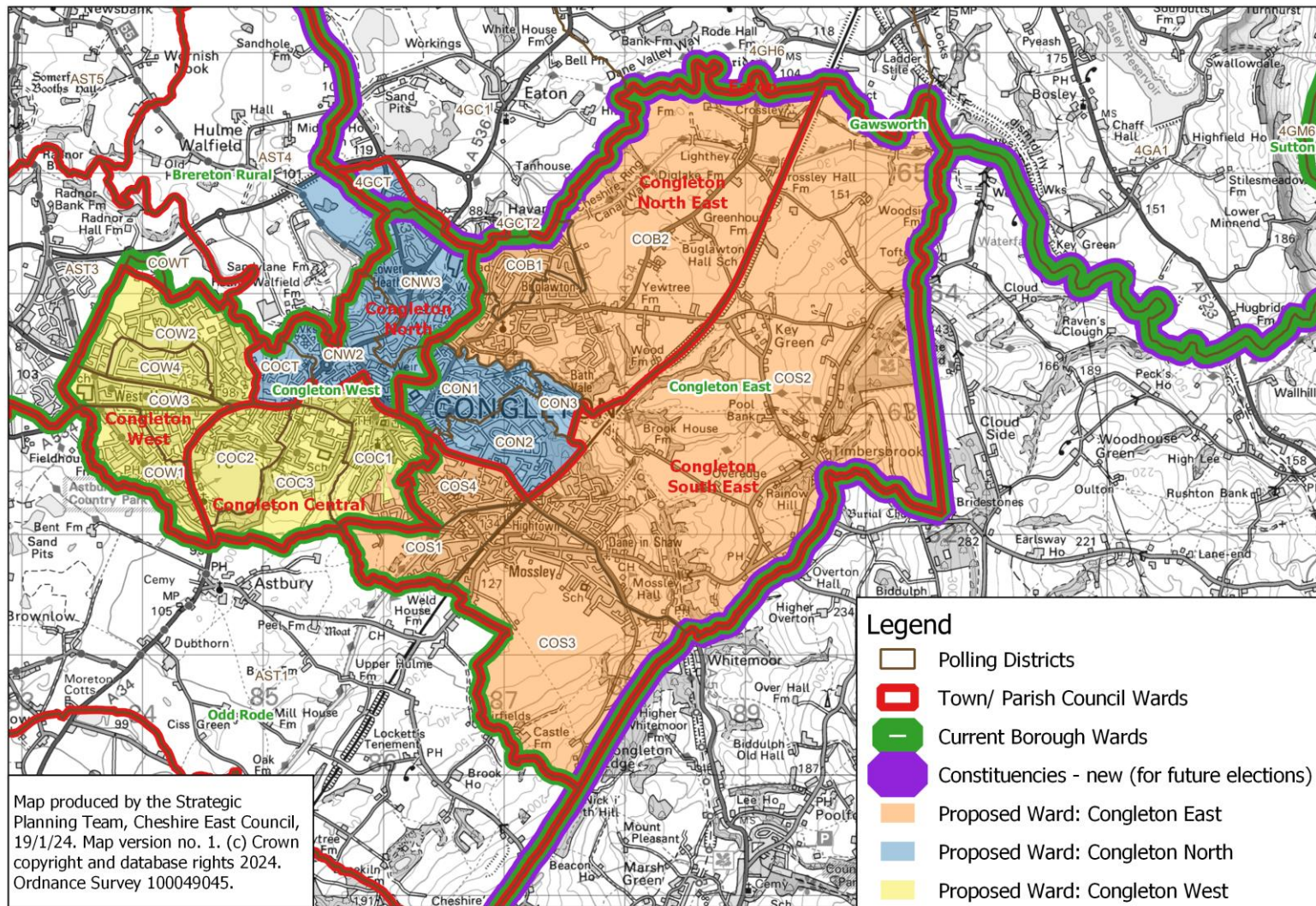
Congleton: potential Borough wards (two three-Member wards - revised proposal) - close-up of boundary in Canal St area

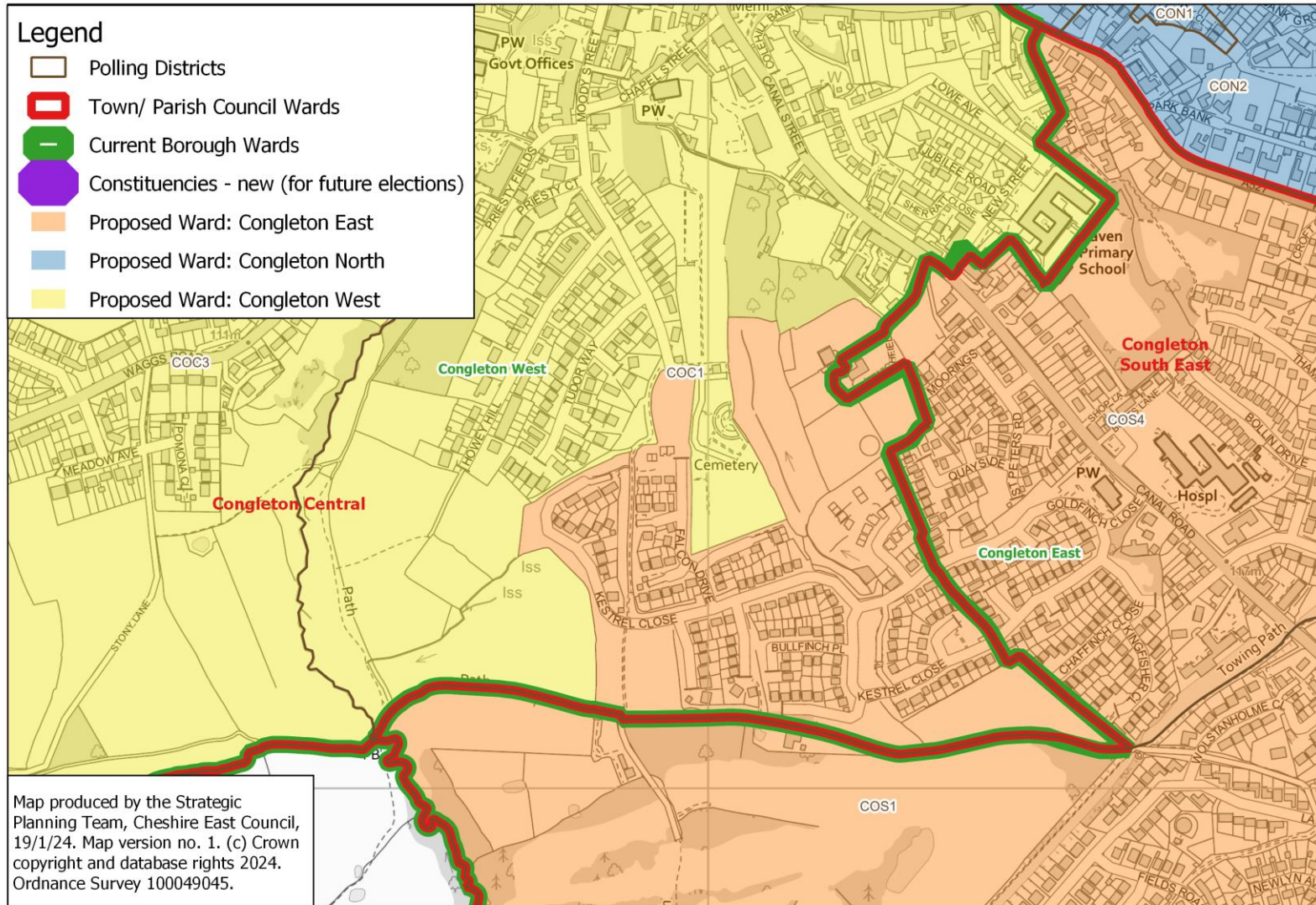
