### 1.0 Report Summary

1.1 This report outlines the process that has been followed and provides feedback on the success of the engagement events.

- 1.2 This will include an update on the range of issues and how Cheshire East Highways are progressing the works and studies that have been identified.
- 1.3 Four routes were identified for studies in the 2012 / 13 financial year. These are the A34, A50, A51 and A49.
- 1.4 A further route, A530, is also to be carried out in the 2012 / 13 financial year with the engagement event planned for the 21<sup>st</sup> November 2012.
- 1.5 These routes were identified based on concerns raised in relation to safety and the operation of the routes.
- 1.6 This report summarises the progress to date both in relation to the consultation phase of the studies, works on site and further works required in assessing road safety and speed limit issues
- 1.7 Updates are also available through the Cheshire East Highways service information website http://www.cheshireeasthighways.org/Welcome.aspx

#### 2.0 Progress

- 2.1 An engagement event was held on the 31<sup>st</sup> July for the A34, A50, A51 and A49 (the A51 was also reviewed at an earlier event 30<sup>th</sup> May).
- 2.2 Key stakeholders were invited including Parish and Ward Councillors the Fire and Police and Council Officers with in total 34 people attending the event.

- 2.2 This allowed those who attended to view plans showing information including that relating to road safety, congestion, road condition. Cheshire East Highways staff were present to answer questions and feedback was recorded.
- 2.3 Opportunity was given to those unable to attend to provide feedback through a downloadable questionnaire.
- 2.4 Following the feedback the data has been collated and categorised into maintenance issues and traffic and road safety issues. As summarised in the table below.

- 9.1 The Route Management Process has been introduced to provide a consistent approach to the review of the operation of key routes within the Borough of Cheshire East.
- 9.2 This allows for an approach that considers road safety, traffic, new developments, and road condition in identifying the issues affecting the route.
- 9.3 Using engagement events key stakeholders have been invited in to meet officers to identify those issues that are affecting the route. This has also included council officers to identify issues that have been raised across the authority.
