99 MINUTES OF THE MEETING HELD ON 28 FEBRUARY 2013

100 DECLARATIONS OF INTEREST

Rachel Musson, Interim Chief Operating Officer, declared an interest in respect of item 7 – Designation of Section 151 Officer and left the meeting during consideration of this matter.

Councillors Dorothy Flude and Wesley Fitzgerald each declared a non pecuniary interest in respect of item 8 – Election of Mayor and Appointment of Deputy Mayor for the 2013/14 Civic year and left the meeting during consideration of this matter.

101 MAYOR'S ANNOUNCEMENTS

The Mayor announced that:

- 1. Councillor Michelle Sherratt had given birth to a baby boy on 23rd April; the baby had been named Quinn Lyrid Sherratt Hale. On behalf of the Council he expressed his good wishes to Michelle.
- That Councillor Steve Carter had been elected to represent the Macclesfield Hurdsfield Ward at a By-Election held on Thursday 25th April. Councillor Carter was formally welcomed to the Council meeting.
- 3. That since the last meeting, he had represented the Council at four funerals. He reminded Members that Council had paid its respects to Honorary Freeman Margaret Duddy MBE at its last meeting. He had attended her funeral on 8th March at Disley Parish Church.
- 4. The following week he had attended the funeral, at Chester Cathedral, of John Platt OBE, Mr Platt had been the longstanding president and chairman of the world famous Cheshire Show and was for many years the Chairman of Governors at Reaseheath College.
- 5. On 23rdApril, he had represented the Council at the funeral of Michael Livesley. Michael was a former Leader of Macclesfield Borough Council and the father of Councillor Bill Livesley.
- 6. On 24th April he had represented the Council at the military funeral, in Handforth, of Lance Corporal Jamie Webb of the Mercian Regiment. Lance Corporal Webb died from wounds he received in Afghanistan.
- 7. He had also been notified of the recent death of a former Macclesfield Borough Council Member, Harry Mottershead. Mr Mottershead represented Poynton on the Borough Council in the 1970s.

Members stood in silent tribute, as a mark of respect.

103 APPOINTMENT OF CHIEF EXECUTIVE AND DESIGNATION OF SECTION 151 OFFICER

(Rachel Musson, having declared an interest, left the meeting during consideration of this matter).

Consideration was given to a report of the Chief Executive containing a recommendation from the Staffing Committee in respect of the appointment of a Chief Executive, including salary to be paid. The report also contained a recommendation on the designation of the Council's Head of Paid Service, the Electoral Registration Officer and Returning Officer, and separately a recommendation to seek approval that the Interim Chief Operating Officer be formally designated as the Council's statutory section 151 Officer.

RESOLVED: That

- (a) Mr Mike Suarez be appointed as Cheshire East Council's Chief Executive and Head of Paid Service, with effect from the earliest possible date to be arranged;
- (b) the salary of the Chief Executive be confirmed as £150,000 a year, with a performance related payment of up to £10,000 in addition;
- (c) Mr Suarez be appointed as Electoral Registration Officer pursuant to Section 8 of the Representation of the People Act and Returning Officer, pursuant to Section 35 of that Act, and in respect of referenda and all other electoral matters referred to in the report: and
- (d) Ms Rachel Musson, (Interim Chief Operating Officer), be designated formally as Cheshire East Council's statutory Section 151 Officer.

104 ELECTION OF MAYOR AND DEPUTY MAYOR FOR THE 2013/14 CIVIC YEAR

(Councillors Dorothy Flude and Wesley Fitzgerald, having each declared a non pecuniary interest, left the meeting during consideration of this matter).

The table above shows the allocation of places as at May 2013 following consultation with the political groups.

These revised Political Proportionalities are based on the decisions made by Council to ensure the total number of seats on all ordinary committees allocated to each Political Group bears the same proportion to the proportion on the full Council having regard to recommendations made by the Group Whips.

The 'others column' shows the proportion of seats which relate to the one Member of the Council who does not belong to a group. There is no entitlement to any committee places for Members who do not belong to a political group.

The proportionality rules do not apply to the Cabinet, or the Appeals Sub Committee, the Licensing Sub Committees, the Local Service Delivery Committee, or to the four panels/sub committees connected with the Councils new standards arrangements, which are drawn from a combination of Members of the Audit and Governance Committee, an additional panel of 5 members nominated by the groups and the four independent persons. COUNCIL MEETING – 15TH MAY 2013

Extract from the Minutes of the Cabinet Meeting on 7th May 2013

188 **DEVELOPMENT COMPANY**

Cabinet considered a report recommending that the Council set up a Development Company, wholly owned and controlled by the Council, to drive forward the development of the Council's land assets for housing and economic growth.

The report summarised the work of Deloitte LLP (business and financial advisors) and Bevan Brittan LLP (legal advisors), appointed to evaluate options and report back on a preferred model to provide the best opportunity to realise the ambitions of the Council, and to create the infrastructure necessary to ensure greater prosperity for local residents.

The preferred option was the delivery of the Council's objectives through a wholly-owned and controlled arm's length company, where the Council retained ownership of the physical assets. The principal advantage of this option was that it allowed the Council to focus its delivery through the separate arm's length company, without distracting the company's management and staff with the Council's other day-to-day operational requirements. The Company could also better promote the Council's land and property assets for development through the Local Plan and planning process.

RESOLVED

That

- (1) Council be recommended
 - (a) to approve the setting up of a Development Company East Cheshire, Engine of the North, wholly owned and controlled by the Council, in the form described in the report, to drive forward the development of the Council's land assets, as a key element for the Council's wider plans for housing and economic growth;
 - (b) to appoint initially to the Board of the Company the following non-executive Directors: Cllr A Thwaite (Chairman), Cllr D Druce (Vice Chair), Cllr D Newton (Vice Chair), Cllr P Groves, the Director of Economic Growth and Prosperity (Caroline Simpson), the newly-appointed Head of Development (Darran Lawless) and to agree that the Interim Borough Solicitor (Mike Rowan) take on the role as Company Secretary; and
 - (c) to approve that a Shareholder Committee be established comprising of the Leader, Deputy Leader, Portfolio Holder for Prosperity, Portfolio Holder for Resources and the Chief Executive.
- (2) subject to (1) above, the Interim Chief Executive and Interim Borough Solicitor and Monitoring Officer be granted delegated authority to take forward the actions

required to implement the recommendations and set up the Development Company, reporting back to Cabinet in October 2013 on progress, specific actions to take forward being:

- 1. to set up the Company as operational (separate legal entity) and establish its Memorandum and Articles of Association by end May 2013;
- 2. to finalise initial staffing arrangements and related HR considerations; insurance arrangements; and other operating procedures to ensure that the Council's budget envelopes and capital plans in relation to the activities of the Company are clearly understood by end May 2013; and
- to develop a 3-Year Business Plan for the Company, to establish the portfolio
 of assets it is required to act upon; any provision of resources to facilitate land
 acquisitions; set objectives against which its performance will be measured.;
 and draw up Company Objects and, if relevant, an Agency Agreement by end
 October 2013.
