It is potentially defamatory, frivolous or offensive against named individuals.

It is substantially the same question which has been put at a meeting of the Police and Crime Panel in the last six months.

It requires the disclosure of confidential or exempt information.

#### 1. APOLOGIES

Apologies were received from Cllr Mike Fry (Halton), Professor Barry Godfrey, Cllr Mike Jones (Cheshire West and Chester), Mrs Gemma Shepherd – Etchells and Miss Yasmin Somani.

Cllr Chris Carlin substituted for Cllr Mike Fry.

## 2. CODE OF CONDUCT - DECLARATION OF INTERESTS. RELEVANT AUTHORITIES (DISCLOSABLE PECUNIARY INTERESTS) REGULATIONS 2012

No declarations of interest were made.

#### 3. PUBLIC PARTICIPATION

No members of the public wished to speak at the meeting.

#### 4. MINUTES OF PREVIOUS MEETING

#### **RESOLVED**

That the Minutes of the meeting held 20th June 2025 be approved.

#### 5. CHAIRS ANNOUNCEMENTS

The Chair welcomed Cllr Andrea Wall (Halton) to her first meeting of the Panel.

The Chair noted that the Panel would shortly be holding a second training day, following on from the one held earlier in the year, she would be consulting with Panel members over the subjects that would be covered at the event.

Reflecting on the recent informal meeting with the Commissioner which had been held in Warrington, the Chair thanked Sergeant David Thomason for the presentation that he had made. In his presentation he had outlined some of the uses the Constabulary were making of AI in its work combating stalking and harassment. The Chair noted that she had written to Sergeant Thomason thanking him for his presentation and congratulating him on the award of the King's Police Medal in the King's Birthday Honours.

The Panel reviewed its work programme for the remainer of the civic year.

### 7. WELCOME TO THE COMMISSIONER AND COMMISSIONER'S INTRODUCTION

The Chair welcomed the Commissioner and his Chief Executive to the meeting. The Commissioner briefed the Panel on a range of issues.

The Chair thanked the Commissioner for the progress report that he had submitted to the Panel, noting that that the Panel had requested this information when it had approved his proposed Precept at the meeting in February. The Panel reviewed the information provided by the Commissioner, seeking clarification on a number of issues.

The Chair noted that Cllr Mike Jones, who was not able to attend the meeting, had produced a very helpful commentary on the Commissioner's Police and Crime Plan which he had circulated to Panel members in advance of the meeting; she asked the Commissioner a number of questions prompted by the work undertaken by Cllr Jones.

The Commissioner introduced his annual report taking questions from Panel members.

That the Panel note the Commissioner's Annual Report, with no formal recommendations being made.

#### 1. APOLOGIES

Apologies for absence were received from Cllr Mike Jones, (Cheshire West and Chester), who was substituted by Cllr David Brown (Cheshire East).

## 2. CODE OF CONDUCT - DECLARATION OF INTERESTS. RELEVANT AUTHORITIES (DISCLOSABLE PECUNIARY INTERESTS) REGULATIONS 2012

No declarations of interest were made.

### 3. COMPLAINTS RECEIVED ABOUT THE CONDUCT OF THE POLICE AND CRIME COMMISSIONER

The Chair explained that three separate complaints alleging political bias by the Police and Crime Commissioner had been received by the Panel in July and August 2025. The full text of each complaint, with only names and email addresses redacted had been published with the papers for the Sub – Committee. In the supporting papers the complaints were described as complaints 1, 2 and 3.

The background papers had also included a copy of the Police and Crime Commissioner's Ethical Framework and Code of Conduct, this document includes a summary of the Seven Principles of Public Life (the Nolan Principles)

and the full text of the Oath of Office taken by the Police and Crime Commissioner following his election in May 2024.

The Chair and Deputy Chair of the Sub - Committee, in accordance with the procedure contained in the Panel's Procedure Rules, had reviewed the complaints when received and determined that they should be considered at a meeting of the Sub-Committee. The Chair noted that a slight delay in convening the meeting had been due to Panel member availability.

Each complaint was considered in turn, with the Sub-Committee taking advice from officers as necessary. The host authority's Interim Head of Legal Services/Deputy Monitoring Officer expanded on the legal advice provided in the report contained in the information presented to the Sub - Committee, explaining that in their personal capacity, a Commissioner may engage in political activities, including making personal endorsement, in the same way as any other citizen.

With reference to the telephone call made to the Commissioner's Office referred to in Complaint 2, the Sub - Committee noted that it was unfortunate that the Office of the Police and Crime Commissioner had no record of the call, but were grateful that checks had been made and that the Commissioner's Office had indicated that they did not dispute that the call had been made.

#### **RESOLVED**

The Sub Committee resolved unanimously that:

- (i) In relation to Complaint 1, the Police and Crime Commissioner had not breached his Code of Conduct or Oath of Office.
- (ii) In relation to Complaint 2, the Police and Crime Commissioner had not breached his Code of Conduct or Oath of Office.
- (iii) In relation to Complaint 3, the Police and Crime Commissioner had not breached Sections 8(a), 8(c) or 9(b) of his Code of Conduct or his Oath of Office, or the Nolan principles; nor had he shown political bias when acting as Police and Crime Commissioner.
- (iv) In relation to Complaint 3, it had been appropriate for the Police and Crime Commissioner to quote full-year figures in relation to crime statistics, as these were more likely to show trends than figures relating to individual months.
- (v) The Panel's Secretariat be asked to draft the formal notices summarising the outcome of each complaint and, when approved by the Chair and Deputy Chair, that these be shared with each complainant.

#### **Questions to the Commissioner, November 2025**

- 1. SWAP Fund: I would be grateful if you could clarify the following points.
  - (i) Audit Process: What audit or oversight process exists for monitoring the allocation and use of SWAP funds?
  - (ii) Fair Distribution: What measures are in place to ensure the funding is distributed fairly across the whole area for which the PCC is responsible?
  - (iii) Political Neutrality: How is it ensured that funds do not disproportionately benefit organisations with political connections, such as those linked to local councillors?

2. In the approach to the festive season what campaigns are you running or championing to safeguard Cheshire's residents and/or make it an area hostile to crime?

#### **Gemma Shepherd - Etchells**

Your fellow Police and Crime Commissioner for Bedfordshire, John Tizard, has called on the government to tighten up the sale of firearms. He is calling for a system to be put in place for clearance from the police to be required prior to the sale of any firearm, not just having the purchaser showing a firearms certificate which could indeed be fake. Will you be supporting this? What are you doing to ensure illegal firearms are not on the streets of Cheshire?

4. With devolution processes being looked at within Cheshire this obviously has implications on the role of the Police and Crime Commissioner. A report by the Association of Police and Crime Commissioners looking at this and the transfer of police and crime powers was published in July 2025. It is proposed that there will be a Mayor with overall responsibility and a Deputy Mayor for policing and crime. With the option of having a Public Safety Commissioner do you feel this would further complicate matters in the eyes of the public as you have previously commented that people can be unsure of the role of the Police and Crime Commissioner at present and how this is differentiated from the police. What will you be advising at any discussion with the local authorities on this?

5. You will recall that at the Police and Crime Panel on 12 September 2025, there was a question relating to the 20<sup>th</sup> Anniversary of the Hunting Act. Some parts of this were considered to be related more to operational policing procedure, than falling within the Commissioner's role. This included suggestions for improved, active communication between all stakeholders and the use of notices to allow all, including the public to be aware of hunting activity in their area and to prepare for it. The answers provided have given rise to follow up questions.

In order to move this discussion forward and to ensure that it remains within the parameters of the Commissioner's role, would you be prepared to meet stakeholders and to discuss the drafting of a Commissioner's Cheshire Hunting Strategy which would meet your Police and Crime Plan pillars of listening to the public, modernising and reducing crime?
