# 26 SHARED SERVICE POSITION STATEMENT

Consideration was given to a report summarising the current position of the shared service arrangements between Cheshire East (CE) and Cheshire West and Chester Councils (CWAC). In particular it highlighted those short term shared services that had recently disaggregated to enable a transition to separate delivery arrangements in each Council as planned. An appendix to the report detailed the position on all current shared service arrangements.

It was reported that an Archives Review meeting was due to be held in the near future and it was hoped that an update on the Youth Offending Service would be available at the next meeting. Discussions were ongoing regarding the International Unit and the termination of the lease for the Brussels Office.

#### RESOLVED

- 2. That the Learning Resource Network and Autism Support Shared Service Transition Logs be endorsed.

#### 27 FINANCIAL REVIEW 2011-2012

# 1 Report Summary

1.1 This report provides an update on activity relating to transitional Shared services and proposals that affect their operation that require consideration by the shared Services Joint Committee.

# 2 Recommendations

2.1 That members approve the extension of the transitional Youth Offending Shared Service until 30 September 2012 to allow CWAC to review activity in order to inform future delivery.

# 3 Reasons for Recommendations

- 3.1 The proposed change for this service has been agreed with operational managers from both Councils and the shared service managers in accordance with the general shared service governance. An extension is sought to ensure a smooth transition to an alternative delivery model for Youth Offending Services in Cheshire. In summary the position of Cheshire East whilst not excluded from the pan Cheshire arrangements, is to continue with the current arrangement whilst CWAC is minded to pursue an alternative arrangement which is to enter into a formal partnership with Halton and Warrington YOT.
- 3.2 The change to this shared service enables the functions they provide to continue to be delivered while the most appropriate long-term arrangement is considered.

# 4 Wards Affected

4.1 This report relates to shared services that operate across both Cheshire East and Cheshire West & Chester so all wards are affected in both Councils.

# 5 Local Ward Members

# 6 Policy Implications including - Climate change - Health

# 7 Financial Implications for Transition Costs

7.1 The costs of transitioning to alternative arrangements in each Council have yet to be established. Once these are known they will be reported to Members

# 8 Financial Implications

- 8.1 The shared funding arrangements for the YOS are based on 47% CE: 53% CWAC split. The budget for 2012-13 is yet to be finalised as the amount of grant funding is still to be confirmed so financial implications are based on current year budget.
- 8.2 The 2011/12 budget for Cheshire East and Cheshire West and Chester contributions is £1,015,250. There are other funding streams from the likes of the Youth Justice Board and statutory partners such as Health, Police and Probation. As a result of the Shared Service Budget Challenge process the Cheshire YOS was requested to make 20% efficiency savings in 2011-12 This will be achieved and the service will deliver a balanced position at year end. It is anticipated that the YOS will receive its full year's budget allocation from all funding streams for 2012-13 and that any residual funds remaining after the transition to new arrangements has been completed will be divided on the basis of the cost sharing agreement.

# 9 Legal Implications

- 9.1 As the sharing arrangements for this shared service are being revised, the following legal documents will need to be revised:
  - The Service Agreements for these services;
  - The secondment arrangements for these services.
- 9.2 The Administrative Agreement sets out the overall arrangements in relation to the manner in which the Authorities will work together. This requires that in the event of either party terminating the Agreement a

period of not less than 6 months, or a lesser or greater period if agreed, be provided. CWAC had advised CE of their intention to terminate the current arrangements for a shared YOS however it is estimated that a six month extension to existing arrangements will be required to facilitate a safe transition to new arrangements in each authority. A formal resolution of this Committee is necessary to provide a legal basis for the extension of the shared services.

# 10 Risk Management

10.1 The main risk with the transition of the Youth Offending Service is the potential disruption of services provide to vulnerable young people and potentially increased risks within communities. This sharing arrangement is currently due to terminate on 30 March 2012 however this provides insufficient time to complete disaggregation and a safe transition to new arrangements. The requested extension will provide for a period of stability to service users and employees whilst the transition process is planned and implemented..

# **11** Background and Options

- 11.1 In 2009 Legal arrangements, business plans and service delivery statements were developed for all shared services and presented to the Joint Officer Board and the Joint Committee. These are regularly reviewed to ensure that they remain relevant to the services being delivered.
- 11.2 All services are now working in accordance to these agreements and plans, delivering services to both Councils under the guidance of the Joint Officer Board and the Joint Committee. However, as work progresses, the need to extend some of the shared service arrangements is being identified..
- 11.3 A number of shared services committed to undertake strategic reviews to determine the most appropriate delivery model for the future in the business plans. The YOS has recently undergone this process.

# 12 Youth Offending Service

12.1 The Youth Offending Service has been designated a transitional shared service to ensure that a strategic review is undertaken and the most appropriate long-term model introduced. This work was completed by the Youth Justice Board in March 2011 and the recommendation was for the current arrangement to continue. Two previous extensions have been agreed by this committee.

- 12.2 Work to identify an appropriate long-term model has progressed in accordance with the terms of reference agreed by the Joint Officer Board, with both Cheshire East and Cheshire West & Chester client managers completing an initial analysis of their long term requirements of the service. However, during the second phase of the review, to determine whether the current sharing arrangements can and should satisfy these requirements an approach was received from the Cheshire Sub-region Leadership Team requested that options for a potential pan-Cheshire Youth Offending Service be explored.
- 12.3 This aspect of the review has now been completed and it has concluded that a pan-Cheshire Youth Offending Service be implemented. CWAC are minded to support this recommendation and join up with the Warrington and Halton Youth Offending Service whilst CE Council do not believe that this provides the best option for their service users moving forward. Therefore it has been agreed that current shared arrangements between the two authorities be dissolved in favour of pursuing alternative service delivery arrangements.
- 12.4 The current arrangements between CE and CWAC for a shared YOS are due to terminate on 30 March 2012. However a further extension up until 30 September 2012 is being requested to ensure that a comprehensive transition plan can be agreed and implemented by the two Councils. This will for allow for wider consultation on the new arrangements whilst ensuring a good degree of business continuity and stability to service users during the transitional period.
