2 DECLARATIONS OF INTEREST

3 PUBLIC SPEAKING TIME/OPEN SESSION

Wilmslow Town Councillor Ruth McNulty attended the meeting on behalf of Wilmslow Town Council and spoke in support of the recommendations contained within the report.

4 PROPOSED DOG CONTROL ORDERS FOR THE CARRS, WILMSLOW

Consideration was given to a report in relation to the recent consultation exercise on proposed 'dog control orders' regarding specified areas of land at The Carrs in Wilmslow. The Cabinet Member was requested to consider the responses received and approve a number of Orders.

RESOLVED

That the following Orders be made:-

(1a) Fouling of Land by Dogs (The Carrs, Wilmslow) Order 2012 (as set out in Appendix A)

(1b) The Dogs (Specified Maximum) (The Carrs, Wilmslow) Order 2012 (as set out in Appendix B)

(1c) The Dogs on Leads (The Carrs, Wilmslow) Order 2012 (as set out within Appendix C)

(1d) The Dogs on Leads by Direction (The Carrs, Wilmslow) Order 2012 (as set out in Appendix D)

2 That the Borough Solicitor, or officer acting on her behalf, be authorised to make and bring into force the order(s) and to give notice thereof in accordance with statutory requirements.

3 That the level of fixed penalty notice in relation to offences under the proposed dog control orders will be £75.

5 REGULARISATION OF MARKET PROVISION

Consideration was given to a report on the legal position in relation to the methods by which market rights may be established together with information in relation to the existing markets at Alsager, Knutsford, Middlewich, Nantwich, Sandbach and Wilmslow. The report requested the consolidation of the existing market rights by the application of the powers within Part III of the Food Act 1984 (as amended).

RESOLVED

That

(1) without prejudice to the Council's existing market rights however acquired, Markets be established in Alsager, Knutsford, Middlewich, Nantwich, Sandbach and Wilmslow under Part III of the Food Act 1984 (as amended).

(2) the markets at Alsager and Sandbach shall come into force only if the Certificate of Lawfulness of Existing Use or Development is granted by the Local Planning Authority.

(3) the resolution (1) above shall only come into force in respect of the markets named which do not place on the highway or for which the consent of the Highway Authority has already been provided in respect of those markets or a Traffic Regulation Order (if applicable) has been made.
