1.0 Report Summary

1.1 As the Strategic Commissioner of School Places, Cheshire East Council has a statutory duty to commission sufficient school places for children resident in its area.

- 1.2 This Decision Paper requests approval to consult on the proposed expansion of
 - **Pebble Brook Primary**, to expand the school from 210 to 315 pupil places (from 1 form of entry to 1.5 forms of entry) with a proposed completion date of September 2013:
 - Wheelock Primary, to expand the school from 210 to 315 pupil places (from 1 form of entry to 1.5 forms of entry) with a proposed completion date of September 2013:
 - **Mobberley CE Primary** to expand the school from 140 to 210 pupil places (from an intake of 20 pupils to 30 pupils) and creating a 1 form of entry primary school) with a proposed completion date of September 2013.
- 1.3 As the Strategic Commissioner of School Places, the Local Authority has a statutory duty to review provision within its area and to establish future demands.
- 1.4 Pupil forecasts indicate a shortfall in the number of primary school places due to changing populations and increasing demand in some areas of the Borough resulting in a forecast of only 8 spaces across all year groups and all primary schools by 2017. Proposals are therefore being made for the Sandbach, Crewe and Knutsford areas of the Borough to expand existing accommodation to meet the increasing demand in these areas and to ensure a level of operational surplus; which is a level of spare capacity intended to accommodate reasonable journey times to school, some degree of parental choice, and flexibility to allow for mid-year entrants.

1.5 In making this recommendation officers have given consideration to a number of issues including the number of pupils in each school's catchment area, the number of first preferences received for each school, the current size of the school together with the school sites and those suitable for expansion and the likely costs of extension. Suitable schools need to be central to the areas where the extra places are required. Full details of the rationale for these proposals are included in the consultation documents presented with this report.

Pebble Brook Primary, Crewe

- 1.6 Pebble Brook Primary School is a popular and successful school with a published admission number (PAN) of 30 pupil places and overall accommodation for 210 pupils across the 7 year groups. The Local Authority is proposing an increase in the school's net capacity, which indicates the number of pupils that can be accommodated in the school. The proposal, if agreed, will increase the school from 210 pupil places (1 form of entry) to 315 (1.5 forms of entry) with an intake each year of 45 pupils into the reception class.
- 1.7 For the past two years, the Local Authority and the school have agreed the admission of additional pupils above the published admission number to ensure that local children can access school places within a reasonable distance from their home address. If the Local Authority had not been able to admit additional pupils to Pebble Brook as their local school, the general shortage of places in the Crewe area would have resulted in parents of some children being offered places in schools at an unreasonable distance.
- 1.8 Due to the popularity of the school and increasing demand in this area, the number of preferences for the school has been steadily increasing. For the last 4 years applications have exceeded the 30 places available in the reception class. For 2011 the Local Authority, in agreement with the school, admitted 40 pupils to meet the demand from families resident in the school's catchment area; for 2012 45 pupils were admitted on the same basis.
- 1.9 Forecasts using January 2012 school census data indicate that across the Crewe Local Area Partnership there will be a shortfall of 416 pupil places by 2017 based on current intakes. For the 14 primary schools located in the Crewe town area (including Pebble Brook Primary), which currently provide 4936 pupil places increasing to 5185 due to changes agreed for implementation in September 2013, forecasts indicate a shortfall of 156 pupil

- places by 2017. Although the Local Authority has already taken measures to alleviate the shortfall in school places in this area, further measures are necessary to accommodate the anticipated increase in demand due to population growth within the Crewe area and to ensure a level of operational surplus.
- 1.10 The Headteacher and Governors have confirmed their support for the proposal to expand the school to 1.5 form of entry to accommodate local children at a school within a reasonable distance, as far as possible.

Wheelock Primary School, Sandbach

- 1.11 Wheelock Primary School is a popular and successful school with a published admission number (PAN) of 30 pupil places and overall accommodation for 210 pupils across the 7 year groups. The Local Authority is proposing an increase in the school's current capacity of 210 pupils to provide 315 pupil places with a proposed implementation date of September 2013. This increase, if approved, will provide sufficient accommodation for an intake at the normal point of entry to the school (the reception class) of 45 pupils with the school operating in the longer term as a 1.5 form of entry primary school.
- 1.12 The number of children in the school's catchment area has increased steadily over recent years and for 2012 admissions there were 61 children resident in the area.
- 1.13 The total capacity across the 8 Sandbach primary schools (including Haslington) is currently 1915 pupil places. Forecasts indicate that there will be a shortfall of 151 pupil places in this area by 2017. Pupil forecasts for the Sandbach town area (excluding the 2 Haslington primary schools) indicate that there will be a significant shortfall of places across the 6 schools by 2017 with an overall shortfall of 11% (144 pupil places). The number of spare pupil places is forecast to fall to 0% in September 2013. This absence of any operational surplus from this time will impact on choice for local residents if additional accommodation is not provided for this area.
- 1.14 For admission in September 2012, the Local Authority received 212 (applications for the 6 Sandbach town primary schools. This exceeded the 185 reception class places available in the area. To accommodate these additional children, 2 of the 6 schools, which included Wheelock Primary, agreed admissions above their Published Admission Numbers to ensure that children were accommodated in schools within a reasonable distance from their home address. The general shortage of places in the Sandbach area for 2012 would have resulted in parents of some children being offered schools over 4 miles away, as the next nearest schools with places available.
- 1.15 The Headteacher and Governors have been consulted and fully support the proposed expansion of the school to accommodate the growing population and increasing demand for school places.

Mobberley CE Primary School, Knutsford.

- 1.16 Mobberley CE Primary is a popular and successful school resulting in the number of preferences for the school exceeding the 20 places available in the reception class for 3 of the last 4 years. For 2012 the school received 33 first preferences against a published admission number (PAN) of 20.
- 1.17 The distance to other nearby schools will seem unreasonable to local families. Many will qualify for transport assistance being over the statutory walking distance of 2 miles if unable to secure a place at their local school.
- 1.18 Pupil forecasts for the Knutsford LAP indicate that there will be a significant shortfall of places across a number of the schools reaching a forecast shortfall of 9% (215 places) by 2017. In order to ensure that there are sufficient places for families seeking places at their local schools, additional places are needed in this area from 2013 when the number of unused places is forecast to fall to only 6 places across all schools and all year groups.
- 1.19 Forecasts for Mobberley CE Primary indicate that from 2012 there will be insufficient places at the school with more children on roll than places available. This trend is forecast to continue reaching a shortfall of 60 pupil places, based on current admission patterns, by 2017.
- 1.20 The Headteacher and Governors have confirmed their support for the proposed expansion of the school to a 1 Form of Entry primary school (30 places per year group) in order that accommodation is suitable for existing pupils on roll and to accommodate the growing population and demand for places from local families now and in the future.

2.0 Recommendations

- 2.1 That the Portfolio Holder give permission to commence statutory consultation on 8 October 2012 on the proposed expansions of three schools:
 - Pebble Brook Primary, from the 210 school places (1FE) to 315 school places (1.5 FE) thus providing an additional 105 school places with effect from September 2013:
 - Wheelock Primary, from the 210 school places (1FE) to 315 school places (1.5FE) thus providing an additional 105 school places with effect from September 2013:
 - Mobberley CE Primary from the current Published Admission Number (20) providing 140 school places to a PAN of 30 (1FE) thus providing an additional 70 school places with effect from September 2013.

3.0 Reasons for Recommendations

- 3.1 In making this recommendation the authority has given consideration to a number of issues including the number of pupils in each school's catchment area, the number of first preferences received for each school, the current size of the school together with the school sites and those suitable for expansion and the likely costs of extension. Suitable schools also needed to be central to the areas where the extra places are required
- 3.2 Pebble Brook Primary School was established in 1988 following the amalgamation of Bedford Street Infants and Pebble Brook Junior School. Originally developed to accommodate a one and a half form entry primary school with 315 pupil places following a decline in the need for places in the area the school was reduced to a one form entry school with 210 school places and a Children's Centre was established on site. However the site remains sufficient to expand to accommodate 315 pupil places retaining adequate playground and playing field provision. It is envisaged that the proposed extension would require 3 additional classrooms,
- 3.3 Wheelock Primary is situated on the outskirts of Sandbach Town the school was originally developed to accommodate 5 classrooms and later extended to a one form entry primary school with 210 pupil places. However the site is sufficient to expand to accommodate 315 pupil places retaining adequate playground and playing field provision. It is envisaged that the proposed extension would require 4 additional classrooms,
- 3.4 Mobberley CE Primary is situated in the rural village of Mobberley on the outskirts of Knustford. The school was originally built in 1858 and consisted of 2 classrooms. Extensions and refurbishments have taken place over a number of years and following the closure of Ashley CE Primary School in 2004 the school was further developed and the accommodation now consists of 5 classrooms, 2 practical areas, hall, staffroom and office accommodation. It is envisaged that the proposed expansion would require 2 additional classrooms.

6.0 Financial Implications (Authorised by the Director of Finance and Business Services)

- 6.1 All the proposed expansions are part of an approved block budget (grant) set aside for Basic Need. The block budget was formally approved at Council on 23 February 2012.
- 6.2 The building work would be funded from the Council's 2012/2013 Capital Programme for Basic Needs. The capital investments required are estimated at:

Pebble Brook Primary £1.105,000
Wheelock Primary £1,765,758
Mobberley CE Primary £796,000

6.3 Although the Local Authority is proposing an expansion to Mobberley CE Primary this would be subject to the acquisition of land adjacent to the school, agreed costs would be in addition to the estimated £796,000 quoted above.

7.0 Legal Implications (Authorised by the Borough Solicitor)

- 7.1 Statutory consultation is required for this proposal as the changes, if approved, will fall within the category of a significant enlargement. The additional accommodation proposed for Pebble Brook Primary, Wheelock Primary and Mobberley CE Primary School would increase the capacity by more than 30 pupils and by more than 25%.
- 7.2 This would ensure that the Local Authority is compliant with statutory requirements as set out in The Education and Inspections Act 2006 (EIA 2006) and The School Organisation (Prescribed Alterations to Maintained Schools)(England) Regulations 2007 (as amended by The School Organisation and Governance (Amendment)(England) Regulations 2007 which came into force on 21 January 2008 and The School Organisation and Governance (Amendment)(England) Regulations 2009 which came into force on 1 September 2009).
- 7.3 The 5 statutory stages to expanding a school are:-
 - 1. Consultation
 - 2. Publication
 - 3. Representation
 - 4. Decision
 - 5. Implementation.

8.0 Risk Management

- 8.1 Disruption to pupils, staff and the community must be kept a minimum during the consultation period, and any subsequent building programme, to ensure that standards continue to improve
- 8.2 The proposed expansions were identified to address a Basic Need in the individual areas. This is in order to ensure that the Authority meets its statutory duty to provide sufficient school places in this area. In order to complete these scheme by September 2013 the construction phase would need to commence by late February 2013. There is therefore a key risk resulting from the very tight timetable leading up to this.
- 8.3 The Authority cannot enter into a contract to provide the further accommodation until additional land to be used for hard-standing area has been acquired, and approval to the building scheme, including the proposed use of the additional land for hard-standing area, has been approved by the Planning Authority. If additional land cannot be acquired, then the Authority will have to investigate alternative provision in the Knutsford area.
- 8.4 If the land-owner is not willing to sell, the only other option on the Mobberley site would be to consider converting the existing playing field to form a synthetic pitch that could be used by pupils at break-times etc. in addition to meeting the school sporting requirements. This would increase the capital cost of the project and also cause the school some organisational difficulties of having to supervise pupils across a farm track which is used regularly. Sport England have been consulted on this and offered the following comments "The Artificial Grass Pitch (AGP) would need to meet the following exception to the playing field policy replicated in paragraph 74 of the National Planning Policy Framework":
- 8.5 Implementation of these proposals will be subject to the necessary planning permissions.

OBJECTIVE OF THIS CONSULTATION DOCUMENT

To undertake formal consultations with parents and carers of pupils at Pebble Brook Primary School and other interested parties before a final decision is taken regarding a proposal to make a significant enlargement to Pebble Brook Primary School.

The Local Authority is proposing the expansion of Pebble Brook Primary School to provide an additional 105 places increasing the school from 210 places (1 form of entry) to 315 places (1.5 form of entry) with a proposed completion date of September 2013.

INTRODUCTION

Pebble Brook Primary School is a popular and successful school with a published admission number (PAN) of 30 pupil places and overall accommodation for 210 pupils across the 7 year groups.

The Local Authority is proposing an increase in the school's net capacity, which indicates the number of pupils that can be accommodated in the school. The proposal, if agreed, will increase the school from 210 pupil places (1 form of entry) to 315 (1.5 forms of entry) with an intake each year of 45 pupils into the reception class.

For the past two years, the Local Authority and the school have agreed the admission of additional pupils above the published admission number to ensure that local children can access school places within a reasonable distance from their home address. If the Local Authority had not been able to admit additional pupils to Pebble Brook as their local school, the general shortage of places in the Crewe area would have resulted in parents of some children being offered places in schools at an unreasonable distance. Temporary accommodation has been agreed for the school as an interim measure pending the decision on the proposed expansion. Although the Local Authority has recently implemented these interim measures to alleviate the shortfall in school places for the Crewe area, this proposed long term measure is necessary to accommodate the anticipated increase in demand due to population growth within the Crewe area.

The school is popular and successful and the number of first preferences for the school has been steadily increasing. For the last 4 years applications have exceeded the 30 place available in the reception class. For 2011 the Local Authority in agreement with the school admitted 40 pupils to meet the demand from families resident in the school's catchment area; for 2012 45 pupils were admitted on the same basis.

The school's site is large enough to accommodate a 1.5 form of entry school.

The Headteacher and Governors have confirmed their support for the proposal to expand the school to 1.5 form of entry to accommodate local children at a school within a reasonable distance, as far as possible.

BACKGROUND

The Crewe Local Area Partnership (LAP) has 21 primary schools and 5 secondary schools covering the areas of Crewe, Nantwich, Sandbach, and Shavington. Currently the total primary school capacity across this area is 6992 pupil places.

Forecasts using January 2012 school census data indicated that across the area as a whole there will be a shortfall of 416 pupil places by 2017.

During the academic year 2011-2012, the Local Authority agreed the expansion of Oakefield Primary and Nursery School from 315 to 420 pupil places with effect from September 2013 increasing the school from a 1.5 to a 2 form of entry primary school and an additional 105 pupil places for the Crewe area to address forecast shortfall. Other changes introduced for Crewe included increased intakes to Beechwood Primary from 280 places to 315 (additional 35 pupil places); Monks Coppenhall from 360 places to 420 (additional 60 pupil places) and Brierley Primary from 161 places to 210 (additional 49 pupil places) with a total additional capacity agreed for this area of 249 pupil places. Without these changes 13 of the 21 primary schools were forecast to be over capacity or to have a very low level of unused places by 2017.

Based on January 2012 forecasts, the remaining shortfall in the number of places needed for the Crewe area indicates that further changes are needed to ensure sufficient school places for children resident in the area with projections indicating only 1 spare place across all year groups and all schools in the Crewe Local Area Partnership (LAP) by 2015 and insufficient places to meet the current pattern of intake for subsequent years.

The 14 primary schools located in the Crewe town area of this Local Area Partnership currently provide 4936 pupil places increasing to 5185 from September 2013.

It is in this area where demand for places has increased significantly and changes have been made to increase the number of pupil places in the four schools stated above. For many schools, these changes will address this growth in the number of primary aged pupils, however, high demand for places requires further measures; not only to ensure that there are sufficient places for local children to attend local schools within a reasonable distance, but also to ensure the Local Authority can build in operational surplus, which is a level of spare capacity intended to accommodate reasonable journey times to school, some degree of parental choice, and flexibility to allow for mid-year entrants. The remaining shortfall across these 14 primary schools based on current intake

patterns has informed the decision to propose the expansion of Pebble Brook Primary to provide further accommodation in this area of the Crewe Local Area Partnership to meet this increasing demand due to population changes.

ADMISSIONS

Due to changes in demographics for this area the Local Authority received applications for admission in September 2012 in excess of the 708 reception class places available with a total (to date) of 773 admissions.

The number of children resident within the schools catchment area has been steadily increasing in recent years and for September 2012 the number of applications received was nearly four times the school's current intake of 30 places. In order to accommodate children resident in the school's catchment area for whom there was no other schools with vacancies within a reasonable

distance, the Local Authority agreed additional places over the school's published admission number for September 2011 and 2012 and has arranged for temporary accommodation on the school's site as an interim measure.

The number of children resident within the schools catchment area is expected to continue to rise in future years. It is therefore recommended that the local demand for places at this school justifies an extension of classrooms to take the school from 210 school places (1FE) to 315 places (1.5FE) with a PAN of 45 per year group.

SITE AND BUILDINGS

The school was established in 1988 following the amalgamation of Bedford Street Infants and Pebble Brook Junior School. Originally developed to accommodate a one and a half form of entry primary school with 315 pupil places, following a decline in the need for places in the area the school was reduced to a one form entry school with 210 school places and a Children's Centre was established on site. However, the site remains sufficient to expand to accommodate 315 pupil places retaining adequate playground and playing field provision.

Expansion of the school will be subject to planning permission.

FINANCIAL ISSUES

The Pebble Brook proposal is part of an approved block budget (grant) set aside for Basic Need. The block budget was formally approved at Council on 23 February 2012.

The building work would be funded from the Council's 2012/2013 Capital Programme for Basic Needs. The capital investment required is estimated at £1,105,000 which includes the provision of the temporary mobile already agreed.

OBJECTIVE OF THIS CONSULTATION DOCUMENT

To undertake formal consultations with parents and carers of pupils at Wheelock Primary School and other interested parties before a final decision is taken regarding a proposal to expand Wheelock Primary School.

The Local Authority's proposal is to expand Wheelock Primary School, Sandbach from 210 to 315 pupil places for completion in September 2013.

INTRODUCTION

Wheelock Primary School is a popular and successful school with a published admission number (PAN) of 30 pupil places and overall accommodation for 210 pupils across the 7 year groups.

The Local Authority is proposing an increase in the school's current capacity of 210 pupils to provide 315 pupil places with a proposed implementation date of September 2013. This increase, if approved, will provide sufficient accommodation for an intake at the normal point of entry to the school (the reception class) of 45 pupils with the school operating in the longer term as a 1.5 form of entry primary school.

For 2012 admissions, the Local Authority and the school agreed the admission of 45 children to accommodate local children due to an increase in demand for school places in the Sandbach area. The general shortage of places in the Sandbach area for 2012 would have resulted in parents of some children being offered schools over 4 miles away, as the next nearest schools with places available.

The number of children in the school's catchment area has increased steadily over recent years and for 2012 admissions there were 61 children resident in the area.

At primary phase, pupils that are admitted to these 6 Sandbach schools are predominantly resident within the school's 'catchment area' or live within the Congleton Local Area Partnership (LAP) with only 3.9% living outside the LAP and 0.3% living outside Cheshire East Borough.

Pupil forecasts for Sandbach town area indicate that overall there will be a significant shortfall of places across the 6 schools by 2017 with an overall shortfall by 11% (144 pupil places). Expansion of the school will be subject to planning permission.

OBJECTIVE OF THIS CONSULTATION DOCUMENT

To undertake formal consultations with parents and carers of pupils at Mobberley CE Primary School and other interested parties before a final decision is taken regarding a proposal to make an enlargement to Mobberley CE Primary School.

The Local Authority is proposing the extension of Mobberley Church of England Primary School, which has a current capacity of 140 pupil places. The proposed increase to 210 places will deliver sufficient capacity for the school to become a one form of entry (30 places per year group) primary school with a proposed completion date of September 2013.

INTRODUCTION

Mobberley CE Primary is a popular and successful school resulting in the number of preferences for the school exceeding the 20 places available in the reception class for 3 of the last 4 years. For 2012 the school received 33 first preferences against a published admission number (PAN) of 20.

In 2004, Ashley Primary school closed and children on roll at the time of closure were transferred to Mobberley CE (C) Primary. The catchment area for Mobberley was extended to include the area previously zoned to Ashley Primary School. At January 2011 67% of children living in the catchment area were on roll at the school. This represented 76% of the school's pupil population. This percentage increased to 69% at January 2012 due to the increase in the number of children resident within the area seeking places in the reception class and at that time representing 78% of the school's pupil population.

The distance to other nearby schools will seem unreasonable to local families. Many will qualify for transport assistance being over the statutory walking distance of 2 miles if unable to secure a place at their local school.

Initially, the school had sufficient capacity to accommodate the additional demand in this area. However, subsequent changes, including new housing and the number of primary aged pupils in the area, have resulted in an increase in the number of children living within the school's catchment area, with 44 children resident in the catchment area for admission in September 2012 into the reception class.

For 2012 admissions although the school supported the Local Authority by agreeing the admission of 30 catchment area children (10 over the school's published admission number) this resulted in 3 catchment area children without a place at their local school for whom alternative schools had to be offered. These additional 10 pupils have been accommodated in the school in September 2012.

Live birth data gathered for 1 September 2011 up until 31 July 2012 indicates 48 children have been born in this 11 month period in the Mobberley Ward. These children will be due to commence school in 2016.

The Headteacher and Governors have confirmed their support for the proposed expansion of the school to a 1 Form of Entry primary school (30 places per year group) in order that accommodation is suitable for existing pupils on roll and to accommodate the growing population and demand for places from local families now and in the future.

BACKGROUND INFORMATION

Knutsford Local Area Partnership (LAP)

The Knutsford Local Area Partnership (LAP) has 10 primary schools and 1 secondary school covering the areas of Knutsford, Chelford, High Legh, Little Bollington, Nether Alderley and Peover Superior. The total primary school capacity across the LAP is 1684, 4 of these primary schools are located within the village of Knutsford providing 1050 pupil places for this area.

At the primary phase, pupils who are admitted to schools in the Knutsford LAP are predominantly resident within the school's 'catchment area' or live within the Knutsford LAP with only 6.7% of pupils on roll at Knutsford primary schools resident in other Local Area Partnerships within Cheshire East and with only 8.4% living outside Cheshire East in January 2012.

Pupil forecasts for the Knutsford LAP indicate that there will be a significant shortfall of places across a number of the schools reaching a forecast shortfall of 9% (215 places) by 2017. In order to ensure that there are sufficient places for families seeking places at their local schools, additional places are needed in this area from 2013 when the number of unused places is forecast to fall to only 6 places across all schools and all year groups. This operational surplus; which is

the level of spare capacity intended to accommodate reasonable journey times to school, some degree of parental choice and flexibility to allow for mid-year entrants, is insufficient and must be addressed.

Forecasts for Mobberley CE Primary indicate that from 2012 there will be insufficient places at the school with more children on roll than places available. This trend is forecast to continue reaching a shortfall of 60 pupil places, based on current admission patterns, by 2017.

The changing demographics of Mobberley Village and the demand for places at the local primary school indicate that the school has insufficient capacity to accommodate local demand. Although the Local Authority has taken measures to alleviate the immediate shortfall in certain areas of Knutsford including Mobberley long term measures are necessary to accommodate the anticipated increase in demand due to population growth in this area

ADMISSIONS

For admission in September 2012, the Local Authority received applications for Knutsford LAP schools in excess of the 241 reception class places available with a total, to date, of 273 admissions.

For September 2012 admissions the number of children resident within the Mobberley CE Primary School catchment area was 41, which was more than double the school's current capacity of 20 pupils per reception intake. Following the completion of a large housing development in the area the number of catchment children has exceeded the reception places available for the last 3 years and indications are that this trend will continue.

Demand for places from local residents has been exceeding the number of available places and this rise is expected to continue in future years. It is therefore recommended that the local demand for places at this school justifies an extension to take the school up to 210 places with an admission number of 30 pupils per year (1 Form of Entry).

SITE AND BUILDINGS

Situated in the rural village of Mobberley the school was originally built in 1858 and consisted of 2 classrooms. Extensions and refurbishments have taken place over a number of years and following the closure of Ashley CE Primary School in 2004 the school was further developed and the accommodation now consists of 5 classrooms, 2 practical areas, hall, staffroom and office accommodation. The proposed expansion includes a two classroom extension plus additional toilets and enlargement of existing kitchen facilities. This proposal is conditional on the acquisition of additional land, which will be required to supplement the loss of hard-standing playground space needed to support the proposed extension.

Expansion of the school will be subject to planning permission.

FINANCIAL ISSUES

The Mobberley proposal is part of an approved block budget (grant) set aside for Basic Need. The block budget was formally approved at Council on 23 February 2012.

The building work would be funded from the Council's 2012/2013 Capital Programme for Basic Need. The capital investment required is estimated at £796,000. As this proposal is conditional on the acquisition of land adjacent to the school, additional costs would be incurred above the estimated £796,000.

A final decision on this proposal will be subject to Council approval to fund the proposed expansion from its Capital Programme.
