  - 2. That approval in principle be given to the freehold transfer of Lyceum Public Convenience (delineated red in Appendix 2 of the report) to Crewe Parish Council, subject to conditions contained within the report considered as item 6 on the agenda.
  - 3. That the objection raised by a member of the public, following the publication of recent Public Open Space adverts, be noted, and that no formal action be taken in respect of it other than for a formal response being made in answer to the objection.
- **Background:** An approval is required to ratify a formal Order made in December 2012 to transfer 11 allotment sites in favour of the newly formed Crewe Parish Council (each by way of 150 year leases); to ratify a formal Order for the freehold transfer of Lyceum Public Convenience in favour of the newly formed Crewe Parish Council and to agree a formal response in answer to an objection raised by a member of the public following the publication of recent Public Open Space adverts.
