#### **Procedure for Hearings – Licensing Act 2003**

#### **The Licensing Committee**

The full Licensing Committee consists of fifteen elected Members of the Council. From this full Committee will be drawn sub-committees of three members to deal with licensing functions under the Licensing Act 2003. The Chairman and Vice Chairman of the Licensing Committee shall have the discretion to refer a matter up to a hearing of the full Licensing Committee.

#### **Officers at Hearings**

- The Committee Officer introduces all parties and records the proceedings
- The Legal Adviser provides independent advice to the Members on legal matters and procedure.
- The Licensing Officer will introduce the matter and outline the application; the officer will also answer any questions Members may have.

#### **PROCEDURE**

NOTE: If the Sub-Committee has not already elected a Chairman, that will be the first item of business.

1	Chairman	The Chairman will:  (i) call the matter to be considered  (ii) call for any declarations of interest  (iii) ask all parties to introduce themselves  (iv) summarise the procedure to be followed at the hearing  (v) will consider any request made by a party for another person to appear at the hearing  (v) will advise the parties of any maximum period of time in which it has to present its case (if a maximum is imposed this shall be equal for all parties)
2	Licensing Officer	Will introduce and summarise the application, highlighting areas of contention or dispute.
3	Committee Members	May ask questions of the Licensing Officer
4	Applicant	Will present his/her case, calling witnesses, as appropriate.  (If necessary, applicant will produce any notices required by law. Legal Adviser will draw attention to this if required.)

5	Responsible Authorities	Each in turn may ask <u>questions</u> of the applicant, by way of clarification.			
	(who have made representations)				
6	Other Persons (who have made representations)	To be invited to ask <u>questions</u> of the applicant, by way of clarification.  It is normal practice for a spokesperson only to speak on behalf of a group of residents.			
7	Committee Members	Each in turn may ask questions of the applicant.			
8	Applicant	May make a <u>statement</u> or ask his witnesses to clarify any matters which he feels are unclear, or may have been misunderstood.			
9	Responsible Authorities	Will make their representations.			
10	Applicant	Or his representative or witnesses to ask <u>questions</u> of Responsible Authorities represented at the meeting, by way of clarification.			
11	Other Persons	May ask questions of the Responsible Authorities			
	(who have made representations)	represented at the meeting, by way of clarification.  (Note: This is not the point at which they should be stating their objections.)			
12	Committee Members	May ask <u>questions</u> of the Responsible Authorities represented at the meeting			
13	Other Persons	Those who have objected to the application will be invited <b>to</b>			
	(who have made representations)	make observations on the application and present the bases of their objections.			
15	Applicant	Or his representative or witnesses may ask <u>questions</u> of the other persons, by way of clarification.			
16	Committee Members	May ask <u>questions</u> of the other persons.			
17	Chairman	To invite both <b>Responsible Authorities</b> and <b>Other Persons</b> to make their closing addresses.			
18	Applicant	Or his representative will briefly summarise the application and comment on the observations and any suggested			

		conditions.
19	Committee	Will retire to consider the application. The Committee may request the Legal Advisor to advise on legal issues.
20	Committee	Will return to give its decision, with reasons, which will be announced by the Chairman and subsequently confirmed in writing to the applicant and to all the parties that made representations.  In cases where a decision cannot be given at the end of the hearing, parties will be advised of the decision within five working days.

#### **Notes**

- The hearing shall normally be held in public. There may be occasions on which the Committee find it necessary to exclude members of the press and public; any such decision will be taken on the basis that the public interest in doing so outweighs the public interest in the hearing, or that part of the hearing taking place in public.
- 2. The Chairman may require any person behaving in a disruptive manner to leave the hearing and may (a) refuse to permit that person to return, or (b) permit him/her to return only on such conditions as the authority may specify, but any such person may submit in writing any information which they would have been entitled to provide orally if they had not been required to leave.
- 3. Prior to the hearing each party shall have given notification and served documentation (eg statements of witnesses or reports of experts) as required. Late representations and evidence will only be considered with the agreement of all parties.
- 4. Anyone entitled to be heard may be represented by any person, whether or not that person is legally qualified.
- 5. Hearsay will be permitted but the Sub-Committee will be reminded to give it appropriate weight.
- 6. Due note shall be taken of the provisions of the Hearings Regulations 2005.
- 7. The Chair may, in the interests of expediency or convenience of the parties, vary the procedure from time to time, provided notice is given to the parties and the rules of natural justice are observed.

#### **Summary of Procedure**

- 1. Chairman appointed (if this has not been done previously).
- 2. Chairman to call for declarations of interest and request that all parties introduce themselves.
- 3. Chairman summarises the procedure for the hearing
- 4. The Licensing Officer summarises the application
- 5. Applicant to present his/her case.
- 6. Applicant to be questioned by all parties (to clarify points only) following which, he/she can clarify any other matters which he/she feels may have been misunderstood when the application was presented.
- 7. Applicant to be questioned by the Committee.
- 8. Responsible Authorities to make their representations following which they can be questioned by all parties by way of clarification.
- 9. Other Persons will be invited to present the bases of their objections, following which they can be questioned by all parties by way of clarification.
- 10. The applicant will be invited to sum up his/her case
- 11. Committee/Sub-Committee withdraws to make its decision
- 12. Committee/Sub-Committee returns to announce its decision to all present.

The licensing objectives are (a) the prevention of crime and disorder; (b) public safety; (c) the prevention of public nuisance; and (d) the protection of children from harm.

- 8.1 In accordance with the provisions of section 18 of the Licensing Act 2003 the Licensing Authority must, having regard to the representations, take such steps (if any) as it considers appropriate for the promotion of the licensing objectives. Section 18(4) provides that the authority may:
  - (a) Grant the licence subject to the relevant mandatory conditions and conditions consistent with the operating schedule
  - (b) Modify the application to such extent as the Authority considers appropriate for the promotion of the Licensing Objectives
  - (c) Exclude from the scope of the licence any of the Licensable Activities to which the application relates
  - (d) Refuse to specify a person in the licence as the Premises Supervisor
  - (e) Reject the application.

#### 9.0 Risk Management

9.1 Section 181 and Schedule 5 of the Licensing Act 2003 make provision for appeal to the Magistrates' Court of any decision made by the Licensing Authority.

#### 10.0 Background and Options

10.1 The application, received on the 1<sup>st</sup> August 2013, is for the grant of a Variation of the Premises Licence under section 34 of the Licensing Act 2003.

This application was originally submitted on 4<sup>th</sup> June 2013. However, due to an error on the part of Cheshire East Council, details of the application were not listed on the Cheshire East Council website and the application was made invalid as a result. The application was subsequently re-applied for on the 1<sup>st</sup> August 2013.

- 10.2 The operating schedule indicates that the proposed variation is as follows:
  - To extend the hours for all existing licensable activities.
  - To extend the opening hours of the premises.
  - To amend the plan attached to the Premises Licence.
  - To amend the conditions attached to the Premises Licence.
- 10.3 The hours applied for are as follows:

#### Sale and Supply of Alcohol

Sunday to Thursday 08:00 to 01.00 hours
Friday and Saturday 08.00 to 02.00 hours

On the occasion of British Summertime an additional hour is requested.

#### Opening Hours of the Premises

Friday and Saturday 08.00 to 02.30 hours
With non standard timings: terminal hour of 02.30 hours on a Sunday preceding a statutory Bank Holiday, Christmas Eve and Boxing Day.
On the occasion of British Summertime an additional hour is requested.

- Application is made to remove Conditions 12 and 13 of Annex 2 of the Premises Licence relating to children's entertainment. Also to amend Condition 1 of Annex 3 (conditions attached after a hearing of the Licensing Authority) to enable the outside area to be available for the sale of alcohol and consumption of alcohol until 01.00hrs on New Years Eve/Day.

- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;
- (d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on—
- (i) the outcome of a race, competition or other event or process, or
- (ii) the likelihood of anything occurring or not occurring;
- (e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.

#### **Condition 2**

The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).

#### **Condition 3**

The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

#### Condition 4

- (1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
- (2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

#### **Condition 5**

The responsible person shall ensure that—

- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
- (i) beer or cider: ½ pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml; and
- (b) customers are made aware of the availability of these measures.

#### Annex 2 - Conditions consistent with the Operating Schedule

#### **Prevention of Crime and Disorder**

- 1. Any person excercising a security activity (as defined by paragraph 2(1)(a) of schedule 2 of the Private Security Industry Act 2001) shall be licensed by the Security Industry Authority.

- 11. Children under the age of 16 shall not be permitted to enter the premises after 9pm.
- 12. Where there is provided in the Premises an entertainment for children, or an entertainment at which the majority of the persons attending are children, then, if the number of children attending the entertainment exceeds one hundred, it shall be the duty of the person providing the entertainment to station and keep stationed wherever necessary a sufficient number of adult attendants, properly instructed as to their duties, to prevent more children or other persons being admitted to the building, or to any part thereof, than the building or part can properly accommodate, and to control the movement of the children and other persons admitted while entering and leaving the building or any part thereof, and to take all other reasonable precautions for the safety of the children







All necessary steps shall be taken to ensure that any noise from the premises shall not be at a level which could cause a noise nuisance at the boundary of the nearest residential premises, therefore:

All regulated entertainment shall take place indoors.

All external windows and doors shall be closed whilst regulated entertainment is taking place, except for normal access and egress.

There shall be no temporary or permanent speakers for the use of amplified music, speech or dance, permitted within the outside area or beer garden.

The Licence Holder/Designated Premises Supervisor or responsible person nominated by him in charge of the Premises shall ensure that any noise emanating from the Premises is not audible at the boundary of noise sensitive properties.

Customers shall be permitted to stay inside the premises whilst waiting for taxis.

To whom it may concern.

I fully oppose ALL aspects of the variation to licence for the above premises. I truthfully laugh at the application proposals but conversely am significantly worried and deeply concerned should all or any of the variations be approved. I support initiative in business but feel what they want is totally too much and is the wrong thing for the local area and the people who live there. Noting that all residents have lived in the area longer and before than the new landlord to the Pub has been in place and who instigated these plans. This has to be your priority in looking after those that live here and who's day to day lives will be greatly negatively effected to a point of explosion of frustration and sending all of us round the bend.

Please consider the following;

#### Location

Simply the pub is in a RESIDENTIAL area. Apart from two small independent day traders in the old post office there are no other commercial activities going on. People want to live here in amongst other homes where noise is limited. To have a pub with such plans would deverstate our quality of life should they be approved. The area is a conservation area and for the proposals to be approved would make a mockery of the status. It would also bring into question the council and governments restrictions on normal home planning issues (extensions, solar panels, other home improvements) if the Legh arms has permission to RADICALLY change the way it may operate.

#### Noise

I have significant cause for concern over the noise generated from the activities planned and equally the hours of operation. I am a human being and I have a high pressure job. Like others I need my sleep. I have a human right to this. The building is old and large and without massive investment in acoustic control is totally unsuitable for their plans. With no air conditioning systems in place, windows are often left open in the summer and with the distance from the DJ booth to the nearest residential house being less than 6m will destroy our lives in terms of noise. One can expect that their will be extra noise outside from cars leaving, shouting, people slow to move on and rowdy drunken behaviour will create further problems. I have reported noise issues in the past to your environment department after late entertainment nights and the general lack of care shown by previous landlords highlights their attitude to the neighbourhood. The thought of weddings, horse race outing turning up in coaches at 0800 singing 'agadoo' to have champagne breakfasts in the early morning worries me also. In todays 24hr pace of life, it is important to remember that some people work shifts therefore noise has to controlled and moderated at all times of the day.

### Crime

More people, drinking more alcohol at unsociable times of the day will create more crime issues. I have personally witnessed someone trying to break into my home again after a entertainment night in the Legh Arms previously. I and my neighbours will not tolerate

this. Referring to location again, all the police are rightly in the town centre controlling the crowds there and response times will be greater to get up to the Legh Arms. If people want to party let them party in the town centre where there are resources and not in this residential area. They may deem a issue from the Legh Road area as low priority compared to a similar town centre issue? They don't have the resources to cover both geographical locations.

### Opening of outside Bar area

Again this will move the noise and disturbance in the wrong way - outside and create further noise issues. More pain for the local residents. I believe like the other ideas that they intend to operate very late.

#### Traffic Issues

It is common knowledge that the Legh Road/Chelford Road/Mobbereley Road/Brook street/Sparrow Lane junction is very dangerous. It is a fast road, very narrow and is active 24hrs a day with heavy slow to brake lorries. If any plans are approved then this will lead to more people, more traffic and more chance of a serious road traffic accident. I am not willing to see this happen. Has anyone considered parking as well. With more people then where is everyone going to park? Legh Road is already very busy and full with residents parking there and also a lot of office workers parking during the day. The place would look like a car park and would see lines of cars all the way down to Parkfield Road. This would create frustration to even more innocent residents who can't access/park outside their own homes and extra danger to those that use Legh Road as a through way. It would also mean that visibility would be reduced for those trying to cross the road such as children who also live in the area.

#### Proposed Ideas

I have major issues with the proposals and think they will make the area look shabby and degrade it. To have regular disco nights, film night, karaoke evenings, ABBA nights on a frequent basis will kill the area and make it look cheap. I have issues over the late night kitchen and people popping in from elsewhere having not drunk at the pub, for a late night burger and chips. Is the Legh Arms going to replace the services on the M6? The smells and the general ambience to the area will be Terrible. The Legh Arms could be known as Knutsford's new alcoholic cinema showing horror films with booze thrown in. I am very concerned over all the opening hours requested.

I believe it would have a negative effect on the house prices in the area.

Despite the Pubs plea to work with the local residents, the licensing team when considering the application have no option but to think worst case with regard to the opening hours. The following are all possible:

1. Horror films being shown to 0055 on a Sunday night 2. Burger and fries available on a Tuesday night till 0030 3. Live Beatles band on a Thursday night to 2355 4. Johnnies advertised mobile disco playing every Saturday night till 0155 with kicking out at 0225 5. Dominio nights on a Monday night till 0035

### Management of the Pub

Though I support enterprise, the Pub were unable to get the first simple application procedure correct by displaying the wrong poster in the wrong place. Together with their ludicrous business ideas I have little confidence in their ability. Should their plans be approved it could open the flood gates for more future CRAZY ideas that will further destroy the area. This would be tremendously difficult to control with a precedence already set by you namely in the operating hours that they could work within.

I also believe that the pub know that their ideas are too much and therefore have a full legal time backing their application. They are focused on profit only, in a pub that has always struggled and will try anything now to turn a £. This is not our problem. Their plans are not appropriate for the area and they need putting into touch by the planning department. Is it not our fault that they have a dead horse of an establishment and trying to turn it into combined music venue, wedding venue, film venue, late eating venue, outside bar area may help turnover but WILL kill this area of Knutsford, guaranteed.

The length and content of my letter highlights the personal issues that I have with these plans. Yes let them continue serving beer to the old man and serve family Sunday lunches but to change the way that they want too will be unfair and totally inappropriate to others around. Cheshire East must instantly halt these ludicrous plans that will simply kill the area.

If approved trust me I will fight the plans to the next level.

### Amendment to license of Legh Arms, Knutsford

I note that an application has been re-submitted to amend the license for the Legh Arms public house on Brook Street, Knutsford.

We live opposite the Legh Arms and object to the proposed amendments.

We are occasionally disrupted by patrons leaving the Legh Arms, who are noisy. In addition, if the Legh Arms has live or recorded music, this can be clearly heard in our home, particularly if they leave their windows/door open. We are concerned that if the license were extended further that this nuisance would be far greater.

The Legh Arms is situated in a residential area, rather than the town centre near other non-residential buildings. Our children's bedrooms are situated at the front of our home, and face the Legh Arms. We feel that allowing the extension of the license will disturb many local residents, including us.

There was no reference to the application in the Premises License Applications section of the Cheshire East website, when originally requested in June. As a result it was not possible to respond to specific points.

I have previously met with Tim Coulston of the Legh Arms and whilst I acknowledge his plans for the business, I am concerned that extending the license would allow any subsequent tenant to abuse the longer opening hours. In any event, I consider the current opening hours (closing times) are sufficient.

I note the application requests an opportunity to open at 8.00am. I have no objection to this.

In addition, and in view of the noise issues raised above, I would request that the license should require the windows and doors at the Legh Arms to be closed when live or recorded music is being played.

I also feel that there should be an obligation on staff to take positive action to prevent noise and nuisance when patrons are leaving the premises. The current license specifies there should be a sign asking patrons to leave quietly and respect neighbours. I checked recently and no such sign exists. I don't think a sign goes far enough and the staff at the Legh Arms should be required to challenge any patrons who create a nuisance when leaving the premises.

I would ask that these points and the impact on local residents are taken into account when considering the application made by the Legh Arms.

I wish to register a strong objection to the above application on behalf of myself and my terminally ill husband, He is unable to write or word process now as he is enduring the later stages of MSA, a progressive neurological illness, but he has asked me as his primary carer and attorney to include his name on your list of objectors.

We have lived opposite the Legh Arms for over twelve years now and are sorry that, given the catchment area, it has never been fully developed as a five star gastropub. It would have done extremely well!

Given our circumstances, we are unable to patronise the pub, which is a shame, but wish the new team well. The recent external renovations suggest that greater ownership and pride are being taken in longer term planning for the success of the business, rather than the 'quick fix' changes that have been implemented / failed more recently. We have heard very good reports about improvements that have been made of late and were therefore all the more disappointed when we heard from \_\_\_\_\_\_\_\_, a neighbour, that an application had been made by the brewery to extend to ridiculous proportions the existing hours of drinking andentertainment. This is not a city centre pub, nor even a Knutsford Town enterprise, but a business set in a conservation area with its own special identity and restrictions on change.

There has been a quick turnaround of management over the last few years and we had considerable issues with the landlord previous to the 'moonlighter'. Evenings of live music (at full blast with windows opened) extended beyond hours, up to 1:30am on a couple of occasions, and no consideration was given to residents' wellbeing. Communication with CCC Environmental Health officials proved entirely fruitless. The manager was contacted but there was absolutely no change to the level of noise, internal and external and we just had to 'put up and shut up' and suffer in silence. It was no joke and I am not prepared to go through this again. Let's see why—

If this application is passed I envisage, on top of deafening noise into the early hours, extra traffic noise problems and rowdiness as people leave the pub at a very late hour; limited police cover to deal with fights; a substantial change to the image of the area and its effect on house prices and, most importantly, the detrimental effect on our quality of life in this currently peaceful residential area. Given our previous experience, I have absolutely no faith in promises being kept and in prompt and real support being provided to curtail the excesses of a few.

The application process was proved highly flawed and I would suggest that the proposed changes are being made solely for the interests of the brewery. For this reason we lodge our objections.

I am writing to object in the strongest possible terms to the application for a variation of the license for the above premises.

The premises are situated in a quiet residential area on the boundary of the Legh Road Conservation Area and the extension is totally unsuited to this situation.

Already, our sleep is disturbed by late night revellers, cars revving and doors banging and if this application is granted the scene will be set to become worse. There is limited parking available on the premises and their customers park along Legh Road. This also creates congestion at a dangerous road junction causing tailbacks onto the main Chelford Road. I have also noted that drivers 'popping in' often do not respect the yellow lines and this makes the problem worse.

There is also a small, but growing problem of littering with beer glasses and drink containers being thrown into nearby gardens and dropped in Legh Road.

Our quiet enjoyment of our own gardens has also been disturbed this summer by outdoor parties with loud music during the daytime at weekends.

25 years ago, this used to be a quiet local pub with a bowling green. Since the bowling club departed, the use of the bowling green has been changed into 'Knutsfords Biggest Beer Garden' – their words, not mine, as used on the roadside A-board. This in turn has changed from a garden with seats into something resembling a mini Glastonbury festival and is completely out of hand.

The Cheshire East vision for Knutsford states 'the community has a high quality of life'. This will not be enhanced by the activities proposed at the Legh Arms.

I have no objection to what they do inside the building during the normal licensed hours. Any further extension to the hours or encouragement to develop outdoor activity is totally opposed.

As a close neighbour of the Legh Arms I have been made aware of the recent application and would like to formally object to certain aspects of the application on the following grounds:

Please note that the information I have relating to the detail of the application is only that supplied by my neighbour and a brief look at your web site, so i hope my responses and views make sense. It would have been more useful and less concerning if the brewery had notified close neighbours such as myself of their intentions and perhaps explained their rationale; this may have alleviated some of the inevitable fears myself and other local residents may have of exactly what they intend to do and why they have chosen to apply without canvassing local opinion, making the application at such a time when so many people are away on holiday.... It brings trust into question, does not seem particularly neighbourly and raises concerns about their motives.

Objection 1. Live/ loud Music to 1pm mid week and 2am on weekend night(s)

Grounds: we have experienced this from the Legh Arms on a few dates, notably Saturday 13 July when late night music disturbed the sleep of my family and we had to resort to closing windows on a hot summer evening/ night to reduce the disturbance.

It would seem acceptable to have music if the noise levels are monitored and prevented from leaving the building at above acceptable levels by the requirement for the music to be confined to within the main pub building with all the pub windows being closed.

Objection 2. The Introduction of an outdoors (garden) bar to serve alcohol in the beer garden

Grounds: we have experienced disturbing noise from late night drinkers whose voices carry across the gardens and have woken my children up (ages 3 and 5) on school nights (various June/ July 2013) as well as disturbing adult sleep in the house. This is especially bad when the summer heat requires the windows to be open. If this was confined to last orders at 7pm in the beer garden and people encouraged to move inside the pub after this time ( with all windows closed) this would then seem acceptable.

Objection 3. The use of Legh Arms as a wedding venue

Grounds: noise as above; it would seem acceptable for this to carry on inside the pub building with all windows closed and noise limits being set to ensure neighbours are not disturbed.

We feel that in this residential (incidentally also a conservation area) we should be entitled to relatively peaceful noise levels associated with a residential environment as oppose to inner city noise.

If there are any more specifics required, please let me know and I will be plea to expand.

Please note my objection to the above referenced application for variation of a premises licence on the following grounds.

### **Extension of Licensing Hours**

Any extension of licensing hours, particularly late night hours beyond 11.00 p.m. and up to 2.00 a.m. can and will result in an increase in noise and disturbance to residents in close proximity to the establishment. This will impact on the inherent right of residents to quiet enjoyment and therefore represents the potential for significant diminution of amenity. Additionally, one cannot see the reason for, or benefit of, being granted licence to serve alcohol from 08.00 daily on these premises.

**N.B.** It is noted that in the application the premises are referred to as 'The Legh Arms Hotel'. The Legh Arms is not a hotel. Indeed, nowhere is it referred to as such in its own publicity material. On the contrary, it is clearly stated to be a pub. This ambiguity is troubling and should elicit questions of the owners.

#### Noise and Disturbance:

The extended provision of licensing hours for the playing of live or recorded music within or on the exterior grounds of the premises, will give rise to an unacceptable level of noise disturbance, which again diminishes residents right to quiet enjoyment and impacts on amenity. Noise impact is already experienced by residents in close proximity to the premises when music events are conducted on the premises. Especially given that the downstairs windows of the premises facing onto brook Street are often open.

### Crime & Disorder:

Where the time period for the provision of alcohol is to be extended, it is fair to assume instances of increased consumption. It is reasonable, therefore, to postulate that such increase can, and on occasion will, lead to undesirable behaviour which can result in crime and disorder. This is already experienced with the smashing of windows in the Sparrow Lane telephone box, and, on occasion, damage to parked vehicles.

### **Public Safety:**

The frontage - and main entrance - of the premises is directly onto the busy A537 thoroughfare. There is no pavement to the frontage of the building, nor indeed down a considerable length of Brook Street on the same side of the road as the premises. Similarly, there are the junctions of Legh Road and Mobberley Road conjoining Brook Street, on opposite sides of the road to the left and right of the pedestrian and vehicular access points to the licensed premises. These factors must give rise to concern for the safety of pedestrians, effectively exiting directly onto a busy thoroughfare which carries significant heavy goods traffic at all hours of the day and night.

### **Public Nuisance:**

As previously stated, and widely recognised, the potential for increased alcohol consumption can and does bring about increased incidents of undesirable behaviour, resulting in public nuisance. This can manifest itself through increased noise and rowdiness. Littering, including empty bottles and broken glass. And, as has been experienced, people urinating down Sparrow Lane – specifically in the access alleyways to the rear and frontages of No.s 2, 3, 5, 6 & 7 Sparrow Lane.

I would be obliged if, in considering this application, you give weight to the objections raised herein and reject the application, particularly when considered with regard to potential conflicts with the licencing authority's four licensing objectives and the stated consideration of the rights of local residents to peace and quiet (Statement of Licencing Policy 8.3) and the wider remit of the Local Authorities duty to seek to protect residential amenity.
