Decision in the matter of: Policy for the Allocation of War Memorial Grants

Decision: That approval be given to the Policy for the Allocation of War Memorial Grants.

Background: Cheshire East Council needs to agree the Policy for the Allocation of War Memorial Grants. The policy addresses the governance arrangements, procedures and monitoring process to facilitate this process.

The aim of the grants is to assist the funding of the repair and refurbishment of First World War memorials across the Borough in order to commemorate the anniversary of the start and end of the First World War.

In repairing and refurbishing these important community monuments, it is anticipated that there will be increased local community

involvement and additional events planned around these monuments.
