#### 1.0 Report Summary

1.1 This report presents the Implementation Plan for the Cheshire East Rights of Way Improvement Plan (ROWIP) to cover the period 2015-2019.

#### 2.0 Recommendation

2.1 **That** the Cheshire East Rights of Way Improvement Plan (2011-2026) Implementation Plan for 2015-2019 be approved.

#### 3.0 Reasons for Recommendation

3.1 A Rights of Way Improvement Plan has been compiled for the period 2015-2019 on that basis of the prioritisation methodology approved by the Public Rights of Way Committee on 13<sup>th</sup> December 2010. This is the second Implementation Plan in the period 2011-2026 and is now put forward for approval.

#### 6.0 Policy Implications including - Climate change - Health

6.1 The development of the ROWIP is aligned with the economic prosperity, quality of place, transport and health and wellbeing objectives and priorities of the Council:

- Cheshire East Council 3 year plan 2013-2016:
  - o Outcome 2 Cheshire East has a strong and resilient economy
  - $\circ~$  Outcome 4 Cheshire East is a green and sustainable place to live
  - Outcome 5 People live well and for longer;
- <u>Cheshire East Sustainable Community Strategy</u> priority actions:
  - Ensure a sustainable future
  - Drive out the causes of poor health;
- <u>Cheshire East Local Plan</u> strategy submission version includes a number of Policies (PG5, EG4, SC1, SC2, SE4, SE6, SE7, and CO1) which relate to active travel, health and wellbeing and countryside access;
- <u>Cheshire East Visitor Economy Strategic Framework;</u>
- Cheshire East Local Transport Plan; and,
- Emerging Cycling Strategy core responsibilities.
- 6.2 The role of accessible Green Infrastructure is one of increasing importance within the growth plans for Crewe, the Science Corridor and the Northern Gateway. Accessible greenspace contributes to the quality or 'distinctiveness' of a place. That in turn contributes to the economic wellbeing of an area, offering characteristics that can hold it apart from its neighbours and competitors. In delivering growth in the borough's economy, it will be important that accessible greenspace, together with the other components of quality places, keep pace with this ambition, retaining the characteristics that support existing success and building on those that will help attract future prosperity.
- 6.3 In addition, the ROWIP is an integrated part of the Local Transport Plan.

#### 7.0 Financial Implications

7.1 Potential funding sources, which will include external grants, are identified in the Implementation Plan, but are not committed as the funding is unknown and the actual projects developed may vary from those presented in the Plan.

#### 8.0 Legal Implications (Authorised by the Borough Solicitor)

8.1 It is a statutory duty under section 60 of the Countryside and Rights of Way Act 2000 for every local highway authority to prepare and publish a Rights of Way Improvement Plan. A ROWIP should contain a statement of the action which the authority proposes to take. 8.2 Non compliance with the requirement for the full integration of the ROWIP with the Local Transport Plan could result in criticism from statutory monitoring bodies, agencies and local user groups.

#### 10.0 Background and Options


- 10.1 Under the Countryside and Rights of Way Act 2000, every highway authority in England is required to prepare and publish a Rights of Way Improvement Plan (ROWIP) for its area. The plan must then be assessed and reviewed within ten years and at similar intervals thereafter. ROWIPs were created to publish the authority's assessment of:
  - the extent to which the local Public Rights of Way network meets the present and future needs of the public;
  - the opportunities provided by local Public Rights of Way for exercise and other forms of open-air recreation and the enjoyment of the local authority's area; and,
  - the accessibility of local Public Rights of Way for blind or partially sighted persons and others with mobility problems.
- 10.2 The ROWIP strategy for Cheshire East was developed through consultation with residents and the wider public, Ward Members, local user groups and parish and town councils. The strategy covers the period 2011-2026.
- 10.3 The ROWIP strategy is integrated into the Local Transport Plan in recognition of walking and cycling as means of travel. The strategy is also embedded into the Council's agendas of economic prosperity through visitor economy and high quality of place, and that of health and wellbeing.
- 10.4 On 17<sup>h</sup> January 2011 the Portfolio Holder for Health and Wellbeing approved the Cheshire East <u>Rights of Way Improvement Plan 2011-2026</u> which sets out the strategy for this period.
- 10.5 ROWIPs are also required to contain a statement of the action which the authority proposes to take for the management of local Public Rights of Way, and for securing an improved network of those routes. Therefore, under the ROWIP strategy there are rolling 4-year implementation plans detailing projects through which the policies and initiatives stated in the ROWIP will be delivered.

- 10.6 The first <u>ROWIP Implementation Plan 2011-2015</u> has expired, and the next Implementation Plan has been prepared.
- 10.7 Suggestions for improvement projects are submitted by residents, Ward Members, local user groups, community groups, parish and town councils and officers. These suggestions are prioritised using the methodology selected and amended by the Cheshire Local Access Forum and which was presented to the Public Rights of Way Committee on 13<sup>th</sup> December 2010. This methodology takes into account the benefits of the scheme, including those of health and wellbeing, quality of place and visitor economy, in the context of local need, under the policies and objectives of the ROWIP.
- 10.8 The highest priority suggestions have been selected for each category of suggestion: walking, cycling, horse riding, transport-related and cross-cutting projects. It is intended that these suggestions be investigated and developed first, with the acknowledgement that some may not be feasible and other opportunities may arise through partnerships, funding opportunities and development sites that result in alternative projects being taken forward.
- 10.9 On 13<sup>th</sup> December 2010, the Public Rights of Way Committee gave the Green Spaces Manager the delegated powers to, in consultation with the Chairman of the Committee, compile the Implementation Plan based on the prioritisation methodology. The Implementation Plan was then approved by the Portfolio Holder for Health and Wellbeing on 14<sup>th</sup> March 2011.
- 10.10 A new Implementation Plan has been drawn up, assessing the delivery of the preceding Plan, and setting out the intentions of the Council in relation to the period 2015-2019.
- 10.11 Monitoring and reporting shall be undertaken through annual progress reporting to the Public Rights of Way Committee.



### Introduction

- 2.1 In April 2011, Cheshire East Council published its Rights of Way Improvement Plan (ROWIP) 2011-2026 which set out the strategy by which the Council aims to improve Public Rights of Way (PROW) and countryside access across the Borough.
- 2.2 The publication of a ROWIP is a statutory duty of the Council under section 60 of the Countryside and Rights of Way (CROW) Act 2000. The aim of a ROWIP was given as to:-



Rights of Way Improvement Plan 2011-2026 <sub>Cheshire Eas</sub>

- Assess the extent to which local rights of way and other countryside access resources meet the present and likely future needs of the public;
- Assess opportunities for exercise and other forms of open air recreation and enjoyment of the authority's area; and,
- Assess the accessibility of local rights of way and other routes to blind or partially-sighted people and others with mobility problems.

#### 2.3 The ROWIP has 5 chapters:-

- 1. Introduction an explanation of what the ROWIP is and how it was produced;
- 2. Evaluation of Cheshire's ROWIP 2006-2011 an assessment of successes and ongoing challenges;
- 3. Network assessment a description of what countryside access is available to the public in Cheshire East;
- 4. Demand assessment a description of what people want from Public Rights of Way and countryside access at the present time and future demand trends; and,
- 5. What we need to do listing policies and initiatives through which we aim to make improvements. These are common to the Local Transport Plan 3 (LTP3).
- 2.4 The policies and initiatives stated in chapter five state what we need to do and are repeated below. For full background details please read the ROWIP strategy available at <u>www.cheshireeast.gov.uk/prow</u>.
- 2.5 The CROW Act also requires local authorities to prepare a statement of action listing the projects through which improvements could be made to Public Rights of Way and wider countryside access. These statements of action are contained within 4-yearly implementation plans, this being the second. National and local structures and funding mechanisms have changed since the writing of the first implementation plan, and will continue to change. For example, austerity measures, the development of the Local Plan and

Local Economic Plan and the revision of the Local Transport Plan have and will affect the delivery of the aspirations set out in this document. However, the agendas to which the following policies and initiatives are aligned are, if anything, stronger, with increased need for sustainable travel, healthy activities and enhanced green space.

- 2.6 The momentum of these agendas is being reflected within Cheshire East in its local strategies and policies:
  - <u>Cheshire East Council 3 year plan 2013-2016</u>:
    - Outcome 4 Cheshire East is a green and sustainable place to live
    - Outcome 5 People live well and for longer;
  - <u>Cheshire East Sustainable Community Strategy</u> priority actions:
    - Ensure a sustainable future
    - Drive out the causes of poor health;
  - <u>Cheshire East Local Plan strategy submission version</u> includes a number of Policies (PG5, EG4, SC1, SC2, SE4, SE6, SE7, and CO1) which relate to active travel, health and wellbeing and countryside access; and,
  - <u>Emerging Cycling Strategy</u> core responsibilities.
- 2.7 The role of accessible Green Infrastructure is one of increasing importance within the growth plans for Crewe, the Science Corridor and the Northern Gateway. Accessible greenspace contributes to the quality or 'distinctiveness' of a place. That in turn contributes to the economic wellbeing of an area, offering characteristics that can hold it apart from its neighbours and competitors. #### Policy H2: Promotion of active travel and healthy activities

Work in partnership to promote walking, cycling and horse riding as active travel options and healthy activities

**Promote opportunities and facilities:** highlight opportunities for active travel and healthy activity by promoting new and existing facilities using appropriate media such as signage, walking and cycling maps, leaflets, events, internet sites and other technologies. This will focus on routes and sites that are accessible by modes of active travel or public transport (such as important leisure routes or key employment locations) and will involve working with health agencies, help to promote active travel and other activities as a lifestyle choice for all ages amongst our residents and visitors. Close working with the Peak District National Park Authority and other visitor organisations to provide helpful information and promote a consistent and warm welcome to visitor attractions.

**Organised walks, rides and activities:** undertake and support organised walks, rides and other activities which encourage people to partake in healthy activities that they may not otherwise have the confidence or knowledge to do.

**Public information on the public rights of way network:** enhance the accuracy of the Definitive Map and Statement to provide an up to date and accessible format. This will facilitate changes to the network, through the necessary legal processes, for the benefit of landowners and the public.



#### Policy H3: Public rights of way and green infrastructure

Protect and enhance our public rights of way and green infrastructure and endeavour to create new links where beneficial for health, safety or access to green spaces

**Sustainable access to green spaces:** aim to improve access for all members of society, including disabled people, to and within green infrastructure, including the public rights of way network, town parks, public open space, the Peak District National Park and country parks.

**Link key services:** seek to improve the routes and green infrastructure that link key services (e.g. schools, community centres and tourism destinations) by routes and green infrastructure such as canal towpaths. Investments will include improving surfacing and signage, where appropriate, and creating links where gaps exist in the network.

Leisure routes for cyclists, horse riders and walkers: endeavour to create and enhance leisure routes for cyclists, horse riders and walkers on the public rights of way network and highway network.

Litter, environmental health, safety and security: encourage users to reduce litter and will improve environmental health, safety and other security concerns through education and clean-up campaigns.

**Country parks, town parks and public open space:** ensure adequate maintenance and improvement of land within the Council's ownership that is used for formal and informal public access and recreation, at a local level and sites which are tourism destinations.



#### Policy S7: Walking

# Work with stakeholders to improve facilities for walking so that it is attractive for shorter journeys

**Footway and footpath improvements:** promote improvements to the condition of highway footways, footpaths and public rights of way. In particular, support the development, on safety grounds, of low cost measures, such as verge improvements. Consideration will also be given to resurfacing, removal of litter and other environmental health issues, provision of lighting and seating, where appropriate, and the removal of barriers and obstacles to open up more routes for more people, particularly those with pushchairs and disabled people. This initiative will also recognise the environmental and biodiversity benefits of creating attractive green spaces alongside walkways and cycleways.

**New walking routes:** support the development of new routes where required but not currently provided, such as on rural roads and in villages, and support initiatives to connect up the highway footway and public rights of way networks for greater pedestrian movement, including links to the canal system.

**Pedestrian crossing points:** support the provision of safe crossing points, wide pavements, dropped kerbs and other pedestrian facilities where necessary to encourage travel on foot and improve perceptions of safety along routes and make routes more accessible to disabled people.

**Route signing:** promote the signing of dedicated on- and off-road pedestrian routes to encourage greater use by pedestrians. Initiatives will include the provision of signs relaying destination, distance and time information.



#### **Policy S8: Cycling**

# Work with stakeholders to improve facilities for cycling so that it is attractive for shorter journeys

**New cycle routes:** seek to provide appropriate highways improvements (e.g. on-road cycle lanes or wide nearside lanes) and off-road routes to make commuter cycling a safe and quick alternative to car use. Focus will be on creating a network of joined-up routes catering for a range of cycle skill levels and will capitalise on the potential of the canal system for cyclists.

Junction and route improvements for cyclists: promote the provision of filter lanes, advanced stop lines and toucan crossings, where applicable, to prioritise and enhance the safety of cyclists at junctions. Undertake surfacing and lighting improvements on existing key links. Such measures will be incorporated into the design of new or amended highways, as well as retrospectively to existing road junctions, where possible.

**Cycle facilities:** work to provide greater access to cycling facilities (e.g. cycle parking, changing facilities, showers, hire & ride schemes) in town centres, at community facilities (e.g. libraries) and service and employment centres.

**Route signing:** encourage a greater uptake of cycling through the provision of route signs which state the destination, distance and journey time to selected destinations, to complement other sources of information.



#### **Progress to date**

- **3.1** During the 4 years since the publication of the first ROWIP implementation plan, the Public Rights of Way team have delivered numerous improvements to meet the aspirations of the public and local organisations. Indeed, the everyday and ongoing work of the whole Public Rights of Way team, spanning network management and legal order processes, improves the public rights of way network.
- **3.2** Each year, an annual report is prepared to review the work of the Public Rights of Way team. This report includes work delivered under the ROWIP. The annual reports can be viewed via <u>www.cheshireeast.gov.uk/prow</u>, and elements are summarised below.

#### Length of network and availability to different users

- **3.3** In 2010, the length of the PROW network in Cheshire East totalled 1934.5km. That figure has been increased to 1947.2km as a result of the creation of new PROW and the diversion of existing routes, some cases of which will result in a net increase in the length of the path, whilst other cases may result in a net decrease.
- **3.4** This increase in length has been seen in the categories of Public Footpath and Public Bridleway, both of which are available to pedestrians. Horse riders and cyclists, who can use each of the categories of PROW other than Public Footpaths, can now use 7.9% of the network, compared to 7.6% in 2010. This proportion remains low despite a number of relatively long Public Bridleways that were created during the first Implementation Plan.

#### Ease of use of the PROW network

**3.5** The Public Rights of Way team undertakes path inspections on the basis of the former national Best Value Performance Indicator 178: the percentage of paths deemed 'easy to use'. Each year, a random survey of 5% of the PROW network is undertaken to establish a benchmark indicator, although it is recognised that it is not a full quality audit. 'Ease of use' takes in to account the availability of the route (i.e. not obstructed), and that the statutory signposting is in place. The results returned for Cheshire East Council are shown below.

#### Benchmarking against other authorities

- **3.6** Two benchmarking exercises undertaken in 2012/2013 compared authorities from around the country. The full reports, which can be read on the PROW webpages at <u>www.cheshireeast.gov.uk/prow</u>, found that the Public Rights of Way team at Cheshire East Council works efficiently by:-
  - delivering a joint-second highest 'ease of use' of network score;
  - working with a below-average budget per km length of network;
  - securing some of the lowest per item costs for furniture materials and installation;
  - maintaining a manageable waiting list of Definitive Map Modification Order applications by progressing through casework efficiently; and,
  - delivering a sustainable future workload projection that balances public expectations, resources and statutory duties for the determination of Definitive Map Modification Order applications.

#### Network management and legal order tasks

**3.7** As described previously, the Public Rights of Way team work can be categorised into network management and legal order processes. The tables below summarise the work undertaken during the period of the last Implementation Plan, 2011-2015, both of which describe an increasing workload and output.

#### Usage data

- **3.8** It is recognised that the Council, as is common to other local authorities, had little in the way of data on PROW usage. The PROW team are therefore compiling data from available sources including environmental impact assessments undertaken ahead of new road schemes. A small number of automatic counters are in place on routes such as on the Connect2 Crewe to Nantwich Greenway and further automatic counters have been installed on the PROW network through which further datasets on PROW usage can be collated.
- **3.9** Data on the usage of PROW and wider countryside access routes can provide an indication of the value of the network to our residents and visitors. As a key example, from the usage of a toucan crossing on the Connect2 Crewe

to Nantwich Greenway where it crosses the A530 Middlewich Road, it is estimated that over 40,000 journeys are made on the route every year. Whilst other routes will receive fewer users, the network is highly valued, as was clearly indicated in research for the ROWIP strategy.

#### Working with volunteers

- **3.10** The Public Rights of Way team is ably assisted by a range of volunteers by being the 'eyes and ears' on the PROW network. Many individuals and user groups report in issues that they come across on the network in order that these can be resolved. Some of these reports are on an 'as arising basis' and others, submitted by the Ramblers local groups, take the form of more formal inspections of the network.
- **3.11** In addition, volunteers form a vital role in keeping the PROW network open and available through minor vegetation cutting and putting up waymark disks to guide users along the routes. 133 individuals have registered to carry a Letter of Authority to undertake these tasks whilst out walking or riding. A small number of local groups also arrange working parties on their local network, in close liaision with the PROW team, to undertake practical tasks including step replacements.

#### **ROWIP** projects

**3.12** In addition to the above work, the PROW team deliver improvement projects which aim to meet the policies and initiatives of the ROWIP and which have been logged as aspirations of local communities. Many of these are delivered through the network management role of the team. Other, often larger scale projects, are frequently delivered in partnership with colleagues across the Council's departments, including those managing the Countryside Ranger Service, Cheshire East Highways, Assets and the Parks Development Team (now part of Ansa). Further, many projects are also delivered in partnership with, and sometimes driven by, local volunteer groups and parish and town councils and a range of other local and national bodies, and we are grateful to these groups and individuals for their work. The tables below summarise the ROWIP projects delivered during the term of the first Implementation Plan.



#### **Progress against Statement of Action**

- **3.13** The progress made under the policies and initiatives of the ROWIP have been outlined above. However, a review of progress would not be complete without a direct assessment of progress against the Statement of Action set out in the first Implementation Plan. You'll find that below.
- **3.14** As you will see, some of these projects have not been investigated or delivered fully, and that is due to the delivery of other projects which have required officer and financial resources. As was explained in the first Implementation Plan, other projects may be delivered in place of those listed in the Statement of Action. This is the case, for example, when external funding has been secured by a third party to deliver a project and this results in resources being diverted to deliver that project, rather than one listed in the plan.

### 4 Prioritising improvements

#### Prioritisation


- **4.1** Suggestions for new or improved access continue to be collated from the public, user groups and other organisations. These suggestions are recorded in both geographical and database format for ease of interrogation and sharing with other Council departments, submitting through the planning system and sharing with external organisations.
- 4.2 The suggestions have been assessed and scored through a prioritisation methodology which was selected and amended by the Cheshire Local Access Forum. This statutory body, the predecessor to the current Cheshire East Local Access Forum, advises the Council and other organisations on access to the countryside. The scoring reflects the policies of the ROWIP and the benefits offered by the suggestion in terms of need:
  - improving access where current provision is poor;
  - improving access in a community where there is a high level of deprivation;
  - improving access for disabled people, horse riders and cyclists;
  - improving safety of non-motorised users on roads;
  - Improving access to services such as shops and schools;
  - Improving access to areas of interest such as water bodies or woodland; and,
  - Improving access which will bring about a benefit to the visitor economy.
- 4.3 The prioritisation methodology also incorporates an assessment of the costs of the scheme in terms of capital and resources, and of the feasibility of delivering the suggestion. In the following tables, the amount of staff time required to deliver the project is indicated by stars: \* low, \*\* medium, \*\*\* high. Similarly, the estimated cost of the project is indicated by pound signs: £ low, ££ medium, £££ high.
- **4.4** Those suggestions scoring high in terms of delivering benefits and scoring low in terms of costs have been ranked to be taken forward. The top 5 suggestions in each of the leisure walking, leisure cycling, horse riding, cross-cutting and transport-related categories have been selected.

#### **Statement of Action**

**4.5** The following Statement of Action lists an indicative set of projects that the Council aims to deliver within the 4 year period 2015-2019. What can actually be achieved is dependent to varying degrees on the availability of funding and on landowner agreement. The Council will need to retain flexibility in order to take advantage of opportunities arising, for example, from future development proposals or other partnerships. It follows that the Council may deliver alternative projects to the schemes listed here.

### 4 Prioritising improvements

- 4.6 It is realised that funding from central government, local authority budgets and other sources are likely to be reduced in the future. Therefore, the importance of partnership working in improving the network and the need to draw in external funds from other sources must not be overlooked.
- **4.7** The delivery of projects will also be subject to the organisational changes that will occur within the Council.
- 4.8 Alongside these ROWIP projects, ongoing maintenance works and smaller scale improvements will continue to be undertaken through the maintenance budget of the Public Rights of Way team. These works are aligned to the policies of the ROWIP as well as satisfying the authority's duty to maintain Public Rights of Way. This duty is undertaken in accordance with the authority's prioritisation system for different categories of maintenance and enforcement issues on Public Rights of Way.

### 6 Monitoring

#### Monitoring and assessment

- 6.1 We will continue to monitor the progress of this ROWIP and the subsequent implementation plans through annual reports. These reports are presented to the Public Rights of Way Committee of the Council and published to the website <u>www.cheshireeast.gov.uk/prow</u>.
- 6.2 The Cheshire East Local Access Forum monitor the progress of projects being delivered under the ROWIP and also receive the annual reports.
- 6.3 In addition, monitoring may be undertaken through national indicator sets as these are developed and through the results of the National Highways and Transport Network Satisfaction Surveys.
- 6.4 It is intended that the 'ease of use' random surveys will continue to be conducted and used to monitor the maintenance condition of the Public Rights of Way network.
- 6.5 Finally, the CROW Act 2000 set the requirement for ROWIPs to be reviewed at intervals of not less than 10 years. Given that the strategy extends beyond that timeframe, it is recognised that periodic review will be required and that these Implementation Plans will in effect enact that appraisal.
