**Procedure for Hearings – Licensing Act 2003****The Licensing Committee**

The full Licensing Committee consists of fifteen elected Members of the Council. From this full Committee will be drawn sub-committees of three members to deal with licensing functions under the Licensing Act 2003. The Chairman and Vice Chairman of the Licensing Committee shall have the discretion to refer a matter up to a hearing of the full Licensing Committee.

**Officers at Hearings**

- **The Committee Officer** introduces all parties and records the proceedings
- **The Legal Adviser** provides independent advice to the Members on legal matters and procedure.
- **The Licensing Officer** will introduce the matter and outline the application; the officer will also answer any questions Members may have.

**PROCEDURE**

NOTE: If the Sub-Committee has not already elected a Chairman, that will be the first item of business.

<b>1</b>	<b>Chairman</b>	The Chairman will: (i) call the matter to be considered (ii) call for any declarations of interest (iii) ask all parties to introduce themselves (iv) summarise the procedure to be followed at the hearing (v) will consider any request made by a party for another person to appear at the hearing (v) will advise the parties of any maximum period of time in which it has to present its case (if a maximum is imposed this shall be equal for all parties)
<b>2</b>	<b>Licensing Officer</b>	Will introduce and summarise the application, highlighting areas of contention or dispute.
<b>3</b>	<b>Committee Members</b>	May ask questions of the Licensing Officer
<b>4</b>	<b>Applicant</b>	Will present his/her case, calling witnesses, as appropriate.  <i>(If necessary, applicant will produce any notices required by law. Legal Adviser will draw attention to this if required.)</i>

5	<b>Responsible Authorities</b>  (who have made representations)	Each in turn may ask <u>questions</u> of the applicant, by way of clarification.
6	<b>Other Persons</b>  (who have made representations)	To be invited to ask <u>questions</u> of the applicant, by way of clarification.  <i>It is normal practice for a spokesperson only to speak on behalf of a group of residents.</i>
7	<b>Committee Members</b>	Each in turn may ask <u>questions</u> of the applicant.
8	<b>Applicant</b>	May make a <u>statement</u> or ask his witnesses to clarify any matters which he feels are unclear, or may have been misunderstood.
9	<b>Responsible Authorities</b>	Will make their representations.
10	<b>Applicant</b>	Or his representative or witnesses to ask <u>questions</u> of Responsible Authorities represented at the meeting, by way of clarification.
11	<b>Other Persons</b>  (who have made representations)	May ask <u>questions</u> of the Responsible Authorities represented at the meeting, by way of clarification.  <b>(Note: This is not the point at which they should be stating their objections.)</b>
12	<b>Committee Members</b>	May ask <u>questions</u> of the Responsible Authorities represented at the meeting
13	<b>Other Persons</b>  (who have made representations)	Those who have objected to the application will be invited <b><u>to make observations on the application</u></b> and present the bases of their objections.
15	<b>Applicant</b>	Or his representative or witnesses may ask <u>questions</u> of the other persons, by way of clarification.
16	<b>Committee Members</b>	May ask <u>questions</u> of the other persons.
17	<b>Chairman</b>	To invite both <b>Responsible Authorities</b> and <b>Other Persons</b> to make their closing addresses.
18	<b>Applicant</b>	Or his representative will <u>briefly summarise the application</u> and comment on the observations and any suggested

		conditions.
19	<b>Committee</b>	<u>Will retire</u> to consider the application. The Committee may request the Legal Advisor to advise on legal issues.
20	<b>Committee</b>	<p>Will return to <u>give its decision</u>, with reasons, which will be announced by the Chairman and subsequently confirmed in writing to the applicant and to all the parties that made representations.</p> <p>In cases where a decision cannot be given at the end of the hearing, parties will be advised of the decision within five working days.</p>

### Notes

1. The hearing shall normally be held in public. There may be occasions on which the Committee find it necessary to exclude members of the press and public; any such decision will be taken on the basis that the public interest in doing so outweighs the public interest in the hearing, or that part of the hearing taking place in public.
2. The Chairman may require any person behaving in a disruptive manner to leave the hearing and may (a) refuse to permit that person to return, or (b) permit him/her to return only on such conditions as the authority may specify, but any such person may submit in writing any information which they would have been entitled to provide orally if they had not been required to leave.
3. Prior to the hearing each party shall have given notification and served documentation (eg statements of witnesses or reports of experts) as required. Late representations and evidence will only be considered with the agreement of all parties.
4. Anyone entitled to be heard may be represented by any person, whether or not that person is legally qualified.
5. Hearsay will be permitted but the Sub-Committee will be reminded to give it appropriate weight.
6. Due note shall be taken of the provisions of the Hearings Regulations 2005.
7. The Chair may, in the interests of expediency or convenience of the parties, vary the procedure from time to time, provided notice is given to the parties and the rules of natural justice are observed.

## Summary of Procedure

1. Chairman appointed (if this has not been done previously).
2. Chairman to call for declarations of interest and request that all parties introduce themselves.
3. Chairman summarises the procedure for the hearing
4. The Licensing Officer summarises the application
5. Applicant to present his/her case.
6. Applicant to be questioned by all parties (to clarify points only) following which, he/she can clarify any other matters which he/she feels may have been misunderstood when the application was presented.
7. Applicant to be questioned by the Committee.
8. Responsible Authorities to make their representations following which they can be questioned by all parties by way of clarification.
9. Other Persons will be invited to present the bases of their objections, following which they can be questioned by all parties by way of clarification.
10. The applicant will be invited to sum up his/her case
11. Committee/Sub-Committee withdraws to make its decision
12. Committee/Sub-Committee returns to announce its decision to all present.

**1.0 Report Summary**

- The provisions of the Human Rights Act 1998

- 6.1 The Licensing Authority has adopted a Statement of Licensing Policy in accordance with Section 5 of the Licensing Act 2003.
- 6.2 Whilst having regard to the general principles within the Statement, Members may wish to consider the following:
- 6.2.1 The representations relate to the Licensing Objectives 'Prevention of Crime and Disorder' and 'Prevention of Public Nuisance'. The Licensing Authority sets out at paragraphs 7 and 9 respectively within the Statement of Licensing Policy how it will deal with representations under these objectives.
- 6.3 Members should provide reason(s) for any decision taken and should set out their reasoning where they determine to depart in any way from the Policy or Guidance.

### **8.0 Legal Implications**

- 8.1 In accordance with the provisions of section 18 of the Licensing Act 2003 the Licensing Authority must, having regard to the representations, take such steps (if any) as it considers appropriate for the promotion of the licensing objectives. Section 18(4) provides that the authority may:
- (a) Grant the licence subject to the relevant mandatory conditions and conditions consistent with the operating schedule
  - (b) Modify the application to such extent as the Authority considers appropriate for the promotion of the Licensing Objectives
  - (c) Exclude from the scope of the licence any of the Licensable Activities to which the application relates



- (d) Refuse to specify a person in the licence as the Premises Supervisor
- (e) Reject the application.

- 8.2 Members are reminded that should any conditions be added, they should be practical, enforceable and appropriate to promote the Licensing Objectives.
- 8.3 Members are also reminded of the statutory obligation placed on the Local Authority under section 17 of the Crime and Disorder Act 1998 to through all of its various functions, and Licensing is one of those functions to do all that it can to prevent Crime and disorder, Anti-social Behaviour, behaviour adversely affecting the environment and re-offending.

## **9.0 Risk Management**

- 9.1 Section 181 and Schedule 5 of the Licensing Act 2003 make provision for appeal to the Magistrates' Court of any decision made by the Licensing Authority.

## **10.0 Background and Options**

- 10.1 The application was received on 20<sup>th</sup> February 2017. The application is to vary a Premises Licence under Section 34 of the Licensing Act 2003.

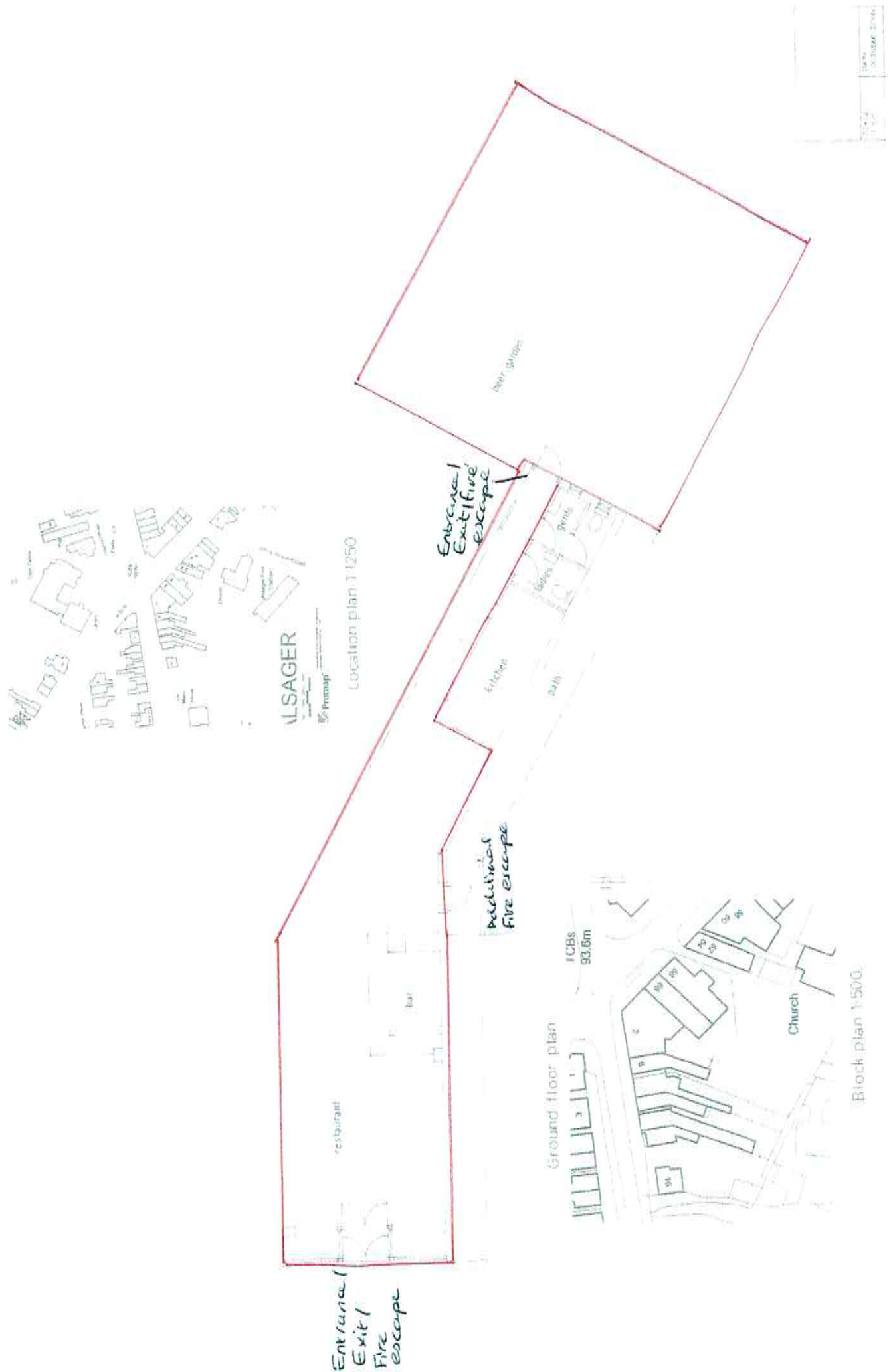

- d) Selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;

- c) Where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

- iii. the personal licence holder who makes or authorises a supply of alcohol under such a licence;

d) 'relevant person' means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

e) 'valued added tax' means value added tax charged in accordance with the Value Added Tax Act 1994.

3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

## Paul praised for running allergy support group

A support group aimed at individuals or families with severe allergies holds its next meeting on Saturday, 25th March.

Congleton dad Paul Moses formed the Allergy Cheshire support group because his four-year-old son James, a pupil at Quinta Primary, suffers from severe anaphylaxis.

Now Mr Moses, (54), of West Heath, has the help of the Anaphylaxis Campaign, the only UK-wide charity to support people with life-threatening allergies.

Mr Moses said: "I got involved with the campaign after my son James' first anaphylactic reaction at seven months, which was severe. Doctors in A&E failed to diagnose allergy, so it was left to me to search the internet for his symptoms and understand what had happened."

"I was able to get a referral to an allergy specialist where he was diagnosed with wheat and peanut allergies."

Food allergies are thought to affect around 8% of children and 4% of adults. Hospitals in England dealt with more than 20,000 admissions for allergies in the 12 months between February 2013 and February 2014.

Mr Moses continued: "We know of others in our area similarly affected so I have decided to set up a local group, with the support of specialists at our local allergy centre."

"Hopefully the group will help to raise awareness of those at risk of severe allergy, and offer a support network to people in the local community who might otherwise feel isolated and unsupported."

The meeting on Saturday, 25th March, is between 10.30am and 12.30pm in The Lecture Theatre (first floor), Macclesfield District General Hospital, Victoria Road, Macclesfield, Cheshire SK10 3BL.

Anaphylaxis Campaign CLO Lyne Regent said: "It's brilliant that Paul runs a support group for us in Macclesfield. Many people in the general population do not understand just how serious allergy and anaphylaxis can be."

"Our support groups, like the one Paul is running, provide a vital touch point for affected families and individuals and are a really positive way for them to support each other."

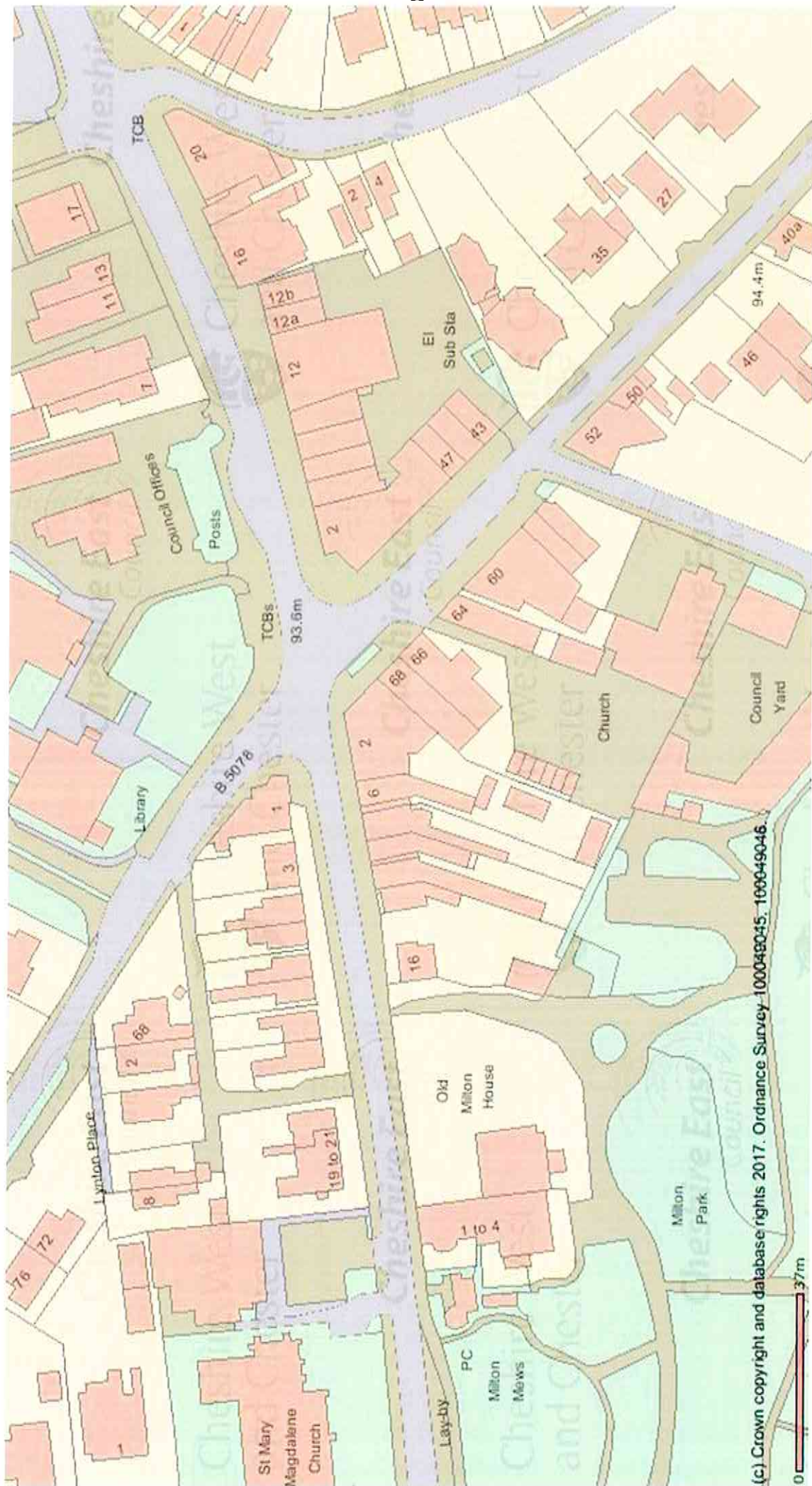

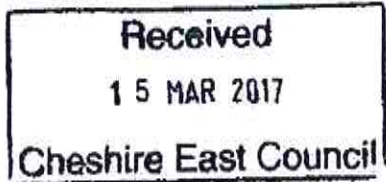

I have just been made aware of an application for variation to a premises licence; one that would allow the premises known as Six Bar and Grill, 6 Crewe Road, Alsager, to extend their licensable area and times.

I wish to register a formal objection to this extension to both licensing and opening.

I live in Milton Park, roughly 100-150metres from the Six Bar and Grill location and am deeply concerned that live music and extended alcohol serving times will negatively impact upon the quality of life of myself, my family and other local residents (many of whom are elderly). The Six Bar and Grill, whilst being on a main high street and in the centre of the town, has residents within its immediate proximity and the needs of these should be taken into account, above the needs of a newly-acquired premises. An alcohol licence that extends to 22:30/23:00hrs and only for customers purchasing food on the premises, as currently in place and the norm, is perfectly acceptable and meets both the demands of the premises type and the local needs; allowing live music to midnight on a Monday to Thursday will negatively and severely impact upon my health and well-being (I have to work during the week, getting up at 04:00hrs, as do many other people within 150metres of this premises) and upon those of my family and other local residents. Furthermore, allowing live music and extended alcohol serving times to 00:30hrs on a Friday and Saturday will, again, be noise intensive and will, as we have experienced previously, result in additional demands upon the police and cause issues of noise and disturbance for local residents that are totally unacceptable and will, be in no doubt, negatively impact upon the number of local customers that the premises wishes to welcome through its doors. The additional request for 23:30hrs on a Sunday is equally unacceptable; those who have to leave for work on a Monday will have been negatively impacted upon by this. This has happened previously on a Saturday evening in October 2015 when a large marquee was erected in the rear of the same premises. The marquee was immediately adjacent to Milton Park and only 100 metres from our house on the corner of Station Road. There was loud music from 9.00 on Saturday night until 1.30 on Sunday morning , accompanied by flashing strobe lighting. It looked as if there was an event inside the park. Dear Sir / Madam

I am writing this email as an objection to the proposal that the premises that was steakhouse No6 and is now known as Six Bar and Grill, would like to change its licence with regard to both its licensed hours and its use of music.

I would like to object, firstly due to past experiences of a premises of this sort owned by the same person. Unfortunately with the owners previous bar, for the two years in which it was open, there was a catalogue of problems that resulted in a large number of complaints to environmental Health, licensing, and the police, from a number of residents including myself. Problems included excessively loud music throughout the week, opening outside of the licensed hours, drug problems (including a early morning drugs raid in which cannabis was found to be growing), illegally showing sports events, violence from patrons of the bar on a regular basis on the street, and anti-social behaviour almost every night as people left the venue. Surely a person associated with a venue of this kind can not open another venue exactly the same elsewhere (let alone 100m up the same road), I would hope checks are completed not just on the licence applicant but also the owner of the property to cross reference with any previous businesses within the industry, and past behaviours taken into account.

I therefore ask that this application is decided with this in mind and that the records for the owners previous property ( ) are considered and the impact that the proposed hours and allowances for music will have on the local residents and community. There are a high number of residential properties in and around the proposed bar even though this is within the town centre that will be greatly effected by the noise and anti-social behaviour that will be produced by this proposed change. The premises also backs onto the local park that is used by many children and families, is this really the sort of venue that should be close to where families and children play.

Unfortunately past experience would indicate that even if there was a slight relaxation on any of the conditions that are imposed at the present would lead to misuse. I am keen to see the town centre thriving and new business open. When the property was a steak restaurant it did not require late night opening and live music to function successfully. The new proposal is that this venue is a Grill, if that is the case then the application to change is contradictory to what the proposal is indicating the premises to be. A grill restaurant does not need the late night hours or live music any more than a steakhouse would. The proposed hours and music usage would only encourage the irresponsible behaviour already experienced when a bar of this type was opened by the owner. Since has closed there has been no issues along Crewe Road including with people visiting the takeaways after the other licensed premises close.

I hope that this application is rejected and the local residents considered before they have to endure the numerous issues mentioned within this email that would occur if this application is approved. If the venue wishes to become a grill then this would be a benefit to the town since it has just lost two similar restaurants recently. However this would not need the proposed changes to occur.

As residents of Alsager, living on Station Road, approximately 200 yards from the Six Bar , we wish to object to the Application for a variation to a Premises Licence .

We are concerned about

1) the level of late night noise that could be generated.  
2) the likelihood that late night availability of alcohol would cause rowdy behaviour and disturbance in the area.  
Station Road is a residential Road with some elderly residents like ourselves (in our 70s and 80s) and several families with young children. Neither of these groups would welcome more noise and disturbance in the Milton Park area. The 6 Bar backs onto Milton Park which is a great resource for the children of Alsager. Sometimes we see the remains of late night misbehaviour in the park in the form of broken glass and bottles and other unsavoury articles in the play area. Anything that increases the incidence is most unwelcome and increases the likelihood of harm to children.

On another side of the Park about 200yards away is New Milton House which is a residential Care Home and some thought needs to be given to the possibility of noise and disturbance spreading in that direction.

Milton Park is a great resource for the community of Alsager and Station Road residents such as ourselves are very happy to enjoy community events such as the Carnival and Music Festival , football matches etc that take place there even though we do have extra noise and disturbance on those days. But we do feel that if this extra licence were to be granted that we would be subjected on a very regular and consistent basis to late night noise and rowdiness which no one wants on their doorstep.

We are very concerned about noise from music, live and recorded till midnight (Mon-Thurs), till 00.30 (Fri-Sat) and to 11.30pm (Sun). We are very concerned about music being played outside; we may be the nearest residential property to 6 Crewe Road. This is especially of concern in summer months when windows are open and noise is more disruptive. The hours detailed in the variation cover every night of the week. The premises are small. We do not consider that this venue is suitable for music in the way outlined in the Variation. There are residences close by on Sandbach Road North and Sandbach Road South and we are very concerned about late-night disturbance. There has been instance in the past of music at this venue being played outside and at a loud level ; it disturbed us and was excessive.

We are concerned about the later hours of supply of alcohol at 6 Crewe Road and the increase of number of licensed premises in Alsager centre in general. Is the number of licensed premises and hours of supply in an area controlled?

As a local resident I wish to make representations objecting to the application for a variation to the Premises Licence in relation to 6 Crewe Road, Alsager, ST7 2ES now known as Six Bar & Grill.

The premises are situated in close proximity to a residential area of the town and until recently were retail premises.

My main objection is to the application to extend the licensable area to the outdoor area at the rear of the premises (possibly in a tent) and play live and recorded, amplified/unamplified music. This outdoor area backs on to Milton Park and there is no barrier to prevent noise travelling from the premises to the surrounding residential properties including those in Crewe Road, Sandbach Road South, Woodhouse Avenue, Wollaston Avenue and Station Road (some of which is a Conservation Area). Included amongst those properties is the old peoples' home New Milton House in Station Road. The Supported Retirement Development Homeshire House is also well within ear-shot.

We already have experience of the impact that this proposition may have when an event was held at these premises about 18 months ago, when it was known as No. 6 Steakhouse, involving an outdoor disco until the early hours of the morning.

Clearly the potential noise nuisance not only represents an invasion of our privacy and right to peaceful use and enjoyment of our home but is also a risk to our health and well-being due to disturbance at night time and deprivation of normal sleep. I have no confidence whatsoever that the assurances given in the application about the timing of events and safeguards to prevent nuisance will have any real effect if approval were to be given, ie it would be a carte blanche for whatever events were to be run, with no control to limit the activities on the premises.

I also wish to object to the application to allow alcohol to be served other than to persons taking a meal on the premises. This is a clear attempt to turn the premises into nothing other than a late night drinking venue, involving loud music and potentially anti-social behaviour as the premises are vacated. The local area already has enough premises in the close proximity for consumption of alcohol, with the Bank Corner and recently opened Kraftworks, so another venue is completely unnecessary.

Finally I would object to the later closing hours applied for since they are clearly inconsistent with other local premises and a factor for potential disturbance of local residents as the premises are vacated. I have no objection whatever to these people running this establishment as it was first intended ie as a restaurant offering food and drink to customers with some music inside to create some atmosphere, within reasonable opening hours, but approval of the variation would give the go-ahead to turn it into a completely different entity totally incompatible with the surrounding area.

I would like to object to the change of licencing for *6 Bar and Grill* on Crewe Road. This is formally known as *Steak House number six*.

**The owner of this property is in fact the same owner that owned** . This bar was over the road from my house and I had to suffer months and months of sleepless nights as a result of the lack of care for the local residents. The laws and the rules were unfortunately exploited through out the whole two years that was open. **This new bar will be owned by the same person.** I experienced nuisance, disturbance, noise pollution, anti social behaviour and a drugs farm out the back (not slander- this was in the newspaper and I witnessed the drugs raid out of my front room window with my vouna children present).

As someone who lived over the road from I witnessed fights spilling out of the bar and I witnessed several fights in the middle of the road. Music that I could hear from my front room and



would regularly wake up my children and baby who at the time had a bedroom at the front of the house. It was absolutely appalling and I am getting worked up now just thinking about how awful it was. I actually walked over there once in my dressing gown in floods of tears because I could not sleep. I asked them to turn the music down and they would not. They made me feel worthless. Bars can be well run with sound proofing, door men and the owners who actually care for local residents and take responsibility for what happens when customers leave their establishment at gone midnight. [redacted] would just shut their doors and not give a monkey's about what their customers did when they left drunk and rowdy. I don't ever want to go through that again and this new bar is about 100meters from my house. I also witnessed several lock ins that went on into the early hours of the morning.

Once I witnessed a fight in the middle of Crewe road (spilt out of [redacted]) Two men in the road in vest tops knuckle fighting late at night. I actually discovered one of the men hiding in my garden and had to ask him to leave despite being terrified. The police were called so the men got into a white van that was parked in the car park (around the back of [redacted]) and drove off at high speed despite the fact that they had spent the night drinking in the bar. This is just one of many. The man who was found in my garden said "I don't want to fight because otherwise I'll go back down and I have only just come out of prison." Absolutely horrendous and I moved to Alsager believing it to be quiet beautiful little town. These men were not even from Alsager yet this bar was able to attract unsavoury characters from out of the town.

I don't mind a bit of noise as people leave pubs provided they are walking down the street heading home. I live at [redacted] so it can be expected at times but this was nothing like that. Since [redacted] has shut there have not been any issues. I am now absolutely alarmed that a new bar will potentially be opened and will be owned by the same person. If this bar opens it will be detrimental to Alsager. I am still dumbfounded as to how a man who was found with a drugs farm at the back of his previous bar is actually even being considered to open a new bar only 100 meters up the road? I am concerned that the property he wants to play loud music from is not even designed for live music- it has always been a café/restaurant in the past. I am worried about drunk people in the street late at night, smashing bottles, lock ins, loud music etc..

I am sure that if you got in touch with the police and environmental health they will have a list of complaints, incidents and reports all based on [redacted] **My concern is that this new bar is owned and will be run by the same person.** This new Bar will attract unsavoury characters into the area and the owner will not care about the local residence living near by. This is based on what I personally lived through living opposite [redacted]
