### **Procedure for Hearings – Licensing Act 2003**

### **The Licensing Committee**

The full Licensing Committee consists of fifteen elected Members of the Council. From this full Committee will be drawn sub-committees of three members to deal with licensing functions under the Licensing Act 2003. The Chairman and Vice Chairman of the Licensing Committee shall have the discretion to refer a matter up to a hearing of the full Licensing Committee.

### **Officers at Hearings**

- The Committee Officer introduces all parties and records the proceedings
- The Legal Adviser provides independent advice to the Members on legal matters and procedure.
- The Licensing Officer will introduce the matter and outline the application; the officer will also answer any questions Members may have.

### **PROCEDURE**

NOTE: If the Sub-Committee has not already elected a Chairman, that will be the first item of business.

#### **Notes**

- The hearing shall normally be held in public. There may be occasions on which the Committee find it necessary to exclude members of the press and public; any such decision will be taken on the basis that the public interest in doing so outweighs the public interest in the hearing, or that part of the hearing taking place in public.
- 2. The Chairman may require any person behaving in a disruptive manner to leave the hearing and may (a) refuse to permit that person to return, or (b) permit him/her to return only on such conditions as the authority may specify, but any such person may submit in writing any information which they would have been entitled to provide orally if they had not been required to leave.
- 3. Prior to the hearing each party shall have given notification and served documentation (eg statements of witnesses or reports of experts) as required. Late representations and evidence will only be considered with the agreement of all parties.
- 4. Anyone entitled to be heard may be represented by any person, whether or not that person is legally qualified.
- 5. Hearsay will be permitted but the Sub-Committee will be reminded to give it appropriate weight.
- 6. Due note shall be taken of the provisions of the Hearings Regulations 2005.
- 7. The Chair may, in the interests of expediency or convenience of the parties, vary the procedure from time to time, provided notice is given to the parties and the rules of natural justice are observed.

### **Summary of Procedure**

- 1. Chairman appointed (if this has not been done previously).
- 2. Chairman to call for declarations of interest and request that all parties introduce themselves.
- 3. Chairman summarises the procedure for the hearing
- 4. The Licensing Officer summarises the application
- 5. Applicant to present his/her case.
- 6. Applicant to be questioned by all parties (to clarify points only) following which, he/she can clarify any other matters which he/she feels may have been misunderstood when the application was presented.
- 7. Applicant to be questioned by the Committee.
- 8. Responsible Authorities to make their representations following which they can be questioned by all parties by way of clarification.
- 9. Other Persons will be invited to present the bases of their objections, following which they can be questioned by all parties by way of clarification.
- 10. The applicant will be invited to sum up his/her case
- 11. Committee/Sub-Committee withdraws to make its decision
- 12. Committee/Sub-Committee returns to announce its decision to all present.

### 1.0 Report Summary

1.1 The report provides details of an Application for the Review of a Premise Licence under section 51 of the Licensing Act 2003 and outlines the evidence presented by the parties in relation to the Review.

### 2.0 Decision Requested

2.1 The Licensing Act Sub-Committee is requested to determine the Application for the Review of a Premises Licence by Mr N Dodd, a local resident, in respect of:

White Horse Inn 22 Pillory Street Nantwich CW5 5BD

- 2.2 The Licensing Act Sub-Committee is requested to consider the review application and any relevant representations and determine what steps, if any, it considers are appropriate to promote the Licensing Objectives.
- 2.3 Acting in the capacity of Licensing Authority, Members must seek to promote The Licensing Objectives, and where Members consider matters have engaged one or more of the objectives, they may exercise their discretion. The Licensing Objectives are:
  - (a) The prevention of crime and disorder
  - (b) Public safety
  - (c) The prevention of public nuisance
  - (d) The protection of children from harm
- 2.4 The Sub-Committee in respect of this application must have regard to the Guidance issued under Section 182 of the Licensing Act 2003 and the Council's Statement of Licensing Policy.
- 2.5 Finally, Members are also reminded that in determining the application in accordance with the Licensing Act 2003, Members must also have regard to:
  - The rules of natural justice
  - The provisions of the Human Rights Act 1998

### 2.6 Members should also consider the following:

- The Local Authority's statutory responsibility under the Health and Social Care Act 2012 for the health of the population of Cheshire East
- Local Authority's statutory duty under the Crime and Disorder Act 1998 to have regard to the need to do all that it reasonably can to prevent crime and disorder, misuse of drugs and alcohol and reoffending in its area.

3.1 The Licensing Act Sub-Committee has the power to determine this application in accordance with the provisions of the Licensing Act 2003 and the Council's Constitution.

### 6.0 Policy Implications

The Licensing Authority has adopted a Statement of Licensing Policy in accordance with section 5 of the Licensing Act 2003. Whilst having regard to the Statement as a whole and the general principles contained within, Members may wish to consider the following:

- This application for the review of a premises licence relates to the undermining of the prevention of public nuisance objective. The Council's policy deals with these matters at paragraph 9.
- Anti-social behaviour, which overlaps with the public nuisance objective, is also addressed within the Councils Policy at paragraph 6.
- The Policy also deals with the reviews of licences and enforcement matters at paragraph 17.

Members should provide reason(s) for any decision taken and should set out their reasoning where they determine to depart in any way from the Policy or Guidance.

### 7.0 Financial Implications

7.1 Not applicable.

### 7.0 Legal Implications

Sub-section 52(2) of the Licensing Act 2003 prescribes that before determining an application for review received in accordance with section 51, the Licensing Authority must hold a hearing to consider the review application and any relevant representations.

Sub-section 52(3) states that the authority must, having regard to the application and any relevant representations, take such of the steps mentioned in subsection (4) (if any) as it considers appropriate for the promotion of the Licensing Objectives. The steps set out within sub-section (4) are:

- Modify the conditions of the licence, this could include either imposing further conditions on the licence or changing (for example, further restricting) the hours of certain licensable activities, where this is proportionate and relevant to the licensing objectives. This may also include a requirement that unregulated entertainment becomes regulated again between the hours of 8am and 11pm. For this purpose, the conditions of the licence are modified if any of them are altered or omitted, or any new condition is added.
- Exclude a licensable activity from the scope of the licence
- The Sub-Committee may decide that it is proportionate and relevant to the Licensing Objectives to remove one or more of the licensable activities.
- Remove the designated premises supervisor
- Suspend the licence for a period not exceeding three months
- Revoke the licence
- 8.2 Members are reminded that should any conditions be modified, they should be practical, enforceable and appropriate to promote the Licensing Objectives.
- 8.3 By virtue of section 52(11) of the Licensing Act 2003, any decision of the Sub-Committee to take one or more of the steps set out above does not have Effect:
  - (a) Until the end of the period given for appealing against the decision or
  - (b) If the decision is appealed against, until the appeal is disposed of.

### 9.0 Risk Management

9.1 Section 181 and Schedule 5 of the Licensing Act 2003 make provision for appeal to the Magistrates' Court of any decision made by the Licensing Authority.

### 10.0 Background

- 10.1 On the 13<sup>th</sup> September 2017 an application for a review of the Premises Licence was submitted by Mr N Dodd a resident of Pillory Street, Nantwich. The grounds for review set out within the review application were the Prevention of Public Nuisance. A copy of the review application is appended to this report as Appendix 1.
- 10.2 A copy of the Premises Licence setting out the premises licence holder, Designated premises supervisor and conditions etc. is appended to this report at Appendix 2.
- 10.3 Within the prescribed consultation period in relation to the review, the Licensing Authority has received representations from Responsible Authorities under the Act. Representations have also been received from other person(s) as defined within the legislation.
- 10.4 In reviewing the Premises Licence and making its decision, the Licensing Act Sub-Committee must have regard to the application and relevant representations. The Sub-Committee may take such of the steps referred to within sub-section 52(4) of the Licensing Act 2003 (if any) as it considers appropriate for the promotion of the Licensing Objectives.
- On the 30<sup>th</sup> June 2016 Mr Dodd applied to review the premises licence for this premises. Mr Dodd contented that the premises was undermining the Licensing Objectives for the following reason The premises are undermining the prevention of public nuisance licensing objective. The premises is causing a nuisance by allowing music to be heard outside the premises and by allowing groups of people to congregate outside of the premises into the early hours.

The review was supported by Cheshire East Environmental Health, Licensing, and four other persons. At the Hearing, after considering all the evidence and information before it, the Sub-Committee replaced the operating schedule conditions with a new operating schedule prepared on behalf of the premises licence holder. That operating schedule has been in place since the hearing and can be found on the premises licence at appendix 2. Members were of the opinion that the new operating schedule should reduce any undermining of the Licensing Objectives.

### **Grounds for License Review**


After taking the White Horse Public House to Court in August 2016 for License Review due to excessive noise and general rowdiness outside the pub with smokers stood on Pillory street it was pleasing that for many months the problem of late night noise with punters from the White Horse Public House had gone away. Measures put in place by the pub, extra security staff and awareness of their neighbours was noticeably different. During 2015 and 2016 I was in a relationship with a woman from Stoke so not often at home on Pillory Street but that relationship ended in June 2016, so I've been home most nights ever since.

As a professional Railway Manager my job takes me all over the country often with midweek nights away however I'm always at home on a Sunday night and up early for work Monday morning compiling reports for the Executive Team first thing.

Friday and Saturday nights on Pillory Street are often boisterous with people passing along the street on the way home from a night out always without issue.

Sunday nights are the issue with the White Horse Public House being the only pub in town open after 11pm so it attracts Students who I guess don't get up for work on a Monday morning.

At 02:15 Monday 17th July I was awoken by revellers coming out of the White Horse screaming and shouting as they walked passed by apartment. I photographed the individuals to record the event forwarding copies of the pictures to Cheshire East Council Licensing Department and Tess the landlady of the White Horse. Cheshire East Council acknowledged my email saying they would speak with the landlady accordingly. To say I was exhausted at work on that Monday was an understatement. I saw Tess a few days later and we chatted about the rowdy punters most of which she knew by name after looking at my pictures! Tess went on to say she'd started getting complaints from other residences in the Town Square / Mill Street of people making excessive noise after leaving her pub in the early hours. She said she struggled to control people after they left her pub but had asked her Local Police Liaison Officer for a police presence on a Monday morning like other licensed establishments have on a Friday or Saturday night. I asked Tess about the drunken state of the people I had photographed and she replied she just serves them water if they appeared drunk in a bid to sober them up so they can all go home together and not have single girls walking home alone.




It's a shame the picture doesn't show the people shouting and swearing at the top of their voices.

At 02:10 Monday 7th August I was awoken by shouting. I looked out my bedroom window and saw a crowd stood outside the White Horse Public House with one girl very agitated swearing at the top of her voice. I switched my phone onto video to record the events. The girl swearing walked down Pillory Street towards my apartment still sweating at the top of her voice with appropriately fifteen other people young men and woman and then it kicked off with several young men punching each other. This is when I stopped filming and called the Police to report fighting on the street. Police reference 65 / 07082017. Within a few minutes a single Police car arrived on the scene. The single Police Officer was faced with approx fifteen people brawling, one man dressed in dark clothing was put in the back of the police car. Then another Police car arrived again with a single Police Officer. Within twenty minutes the situation was calmed by the Police presence and most people had dispersed. I couldn't tell if the man on the back of the police car had been detained or not. I rang the police back to advise I had full video footage on my iPhone of the disturbance for their reference and they said someone would be in touch in days to come.

I emailed Cheshire East Council at 3am to advise them what had happened. I also text messaged Tess from the White Horse Public House who advised she had requested the Police to be proactive and be outside for closing time but no one had turned up. She advised me that she called the Police herself on seeing the fighting start outside her pub. She also advised she had banned approx twenty people that evening for making excessive noise in the street.

I have no problem with the White Horse Public House as a pub but the need for it to be open until 02:00 Monday morning and 02:00 weekday nights is not needed for a small historical market town with residence all around. Young predominantly students getting drunk and being served alcohol until they are ready for a fight is not needed in the conservation area that is Pillory Street. To note there is rarely issues on a Friday and Saturday night.

Needless to say Monday 8th August I was exhausted at work thanks to the antics of the minority spolling it for other and giving the town a bad reputation.

#### **Annex 1 - Mandatory Conditions (as applicable)**

- 1. No supply of alcohol may be made under this Premises Licence
  - a) at a time when there is no designated premises supervisor in respect of the Premises Licence, or
  - b) at a time when the designated premises supervisor does not hold a Personal Licence or his Personal Licence is suspended.
- 2. Every supply of alcohol under this Premises Licence must be made or authorised by a person who holds a Personal Licence.

### Where a Village Hall is exempt from needing DPS under s.19 Licensing Act 2003

Every supply of alcohol under the premises licence must be made or authorised by the Management Committee.

#### Mandatory condition where the licence authorises the exhibition of films

The admission of children to the exhibition of any film must be restricted in accordance with section 20 of the Licensing Act 2003. Admission of children must be restricted in accordance with any recommendation made by the British Board of Film Classification or the Licensing Authority.

#### Prohibited conditions: plays

- 1. In relation to a premises licence which authorises the performance of plays, no condition may be attached to the licence as to the nature of the plays which may be performed, or the manner of performing plays, under the licence.
- 2. But subsection (1) does not prevent a licensing authority imposing, in accordance with section 18(2)(a) or (3)(b), 35(3)(b) or 52(3), any condition which it considers necessary on the grounds of public safety.

#### **Mandatory condition: Door supervision**

Each individual engaged in security activities at the premises must either:

- a) be authorised to carry out that activity by a licence granted under the Private Security Industry Act 2001; or
- b) be entitled to carry out that activity by virtue of Section 4 of the Private Security Industry Act 2001.

### LICENSING ACT 2003 (MANDATORY LICENSING CONDITIONS)( AMENDMENT) ORDER 2014

#### **MANDATORY CONDITIONS**

#### **Condition 1**

- 1. The responsible person must ensure that staff on relevant premises no not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- 2. In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises:
  - a) Games or other activities which require or encourage, or are designed to require or encourage individuals to
    - i. Drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
    - ii. Drink as much alcohol as possible (whether within a time limit or otherwise);
  - b) Provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
  - c) Provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period fo 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;

- d) Selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise antisocial behaviour or to refer to the effects of drunkenness in any favourable manner;
- e) Dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

#### **Condition 2**

The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

#### **Condition 3**

- 1. The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- 2. The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- 3. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either
  - a) A holographic mark, or
  - b) An ultraviolet feature

#### **Condition 4**

The responsible person must ensure that -

- a) Where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures
  - i. Beer or cider: ½ pint;
  - ii. Gin, rum, vodka or whisky: 25ml or 35ml; and
  - iii. Still wine in a glass: 125ml;
- b) These measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- c) Where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

#### The Licensing Act 2003 (Mandatory Licensing Conditions) Order 2014

- 1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2. For the purposes of the condition set out in paragraph 1
  - a) 'duty' is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
  - b) 'permitted price' is the price found by applying the formula—

$$P = D + (D \times V)$$

Where —

- i. P is the permitted price,
- ii. D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and

- iii. V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- c) 'relevant person' means, in relation to premises in respect of which there is in force a premises licence
  - i. the holder of the premises licence,
  - ii. the designated premises supervisor (if any) in respect of such a licence, or iii. the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- d) 'relevant person' means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- e) 'valued added tax' means value added tax charged in accordance with the Value Added Tax Act 1994.
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
  - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

#### Annex 3 - Conditions attached after a hearing by the Licensing Authority

#### General

- 1. The premises licence holder shall require the Designated Premises Supervisor, or in his/her absence other responsible person, to keep an "incident/refusals report register" ('the register') in a bound book in which full details of all incidents are recorded. This shall be completed as soon as possible and in any case no later than the close of business on the day of the incident. The time and date when the report was completed, and by whom, is to form part of the entry. The register is to be kept on the premises at all times and shall be produced to a Police or Licensing Officer when requested.
- 2. The DPS or nominated member of staff shall attend Pub Watch meetings and ensure that Pub Watch bans are identified and where possible reasonable steps are taken to ensure that those persons are excluded from the premises.
- 3. All authorised staff shall receive training at the commencement of their employment, commensurate with their duties, so that they have awareness of the licensing law and wider social responsibilities attached to the sale of alcohol and the conditions attached to the licence. Such training shall be recorded in writing and refresher training given every 6 months.

#### Prevention of crime and disorder

- 1. CCTV equipment shall be installed at the premises, with the number of cameras and citing to be agreed, where possible, in agreement with the Police.
- 2. Images to be retained for a minimum period as agreed with the police and made available to a Police or Licensing Officer upon request and as permitted under data protection legislation.
- 3. The CCTV equipment shall be maintained in good working order and continually record during licensable hours and for a period of two hours afterwards.
- 4. A member of staff technically able to operate the CCTV system shall be available during all licensable hours and shall comply with any reasonable request of an authorised officer of the Council or the Police to view any CCTV "footage" that has been recorded. The Premises licence Holder shall ensure that a member of staff shall be technically able to reproduce CCTV images into a removable format and that such format shall be produced within 24 hours following a request from an authorised officer of the Council or the Police, where such request does not breach data protection legislation.
- 5. The correct time and date shall be generated onto both the recording and real time image screen of the CCTV.
- 6. A minimum of 2 SIA door supervisors are to be employed every Friday, Saturday night and Sunday between 20:00 hours and the close of the premises to the public. At all other times that regulated entertainment is provided, the need to employ door supervisors will be risk assessed by the DPS/manager and the number of door supervisors identified as being required shall be employed for the time required by the risk assessment.
- 7. The premises licence holder shall ensure that where the door supervisors are employed at the premises, they enter in a bound register kept for that purpose their full name, badge number, (including expiry date), the time they commenced their duty and the time they completed their duty, immediately after doing so. This register shall be kept at the premises at all times and made available to a police or licensing officer immediately on requirement. Particulars of duties covering a minimum period of 31 days prior to the requirement shall be available.
- 8. The premises licence holder shall ensure that all door supervisors employed at the premises wear a current identification badge, issued by the Security Industry Authority, in a conspicuous position to the front of their upper body.

### **Public Safety**

- 1. The premises licence holder shall ensure that all drinking glasses used within the premises are of the polycarbonate type or toughened or safety glass to the appropriate safety standard, in that they shall not produce sharp shards when broken.
- 2. The Premises licence holder shall provide training for all staff to ensure that they are familiar with all means of ingress and egress and the appropriate procedures in case of any emergencies that require an immediate evacuation of the premises.

### Prevention of public nuisance

- Recorded music shall be played at a reasonable level so that does not disturb any neighbouring residents.
- 2. For the final 30 minutes of any Dj set due to terminate after midnight, the music levels are to be audibly reduced to affect a 'winding down' period. At the end of their set, Djs to remind customers to leave quietly. The manager on any evening when a Dj is scheduled to play will notify the Dj of this requirement prior to the start of his set and will ensure that the volume is reduced for the required 30 minute winding down period.
- 3. No speaker for amplification of music or speech shall be placed on the outside of the premises, with the exception of the annual Nantwich Jazz Festival and Nantwich Folk Festival.
- 4. Except for access and egress all external doors and windows to the front bar shall be kept closed whilst regulated entertainment if being performed at the premises
- 5. Noise Limiters
  - A noise limiting device shall be used in relation to all sound amplification equipment used in conjunction with the premises licence.
    - a) The noise limiting device shall be installed and set at a level approved by the Council through an authorised officer of the Pollution Control Team.
    - b) The noise limiting device shall be properly secured so that this can not be tampered with.
    - c) The noise limiting device shall only be reset with the authority of the Council through an authorised officer of the Pollution Control Team. If deemed necessary, the noise limiting device shall be reset to a level approved by the Council through an authorised officer of the Pollution Control Team within 14 days of notification.
- 6. No nuisance shall be caused by vibrations transmitted through the structure of the premises
- 7. The outdoor area at the rear of the premises shall not be used by customers after 23.30 hours except for the designated smoking area. After 23.30 hours, no more than 20 customers may use this area at any one time.
- 8. There shall be no consumption of beverages at the front of the premises after midnight.
- 9. Customers will not be permitted to congregate outside the front of the premises after midnight. Customers going outside to smoke will be asked to smoke in the designated smoking area to the back of the premises.
- 10. The premises supervisor, manager or other competent person shall manage the outdoor area to ensure that customers do not behave in a noisy, rowdy or offensive manner.
- 11. Clear notices must be displayed at the prominent points in all outdoor areas informing customers to respect the needs of local residents and behave in a quiet and orderly manner.
- 12. A dispersal policy ('the policy') shall be drawn up and implemented at the premises to ensure that customers leave the premises quickly and quietly at the end of the night. When door staff are employed, there will be responsible, along with the manager, for implementation of the policy.
- 13. Windows and doors at the rear of the premises to be closed after 20:00 hours each evening

- 14. Activities relating to the placing of refuse, bottles and recyclable material into external receptacles shall only take place between 09.00 hours and 20.00 hours.
- 15. A complaints book shall be kept at the premises and any complaints received from members of the public will be recorded in it. As a minimum, the record will contain the date, time and nature of the complaint, along with the names of the complainant (if known), the person making the record and any action taken.
- 16. The licence holder shall ensure that adequate measures are in place to remove litter or waste arising from their customers and to prevent such litter from accumulating in the immediate vicinity of their premises. In particular, where necessary the premises licence holder shall ensure that adequate measures are in place to provide customers with sufficient receptacles for the depositing of waste materials such as etc.
- 17. Notices shall be displayed at all exits to the premises reminding customers to respect the premises' neighbours and leave quietly.

#### Protection of children from harm

- 1. All children must be accompanied and supervised by an adult.
- 2. Children shall not be permitted on the premises after 21:00 hrs unless attending a pre-booked function or table meal, in which case children can stay until the function ends or the meal is finished.
- 3. All staff to be trained in the prevention of under age sales to a level commensurate with their duties. All such training to be updated as necessary, for instance when legislation changes, and should include training on how to deal with difficult customers. The training should be clearly documented and signed and dated by both the trainer and the member of staff receiving it. The documentation shall be available for inspection on request by an authorised officer of the Licensing Authority or police.
- 4. An approved proof of age scheme shall be adopted, implemented and advertised within the premise such as "Challenge 21" whereby an accepted form of photographic identification shall be requested before any alcohol is sold to any person who appears to be under 21 years of age. Acceptable proof of age shall include identification bearing the customers photograph, date of birth and integral holographic mark or security measure. Suitable means of identification would include PASS approved proof of age card, photo-card driving licence and passport.

In addition the disorder and violence reported on 7<sup>th</sup> August suggests issues in relation to the prevention of crime and disorder and public safety licensing objectives that further warrant the review being undertaken.

Dear Licensing Dept,

I passed a lampost with details of the above renewal application.

I feel obliged to strongly object to any relicensing of the premises in its current Form.

I do not use the premises, mainly because it attracts what I would describe as too many 'undesirable individuals'. My observations are that they will serve individuals that have been refused service elsewhere. Either because they have been barred elsewhere or simply because they have been refused service at other premises due to them having been identified as having already consumed enough on that day.

I note it is usually the heavy drinkers last stop of the night.

Other licensed premises are doing their job but The White Horse capitalises on people with alcoholic problems. As a local I know who some of them are.

A recent sighting only 2 weeks ago I had was whilst I was having a coffee outside Enzos on a Sunday Afternoon, a man in his 40s was drunk in the street, he is known locally. He was challenging several teenagers to a fight. This proceeded down the side of the Bookshop but was stopped by a passing individual. The drunk man then proceeded to The White Horse (Customers ar Enzos remarked on this in a way that suggested it was atypical "yes hes going to that pub, in he goes") He was clearly served in there as he did not re emerge in the time we were all there.

This was on a peaceful Sunday Afternoon too. I felt embarassed as some Customers at Enzos were Foreign visitors to our town and it gave off such a terrible impression. I was also ( and I am sure others were ) horrified and felt intimidated.

I also know from a young lady I spoke to recently who lives in Love Lane that she witnesses totally unnaceptable behaviour that is intimidating. I am sure if you question those residents in Love Lane ( which you should in case they do not see the notice ) she will be testament to how bad living there is because of the fall out from these premises.

It should not be the case people are frightened in their homes in our lovely Town.

I noticed broken glass outside those cottages in Love Lane only last Friday and I thought of her.

I also feel if people want to drink heavily to loud music to the early hours, the middle of the Town is not the right place. It is difficult and expensive to Police when they leave as well as increasing shopkeepers Insurance from glass payne damage which is so unfair to them as they are the heart of our Town.

The White Horse is a music venue that should be out of Town but that aside, they let down our Town and other licensees in the way they trade..

The licence should not be renewed.

We have lived at the above address for the last 15 years and during that time have had plenty of issues with the White Horse. A lot of the problems stem from the incredibly loud noise level at which their music is played. This has been reported by myself on several occasions and we have also taken it on myself to speak directly to them. We have also on several occasions spoken to Tracy Billington ( who has always been most helpful) at Cheshire East Licencing on a Monday am, complaining about the drunks coming out of The White Horse.

I am going to concentrate on what affects us the most and this is by far the licence that they have until 2am on a Monday morning. Just about every Monday morning from 2.10am to 2.40am the screaming, shouting and quite often fighting can be heard from the people vacating The White Horse. Both men and women are generally not just drunk but blind drunk!!!

For example:-

18th September - it started earlier than usual at 1.25am - 4 girls having just left The White Horse were trying to 'kill' each other whilst screaming their heads off!!!

5th June 2017 - police incident number 85 - 2.30am. Fighting, screaming outside my property, having all come from The White Horse

26th June 2017 – police incident number 72 – 2.40am. All hell kicking off outside my property – again punters of The White Horse.

They have proven themselves on many fronts that they are not responsible enough to hold a licence until 2am on a Monday morning – no other pub in Nantwich has.

Please make this an 11pm Sunday licence as give us – the residents – of which more are living in central Nantwich – at least a bit of peace in the early hours of Monday morning in readiness for their busy working day ahead. Surely this must be a basic human right????

Dear Sir or Madam

I am writing to provide information that I feel may be of relevance to the Licensing review of the White Horse Pub, located at 22 Pillory Street, Nantwich. I am aware that the pub has received a constant complaint from a local resident in relation to noise on a Sunday night.

The White Horse opens as a 'workers bar' on a Sunday evening allowing for people who work in the hospitality industry, (who are usually all working Friday & Saturdays), to meet friends and other colleagues for a drink, catch up and usually a rest after a week's work.

Since the complaint first arose a number of measures have been implemented by the pub that are clearly obvious even to myself as an occasional customer there. I believe some of these measures to try to reduce noise have had a negative effect on the customer enjoyment of the venue and have actually at times put people off going there. This shows that their commitment to ensuring this night continues and that noise is reduced is more important to them than simply making money. Some of these I have noticed are as listed:

- Windows have all been closed shut on nights in the summer this made the pub unbearable with heat and in effect lost them custom as was simply too hot for people to want to stay there.
- No drinks allowed outside when smoking
- No more than 10 people outside smoking at one point
- No one allowed outside the front of the venue
- Non-smakers asked to go back inside if in the smoking area
- Extra member of door staff to help ensure anyone outside smoking or leaving is doing so quietly
- Bar manager outside 90% of the night also to help assist ensuring everyone is quiet

In my professional opinion, a lot has changed at this venue over recent months and the noise outside is almost non-existent during the pubs opening times in the evening and also once it has closed and people are dispersing. The bar manager and door staff are also still present after the pub itself is closed ensuring people leave quietly, to the extent of following people down the street to ensure no disturbance is caused to the rest of the town.

I hope this information from an independent source may help to clarify that an effort has been made and actions are constantly in effect at this venue to ensure noise is kept to a minimum and that these actions are working.

I am writing to you after hearing that there is a complaint from a local resident in relation to noise on a Sunday night at the White Horse pub in Nantwich.

I live at the White Horse is my second closest pub, after the Railway pub.

I frequently visit the White Horse on a Sunday with my partner who also works in the local hospitality industry. As she works most Friday and Saturdays it is one of the few chances we get to spend together in an average week and The White Horse provides a great atmosphere for us to enjoy a night out together. As there are quite a few other people from the local hospitality industry there on a Sunday I find that the customers are respectful to their friends in front and behind the bar and not overly loud or antisocial.

I am aware of some of the measures taken to reduce noise for local residents over the last year. These include ensuring all windows and doors stay shut, only smokers allowed outside with no more than 10 at a time, door staff and management constantly policing this in and outside of the building, and doing everything they can to ensure people leave quietly at the end of the night.

I am a smoker and not a fan of having to stand in a queue to go outside, especially when all the windows are closed making the pub hotter, I accept this (as many others do) because I realise that we have to respect the local residents noise pollution and the pub's licensing laws.

I was saddened to hear that despite the pub setting these conditions and my abidance of them that there was still a complaint being made, which led me to write this letter. It is my opinion (as a local resident) that the noise has dramatically reduced over the last year and the management of the conditions and customers is noticeably more organised and effective.

It is apparent that The White Horse has a steady stream of customers even on a Sunday and that the pub should not mean that it should be made a victim of it's own success, which is to be a place for social gathering where I enjoy a drink on Sunday nights.

I hope that you can consider my letter in any future review as it seems to me that the White Horse has done their bit to protect their neighbours.

Further to your notice to review the application for the above premise I hereby wish to formally lodge mine and my neighbours' representation against the renewing of this licence.

I write as a local resident and on behalf of my neighbour and wish this correspondence to be received as two objections.

We write as one and I have full support from in the content of this letter.

As local residents of Nantwich Town centre, we are constantly disrupted by the noise coming from various licenced premises. In particular we have the Studio on a Tuesday, Friday and Saturday and despite our objections, you have also just granted a licence to another licenced premise within the Studio, namely Craft Ale.

However, this objection is in relation to the White Horse and the disturbance we have on a weekly basis from the fact that they are allowed to operate a 'late' licence on a Sunday evening. Most of us have day jobs and are professional individuals, working hard to be honest and good citizens, however this is jeopardised in the fact that every Sunday night, into the early hours of Monday morning we are disturbed and disrupted by anti-social behaviour.

It is absolutely unacceptable that gangs of people shout and scream throughout the town centre at ungodly hours, just because they have had several drinks in the White Horse – we know it is the White Horse, because they have this so called 'late licence'.

I live in a first floor apartment, and have had people hanging around underneath my apartment, in the overhang of the shops below me, god only knows what they are doing. They are extremely noisy, I have to get up in the morning (usually with only about 4 hours sleep once they have moved on). We are also aware that they are smoking in the overhang, and my other neighbour said that he challenged them a while ago and found them to be smoking something 'strange'!!

Why on earth does a small market Town need another drinking licence on a Sunday night for goodness sake? This is only appealing to a minority of clientele, and probably not the ones who are hard working on a Monday morning.

These loud, foul mouthed people run through the Town centre, shouting and screaming, and I can hear them kicking things over, no doubt causing all sorts of damage. And then on Monday mornings on my way to work there is usually a shop alarm going off because someone had banged into the glass, Holland & Barratt have had their window shattered several times, and there is litter all over the town square.

There are several residential properties surrounding the White Horse both at the front and the rear, and we all have to suffer for their client base.

It is unacceptable that the Council would even consider granting this licence.

As a frequenter of the venue on their Sunday evenings, which myself and the team use for a winding down period after a long weekend of trading and no social time at all, I have seen a number of measures taken which is impressive and inspiring, which include the following:

- Increased policing of the front area from the door staff to ensure customers entering and leaving the premises are respectful of neighbours
- Employment of additional staff to ensure the outside area is kept quiet and minimal (regardless of summer nights when trade is crucial to sustaining a business)
- A 10 person cap on smoking out of the rear of the building pat a specific time




I was made aware that the White Horse Pub on Pillory Street is up for review and would like to offer my thoughts on the matter. Hive on \_\_\_\_\_\_, my property backs onto the White Horse. In the time I have lived in \_\_\_\_\_\_ I have heard very little in the way of noise, both from the pub "itself, and from enstomers leaving there. I am aware that they have live music nights, but they have clearly made sure to check whether it is too loud before they start playing as I do not hear it. There is very little trouble down our end of town, far less than the rest of town. The staff are polite and courteous, and from experience, will ask people to keep the noise down as they are leaving and to respect the surrounding residents. Some people choose not to listen, but for the most part, they do.

Sunday nights have never been an issue for mc. I am aware that they offer discount to those in hospitality, but it isn't that much of a difference to their normal pricing. I think maybe 20p a pint? I don't hear people screaming as they leave, I don't hear the music. I don't hear much besides traffic and the occasional conversation. It's just people talking as they go home as far as I can tell. I don't know how it is a "public nuisance by allowing people to congregate outside of the premises and demonstrating anti-social behaviour into the early hours" when they won't even let you smoke out the front after midnight. You have to queue to use the smoking area out the back. If it was a public nuisance, surely I would know about it, given my close proximity to the pub...
