**CHESHIRE EAST COUNCIL****Procedure for Hearings – Licensing Act 2003  
COVID-19**

This procedure has been drawn up to take account of the restrictions placed on the Country by the Government in its response to the COVID-19 pandemic and the Council's move towards the holding of virtual meetings.

As a Licensing Authority we are conscious that all Hearings of this nature must be run in accordance with the rules of natural justice and that any modifications to the format of the hearing should not undermine the requirements to hold a fair hearing.

It is the Council's intention to run the Hearing as close a possible to our procedure for Hearings set out in our Statement of Licensing Policy. However, it will be necessary to make a number of specific alterations.

The Council does not intend to hold any Hearings just on the pre Hearing papers (eg applications and written representations). The Council considers that a Licensing determination based solely on written material and without the opportunity for amplification, clarification, and questions does not best serve the decision-making process.

**The Licensing Committee**

The full Licensing Committee consists of fifteen elected Members of the Council. From this full Committee will be drawn sub-committees of three members to deal with licensing functions under the Licensing Act 2003. The Chairman and Vice Chairman of the Licensing Committee shall have the discretion to refer a matter up to a hearing of the full Licensing Committee.

**Platform**

The Council will use Microsoft Teams for all Hearings. This platform can be accessed on a landline, mobile, laptop or tablet. The Democratic Services Officers will ensure that the meeting is set up within the Microsoft Teams platform. All parties to the Hearing will received the Notice of Hearing required by the regulations and an email invitation with specific joining instructions for Microsoft Teams.

**Web Casting**

All Council meetings are web cast through the Council's website. This will continue to be the case during any lockdown period and will allow members of the public to listen to proceedings from their own home.

### **Connectivity Test**

The Council will require Members, officers, and all parties to the Hearing to be available for a connectivity test 30 minutes before the start of the Hearing. This is to ensure that any issues can be identified and overcome before the start of the meeting. Notes on how this test will be conducted will be sent directly to parties.

### **Technical Issues**

If during the course of the meeting, the Chairman determines any technical issues (for example, parties dropping out of the meeting or parties being unable to hear or follow proceedings etc) are compromising the integrity of the Hearing, the Chairman will have discretion to adjourn the matter to later date. The test the Chairman will use when considering any adjournment is what is best in the public interest (including the right of all parties to have a fair hearing). Any adjournment will either be to a date when technical issues can be overcome or to a date when a full hearing with all parties physically present can be held.

### **Etiquette**

In order to maximise effectiveness of the Hearing all parties should:

- Identify themselves at the start of the Hearing when asked to do so by the Chairman
- Put their webcam and microphone on mute all times other than when addressing the Committee
- Indicate that you want to speak by using the chat function
- Only address the Committee when called to do so by the Chairman

### **Committee Reports**

The Committee report and all relevant information will be posted on the Council's website at least 7 days prior to the Hearing. A link to the documents will be provided with the Notice of Hearing. The Committee report pack will be paginated and all parties should refer to this pack rather than their own bundles.

### **Late Evidence**

Parties should submit any evidence for consideration of the Committee prior to the drawing up of the Committee agenda packs. This will mean that all information in containing in one paginated bundle that can be referred to by the parties (referencing pages numbers).

Evidence submitted on the day of the hearing can only be included when all parties to the hearing agree. It will ultimately be for the members of the Committee to decide if late evidence is accepted.



## Decisions

In accordance with Hearings Regulations the Committee will make a determination at the end of the Hearing and the decision will be given within 5 working days. Some decisions are required to be given at the end of the Hearing, in this case the public meeting will resume once Members have deliberated and formed their decision.

## Officers at Hearings

- **The Committee Officer** introduces all parties and records the proceedings
- **The Legal Adviser** provides independent advice to the Members on legal matters and procedure and will draw up the decision notice.
- **The Licensing Officer** will introduce the matter and outline the application; the officer will also answer any questions Members may have.

## PROCEDURE

NOTE: If the Sub-Committee has not already elected a Chairman, that will be the first item of business.

1	<b>Chairman</b>	The Chairman will: (i) call the matter to be considered (ii) call for any declarations of interest (iii) ask all parties to introduce themselves (iv) summarise the procedure to be followed at the hearing (v) will consider any request made by a party for another person to appear at the hearing (v) will advise the parties of any maximum period of time in which it has to present its case (if a maximum is imposed this shall be equal for all parties)
2	<b>Licensing Officer</b>	Will introduce and summarise the application, highlighting areas of contention or dispute.
3	<b>Committee Members</b>	May ask questions of the Licensing Officer
4	<b>Applicant</b>	Will present his/her case, calling witnesses, as appropriate.  <i>(If necessary, applicant will produce any notices required by law. Legal Adviser will draw attention to this if required.)</i>
5	<b>Responsible Authorities</b>  <b>(who have made representations)</b>	Each in turn may ask <u>questions</u> of the applicant, by way of clarification.

6	<b>Other Persons</b> <b>(who have made representations)</b>	To be invited to ask <u>questions</u> of the applicant, by way of clarification.  <i>It is normal practice for a spokesperson only to speak on behalf of a group of residents.</i>
7	<b>Committee Members</b>	Each in turn may ask <u>questions</u> of the applicant.
8	<b>Applicant</b>	May make a <u>statement</u> or ask his witnesses to clarify any matters which he feels are unclear, or may have been misunderstood.
9	<b>Responsible Authorities</b>	Will make their representations.
10	<b>Applicant</b>	Or his representative or witnesses to ask <u>questions</u> of Responsible Authorities represented at the meeting, by way of clarification.
11	<b>Other Persons</b> <b>(who have made representations)</b>	May ask <u>questions</u> of the Responsible Authorities represented at the meeting, by way of clarification.  <b>(Note: This is not the point at which they should be stating their objections.)</b>
12	<b>Committee Members</b>	May ask <u>questions</u> of the Responsible Authorities represented at the meeting
13	<b>Other Persons</b> <b>(who have made representations)</b>	The local residents who are objecting to the application will be invited <b><u>to make observations on the application</u></b> and present the bases of their objections.
15	<b>Applicant</b>	Or his representative or witnesses may ask <u>questions</u> of the Local Residents, by way of clarification.
16	<b>Committee Members</b>	May ask <u>questions</u> of the Local Residents.
17	<b>Chairman</b>	To invite both <b>Responsible Authorities</b> and <b>Local Residents</b> to make their closing addresses.
18	<b>Applicant</b>	Or his representative will <u>briefly summarise the application</u> and comment on the observations and any suggested conditions.
19	<b>Close of Public Meeting</b>	When the Chairman determines that all relevant information has been heard and no further matters are to be discussed, the public meeting will end. All parties to the hearing (including

		Licensing Officers and Responsible Authorities) will be excluded from the platform.
19	<b>Committee</b>	<p><u>Will retire</u> to consider the application. They will be accompanied by their Legal Advisor and the Democratic Services Officer. This means that the Members of the Committee can determine the matter in private session. And can take the opportunity to seek legal advice.</p> <p>Members will give their decision with 5 working days by the issuing of a decision notice.</p>

### **Notes**

1. The Committee can exclude members of the press and public from participation in a Hearing; any such decision will be taken on the basis that the public interest in doing so outweighs the public interest in the hearing, or that part of the hearing taking place in public.
2. The Chairman may require any person behaving in a disruptive manner to be excluded from the Hearing and may (a) refuse to permit that person to return, or (b) permit him/her to return only on such conditions as the authority may specify, but any such person may submit in writing any information which they would have been entitled to provide orally if they had not been required to leave.
3. Prior to the Hearing each party shall have given notification and served documentation (eg statements of witnesses or reports of experts) as required. Late representations and evidence will only be considered with the agreement of all parties.
4. Anyone entitled to be heard may be represented by any person, whether or not that person is legally qualified.
5. Hearsay will be permitted but the Sub-Committee will be reminded to give it appropriate weight.
6. Due note shall be taken of the provisions of the Hearings Regulations 2005.
7. The Chairman may, in the interests of expediency or convenience of the parties, vary the procedure from time to time, provided notice is given to the parties and the rules of natural justice are observed.

### **Summary of Procedure**

1. Chairman appointed (if this has not been done previously).
2. Chairman to call for declarations of interest and request that all parties introduce themselves.
3. Chairman summarises the procedure for the hearing
4. The Licensing Officer summarises the application
5. Applicant to present his/her case.
6. Applicant to be questioned by all parties (to clarify points only) following which, he/she can clarify any other matters which he/she feels may have been misunderstood when the application was presented.
7. Applicant to be questioned by the Committee.
8. Responsible Authorities to make their representations following which they can be questioned by all parties by way of clarification.
9. Other Persons will be invited to present the bases of their objections, following which they can be questioned by all parties by way of clarification.
10. The applicant will be invited to sum up his/her case
11. Committee/Sub-Committee withdraws to make its decision
12. Committee/Sub-Committee will provide its decision in writing

### 1. Report Summary

- 1.1. The report provides details of an application for a variation to the Premises Licence under section 34 of the Licensing Act 2003 and outlines the evidence presented by the parties in relation to the variation.

### 2. Recommendations

- 2.1. The Licensing Act Sub-Committee is requested to determine the application for a variation of the Premises Licence by Marston's PLC, in respect of:

Eight Farmers  
104 Parkers Road  
Leighton  
Cheshire  
CW1 4PY

- 2.2. The Licensing Act Sub-Committee is requested to consider the variation application and any relevant representations and determine what steps, if any, it considers are appropriate to promote the Licensing Objectives.
- 2.3. Acting in the capacity of the Licensing Authority, Members must seek to promote the Licensing Objectives and where Members consider that

matters have engaged one or more of the Objectives, they may exercise their discretion. The Licensing Objectives are:

- a) The prevention of crime and disorder;
- b) Public Safety;
- c) The prevention of public nuisance;
- d) The protection of children from harm.

2.4. Members of the Licensing Sub-Committee are reminded that they may not exercise discretion in any case, merely because it considers it desirable to do so. Careful consideration should be given to the application and the evidence presented by the parties in relation to the review.

2.5. Finally, Members are also reminded that in determining the application, consideration also needs to be given to:

- a) The rules of natural justice;
- b) The provisions of the Human Rights Act 1998.

### **3. Reasons for Recommendations**

3.1. The Licensing Act Sub-Committee has the power to determine this application in accordance with the provisions of the Licensing Act 2003 and the Council's Constitution, and provide the key reasons why the recommendation/s has been made. ### **5. Background**

5.1. The completed application by Marston's PLC was received by the Licensing Authority on the 16<sup>th</sup> July 2020 and sent out for consultation on the 16<sup>th</sup> July 2020. The application is to vary a Premises Licence under section 34 of the Licensing Act 2003.

5.2. The operating schedule indicates that the relevant licensable activities to be altered are:

- Supply of alcohol;
- Late night refreshment.

In addition to the alterations to the licensable activities, the application looks to alter the licensable area which is set out in **Appendix 1**.

5.3. The hours applied for are as followed:

- Late Night Refreshment - Indoors  
Monday to Thursday - 23:00 to 00:30;  
Friday to Saturday - 23:00 to 01:30;  
Sunday - 23:00 to 00:30.
- Sale and Supply of Alcohol - On and Off the Premises  
Monday to Thursday - 10:00 to 00:00;  
Friday to Saturday - 10:00 to 01:00;  
Sunday - 11:00 to 00:00.

**Proposed hours**

- Late Night Refreshment - Indoors  
Monday to Thursday - 23:00 to 00:30;  
Friday to Saturday 23:00 to 01:30;  
Sunday - 23:00 to 00:30.
- Late Night Refreshment - External Area  
Monday to Sunday 23:00 to 23:30
- Sale and Supply of Alcohol - On and Off the Premises  
Monday to Thursday - 10:00 to 00:00;  
Friday to Saturday - 10:00 to 01:00;  
Sunday - 11:00 to 00:00.
- Sale and Supply of Alcohol - External Area  
Monday to Saturday - 10:00 to 22:30;  
Sunday - 11:00 to 22:30.

The full details of the variation to the Premises Licence are set out in the application at **Appendix 1**.

5.4. A copy of the Premises Licence setting out the Premises Licence Holder, Designated Premises Supervisor and conditions etc. is appended to this report at **Appendix 2**.

5.5. Responsible Authorities:

5.5.1. The Council's Environmental Protection team and Cheshire Constabulary have not submitted a representation.

5.6. Other Persons:

5.6.1. The Council has received 19 representations from the public, which are set out at **Appendix 3**.

## **6. Implications of the Recommendations**

and for this purpose the conditions of the licence are modified if any of them is altered or omitted or any new condition is added.

6.1.2. Members are reminded that should any conditions be added, they should be practical, enforceable and appropriate to promote the Licensing Objectives.

Members are also reminded of the statutory obligation placed on the Local Authority under section 17 of the Crime and Disorder Act 1998 to through all of its various functions, and Licensing is one of those functions to do all that it can to prevent Crime and disorder, Anti-social Behaviour, behaviour adversely affecting the environment and re-offending.

Application is made to vary the Premises Licence.

Various applications have been made over the years to vary the licence, the premise is large and seeks with the easing of lockdown to reopen and provide as much space for social distancing as possible for its customers. It also seeks going forward to offer improved the facilities to its customers and the local community.

The premise licence holder seeks to offer the provision of food more widely externally as well as internally. It is also considering following the end of lock down the opportunity to use the extensive car park facilities for Christmas markets/fairs, farmers markets and car boot events during which there may be sales of alcohol externally and possibly the provision of late night refreshment on rare occasions.

Such as Bonfire night and Halloween when people may remain outside for an event but sales of alcohol externally will have ceased.

It is therefore proposed that the external area and carpark area the description of which is identified upon drawing named site plan as the area edged red. The area to interior of the premise remains unchanged.

Application is made in respect of only the sale of alcohol and late night refreshment to the same hours as that permitted under the licence.

Application is made to licence the external area as follows:-

No application is made to amend the licensable activities nor the times in respect of which they operate internally, as a result Boxes A – I, have not been completed save to reference to the lesser hours for the external area.

It is believed this will be a positive enhancement to the premises and will ease congestion within the interior of the premises particularly during the period of transition out of the COVID 19 lockdown and going forward will provide an opportunity for the premises to support the local area and provide different opportunities.

It is therefore believed that no adverse impact will arise in relation to the four licensing objectives. The additional licenced area will be in the main be used as a car park facility. The current restriction requiring closure of the beer garden is to remain and the timing of the end of late night refreshment has been proposed by reference to this.

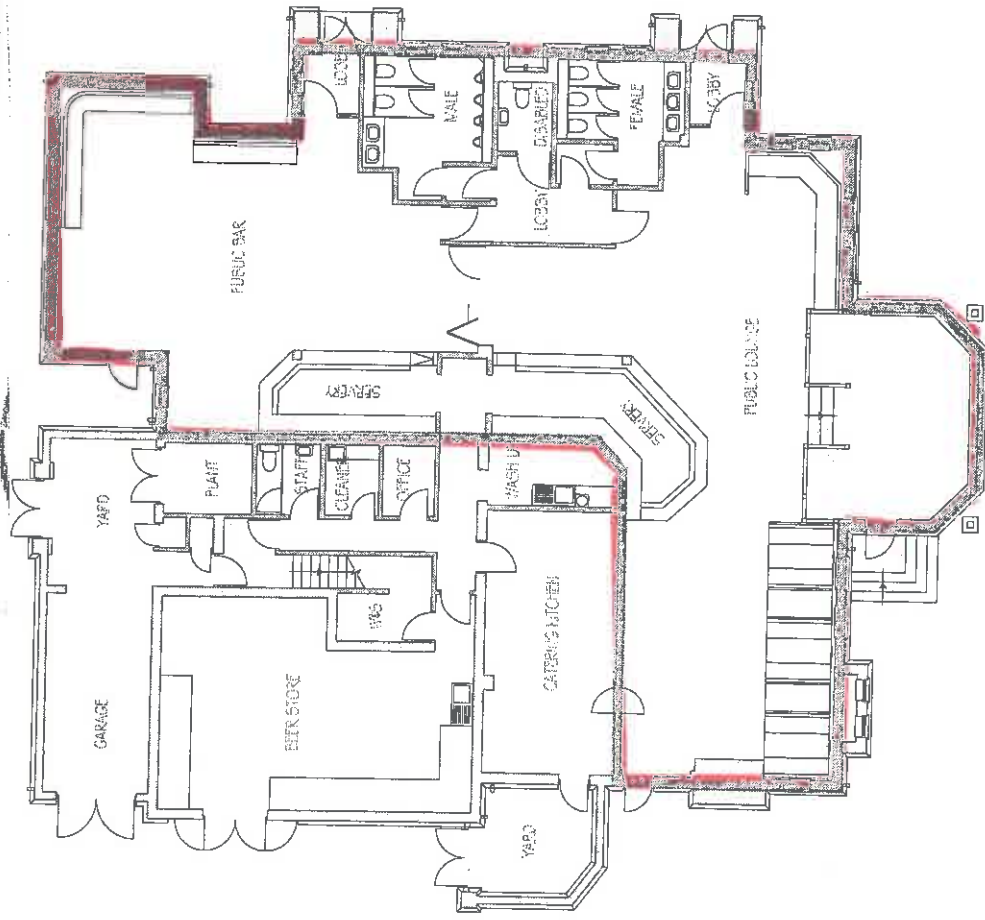
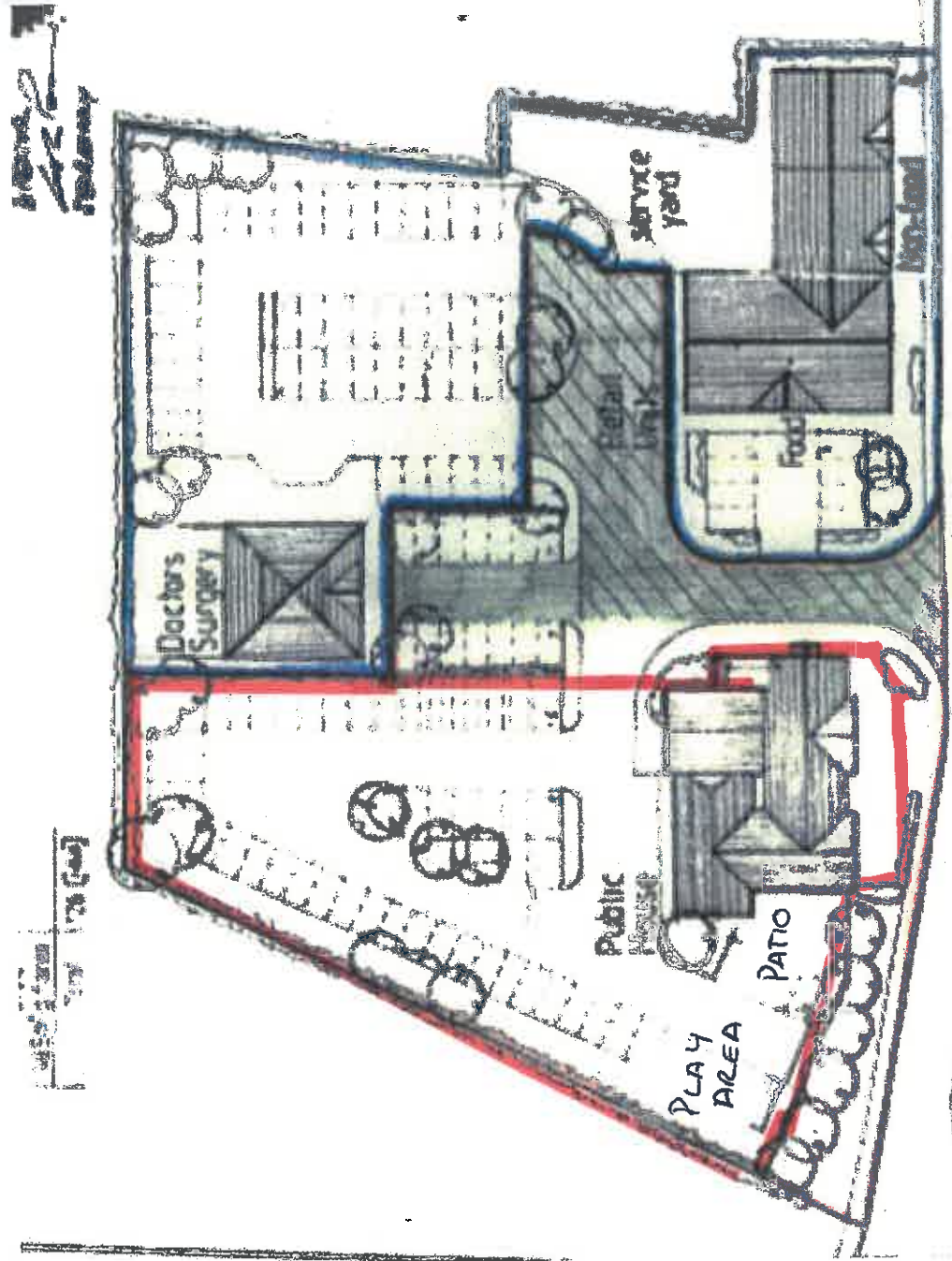

  - iii. Still wine in a glass: 125ml;
- b) These measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- c) Where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

e) 'valued added tax' means value added tax charged in accordance with the Value Added Tax Act 1994.

3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

5. Children under the age of 16 are not permitted to enter or remain on the premises after 22:00 hours unless resident, dining or attending a pre booked function.

**Annex 3 - Conditions attached after a hearing by the licensing authority**

1. No nuisance shall be caused by noise coming from the premises or by vibration transmitted through the structure of the premises.
2. There shall be placed at all exits from the premises, in a place where they can be seen and easily read by the public, notices requiring customers to leave the premises and the area quietly.

I am a [REDACTED] of the 8 farmer's public house, [REDACTED] and have been made aware of an application to extend the time patrons can use the outside facilities.

Whilst I do understand that the business is a commercial enterprise and as such is focused on making a profit, and during the pandemic lockdown this has been difficult. Now the business wants to maximise its assets to increase their profit margin. What they seem to disregard is the fact that their business is located in a mainly residential area and that some of their patrons behave in an antisocial manner. Frequently the behaviour is, loud and abusive with foul language. The pub appears not to take any responsibility for the behaviour of their clientele nor have I seen any evidence of them trying to manage or control it. There have been numerous occasions when the police have been necessary to deal with incidents.

As neighbours we have not complained to the business because we understand that the outside area is important to them in order to continue to trade. However we have been able to do this on the understanding that the noise and disruption will not go on later in the evening. This application seeks to alter that. Surley, whilst it is legitimate for the pub to encourage people to use their facilities, it is also important that those of us who are inconvenienced by how the pub operates have respite from the difficulties their operation of the beer garden and car park area causes.

We have, of course had the unpleasant experience on three occasions of having to deal with the noise created by the fairground. This is an example of sustained noise and disruption that lasts for a week and a half. We can, therefore attest to the view that extending the hours will make life living here very difficult. We believe that this application is, therefore, unreasonable.

There are other problems that we are aware of including people using the premises to sell drugs, regular fights, patrons using my front garden as their personal urinal, and the constant incursion of patrons onto our garden to retrieve a football they have kicked over.

Given all of this we are formally lodging an objection to this planning application.

If the pub cannot control the external activities of their drunken or drugged up customers with the present licence, they certainly won't care about doing so in an enlarged outside serving area. We are not aware of any attempt by the Licencee to control this unacceptable behaviour, This ridiculous idea must be quashed.

As per my email as of 12 August I would like you to accept those comments as my objections for the variation of the license, as well as my comments below.

I believe my husband [REDACTED] has also emailed his thoughts on this matter separately on 12th August.

I appreciate that this variation may appear somewhat beneficial for the community, but would appeal to you to look at how this will effect the local residents, especially noise levels outside which would be for longer periods which is already having a serious affect on so many of us. In particular my vulnerable children. Short term events can come and go, we can live with and appreciate that. But something on a regular basis such as selling drinks outside and making space for more people is not something I can agree to. It will inevitably increase all the issues of noise, more loud swearing and drunken behaviour; likely more drug abuse and selling of close by to our home and the already later than late nights that run way beyond their legal license hours of 1:30am at weekends and 12:30am in the week. This is all often still going on upto 2 -3 hours after the pub should legally be closed. I do not feel a variation should be considered at present when they already cannot stick to the license they have.

There is also previous issues that can be considered produced from the pub having a fun fair in their car park several times a year (again something the local residents have never been informed of). This has produced numerous problems in the past. We've even had gangs who didn't want to pay that came knocking down fences in our cul-de-sac so they could get in for free at the back of the pub! The police were called to help but unfortunately the [REDACTED] of our cul-de-sac passed away due to the upset it caused her. She was taken to hospital that night.

I think there is so much more that needs to be considered here. There are a large number of local residents that live so close by to this pub and many of these changes could and will affect us daily, even more so than we are affected already. I just ask that you please consider us all.

Good morning

I am a local resident who lives very close to this pub and have been affected by certain issues now for a long period of time on and off. However recently these issues have escalated, especially since the lockdown period has ended and pubs have been reopened, these issues have since increased to the point that I filed a police report online on Monday about the weekends events that took place at the Eight Farmers, and was subsequently visited by two officers on Tuesday morning.

Saturday the 9th August was particularly bad, it has been the same for the last few weeks and was often so at weekends and some week nights before the lockdown period began. The general noise level was accompanied by very loud shouting and appalling swearing which could be made out word for word even at a good distance coming from the beer garden of the pub. It started at about 5:30pm and continued to grow louder and worse in nature until it ended at just gone 3am on Sunday 9th. There was definitely one fight diffused and a family left which I viewed from my bedroom window. Fighting in the carpark to the rear is a regular occurrence.

I also know from being able to see the beer garden that there was no adherence to social distancing measures what so ever, and no one was wearing any face coverings that I witnessed. This I find concerning as these are likely members of my local community and have no regard for their safety or others whatsoever. They often then drive home afterwards from 12am onwards spinning off the carpark and racing down parkers road.

There is definitely also an issue with drug taking at the pub in the beer garden, some of my neighbours who back onto the pub have commented on the smell of cannabis coming over into their garden and have been unable to sit out due to it. Several of us have also witnessed drugs being dealt in the cut through at the top of our cul-de-sac (myself included) during pub hours which makes me feel very unsafe. I have while playing out on the kids on their bikes in the cul-de-sac seen strangers stood staring at us menacingly in the gap while exchanging items, my children get very upset and sometimes cry. I would really like this blocked off for safety purposes as it is also used as a stopping point to urinate late at night and also used by so many people who are not resident to the cul-de-sac when there is the main road to use which is exactly the same distance.

Many of us residents have also suffered damage to our properties after the pub closes at 2-3am. I have had my lawn urinated on, glasses thrown on my front lawn, at my house or over my back garden where my children are clearly then placed at risk. Also the moving and breaking of large garden ornaments to the front of the property and breaking christmas ones.

The general noise during normal hours I can live with, that's why i've never bothered complaining in 10 years as a resident although I admit i've often felt like it. But it truly feels like the longer it goes on the worse it is getting and I can see its getting worse still and it's

certainly not just myself and the closest by residents that these issues are affecting, it will be many properties within the local community.

The main issues is the very loud noise outside after 11pm, foul loud swearing, drug use and drunks using the cut through to our cul-de-sac after closing time. These have a huge impact on my family directly and our local community.

Weekends should be for rest but they are becoming more draining than our weekly routine. They find the noise scary and can also now repeat some of the very unpleasant words they heard. My youngest keeps saying 'pissing' as we must have heard that over and over on Saturday night. She has no idea what it means and has never heard it before, I'm truly gutted as she is the most innocent thing you could ever meet.

I have also now heard they want to extend the pub license to include an outdoor bar/food area and alteration of the hours. I have not viewed the paperwork but at present I strongly object to this until some of the existing issues are sorted out.

In early hours of the morning there are many occasions where loud music is being played from cars sat on the car park, there are also people still screaming and shouting way after closing hours.

It's hard to sleep at night because it causes anxiety with the actions people are doing.

I don't feel safe to be around this pub at anytime of day.

On half terms they have a fun fair on the car park The music is incredibly loud, the noise levels due to the screams on the rides is unbearable, people park all around the roads and cul de sac causing issues just to get back home.

There is always trouble once it shuts down for the night with youths staying there to drink.

We have had people once they have left the pub after drinking hours walking back down Parker's road and throw items into our back garden over the fence, this nearly hit myself, there has been occasion it has hit my rabbits cage and scared them and this is not acceptable.

The language which is used by people at the pub is disgusting and unacceptable, we hear them swearing very clearly and we live on an estate which has many young families with small children.

The pub and car park is a constant hive for anti social behavior.

My [REDACTED] attended the pub on the first day of opening after lockdown, they were not asked to provide details when they entered or ordered Incase of the need of track and trace, there was no social distancing happening, people were all stood together propping up the bar drinking and talking. Staff made no effort to try to enforce any sort of social distancing. The police were called as people began to fight and smash glasses and bottles to strike each other with, she felt she had no way to escape and had to jump over the picket fence in order to get away from the chaos.

Therefore I feel that it would not be acceptable to grant the variation as this would cause more distress and upset for the residents in the local area.

This particular venue and its location already attracts some antisocial behaviour, this is especially true since lockdown restrictions have been eased. The language and behaviour over recent weeks is not something I wish my children to see or overhear. In [REDACTED] we can hear everything.  
There is simply no need for this application.

Secondly, changing the external layout to accommodate provision of farmers markets, car boot sales etc etc would result in cars parking along Parkers Road and adjacent roads causing a bottleneck of traffic on an already busy route.

To Whom it may concern.

I am writing to express concern, at the application pushed by The Eight Farmers public house on Parkers Road, Leighton, Crewe for extended licencing hours.

The matter has only been highlighted to residents via the mailbox campaign of Cllr Byron Evans, and although the issue of hosting Car Boot sales etc is not raising concern, allowing later drinking most certainly is.

The Eight Farmers (or to give it its local moniker, The Eight Fighters, to give you insight to the grievance felt by residents in close proximity) plays host to continuously loud patrons, with violence & public drunkenness now sadly the 'Norm'. No respect is paid to those residents living on the boundaries of the Public house, even during the day, when young children playing in their own gardens of their family homes, are exposed to the usual chorus of foul language, and aggression that goes hand in hand with the Pub.

Running up until, and often PAST closing hours, residents are again, forced to endure loud, abusive patrons milling around the public House and the close streets, cars roaring in & out of the car park, and other anti social behaviour.. Allowing later hours, would simply make the residents lives even more of a misery, especially during summer months, when windows have to be closed to avoid the litany of shouting, raucous behaviour and occasional violence. Those considering any extension may do well to think how they would like to endure this at their own homes.

Furthermore, it can be observed at any time, that any supposed 'Social Distancing' is a joke at the premises, this alone should be considered very carefully, as allowing more time for non-observant patrons merely increases risk to themselves, and then by course of action, members of the public who have not even frequented public houses, and increasing strain on NHS & services already stretched thin by the current pandemic. Rather than seeking to extend opening hours, some review should ACTUALLY be undertaken to possibly curb the current opening times, reducing danger to others.

On a personal note, I find asking to remain open later in poor taste given the current worldwide situation, where Public houses & restaurants have only just RE-opened. One wonders why such a request has been made if not for purely financial gain.

This is not the first time residents have acted against plans for the local area, with the new apartment block built next to said Public house going ahead despite very negative support from locals, and indeed, although residents have only moved into these apartments a few weeks ago, as predicted, anti social behaviour has already started

here too!... Please give this thought when considering extending opening hours to a public house to an already troubled spot...

I have received a copy of the application and the map of the pub and external area marked in red of the proposed extension.

I have studied the external plan and it is apparent that this is in no way a current version, as this shows where the doctors surgery was proposed some 20 years.A current view from google earth will confirm some building work, which has now been completed and there are now 12 apartments there occupied, and with corresponding changes to the car park layout.

The current play area within the Eight Farmers is not clearly marked up on the map with the fencing boundary. An issue that perhaps is not required but may be useful as the Annex3 condition is to show where that demarcation is between that and the car park.

In addition I wonder if the surrounding properties should be shown as their location will have a bearing on the outdoor uses the pub wishes to have.

While the current situation has made the numbers of customers that can visit the

internal seating has been reduced, I have reservations that if there was inclement weather, where would the outdoor patrons go if they were eating/drinking. Although not sure that you can eat outside under the current arrangement would have no objection to al fresco, under these arrangements.

There is a wish to sell alcohol externally, by that I understand that an outside bar could be set up, and alcohol taken and drunk while going onto the car park, while special events are taking place. Or even if not can be an interpretation of the application.

the comment that there may be "the provision of late night refreshment on rare occasions" is not a suitable condition.

while i feel that there is ambiguity over the way the following is worded

".....farmers market and car boot sales during which there may be sales of alcohol externally and possibly the provision of late night refreshments on rare occasions"

but a new paragraph follows on and states.

"Such as Bonfire night and Halloween when people may remain outside for an event but sales of alcohol externally will have ceased."

But that means you can go inside , buy the drinks and take them outside onto the car park. ( as Annex 2 would provide for.) The application should i believe be more specific as to how it intends to operate all the type of events it is considering.

Annex2 says that " Children are not permitted to remain on the premises after 22.00hrs. I object to that as i believe it means the car park as well, where the applicant asks for hours to be up to 23.30 on Monday to Sunday. Perhaps conflicting with having some of the late night events outside

Would there have to be a limit on numbers attending events on the new boundary to establish the Fire Risk Assessment. ( Annex 2. point 5)

Overall there are some points I could support but the application is very broad and could leave some ambiguity over the conditions.

I have only just found out about the new application from The 8 Farmers in relation to extending the outdoor area and serving drinks outside.

My [REDACTED] and the pub is already having an adverse impact on the quality of life in the close.

I currently cannot object to this more, for several reasons.

I have already had to recently report the pub to the police and council for -

- Loud noise and swearing during normal hours impacting our standard of living in the close.
- Loud noise, swearing and shouting after hours repeatedly at the weekends till 3am.
- The smell of drugs that comes over the fence and into our gardens
- The drunk patrons getting into cars at 2am to drive home risking their life and others.
- Due to it seems no drink restrictions several fight that breakout each weekend.
- When passing what seems like zero social distancing measures in place endangering the local community.
- Patrons drunk using the cut through at the top of Harris Close as a toilet on the way home and if im not mistaken a pick up point for drugs.

I am aware that I chose to live here and that there will be certain noise from the pub, this is of course acceptable. However, all the above points fall outside how a pub should behave. Its for all the community not just the patrons that frequent it.

I fear that if the pub cannot adhere to current rules and regulations and is having a negative impact on its neighbours then these additional extensions will only further expand the existing issues.

For me the pub already needs to be monitored carefully to ensure minimal impact on the surrounding neighbourhood so these extensions surely cannot be granted till they have these in order as a minimum.

I look forward to your response on this matter and hopefully the declining of this extension at least till things get better.

I refer to the application which I understand is in the process of being made later today. I wish to raise objections to this under the Licensing Act 2003 for the following reasons:

**PREVENTION OF CRIME & DISORDER:**

- several residents have been able to smell drugs into our gardens which has emanated from the Public House car park, where patrons are clearly taking illegal drugs whilst visiting the Public House
- drunk patrons are seen getting into their vehicles at night and driving whilst clearly under the influence
- Police have been called numerous times, it is understood, due to fighting occurring. In fact on the first night the Public House was allowed to re-open after the lockdown, there was a fight which involved a large group of patrons and also it is understood criminal damage occurred to a vehicle parked on the car park. Police were called to this incident.

**PUBLIC SAFETY:**

- the local residents do not feel safe when the Public House is open during "normal hours" let alone if those hours were to be extended. For the last few weekends it has been noted that the Public House has been serving into the early hours as we have been experiencing lots of noise as a result and do not feel safe, especially when regular fights are breaking out and criminal damage.

The patrons often use the "cut through" at the top of Harris Close to walk through and often cause noise or even use as a toilet.

There does not appear to be any regard for "social distancing measures" and in view of the current Covid 19 pandemic, this is also a major concern for local residents.

**PREVENTION OF PUBLIC NUISANCE:**

I understand that numerous residents have already made formal complaints regarding the noise coming from the Public House during the early hours of the morning. This is before any licence extension has been granted. The Landlady/Landlord is clearly not adhering to the current licence conditions, if neighbouring

residents are able to hear such loud noise often until 3am through drunk patrons clearly still consuming alcohol.

I would be most grateful if my representations above could be considered prior to the application for variation taking place. I understand that other local residents have also raised their objections and as stated, several complaints have been made regarding the Public House prior to the knowledge of the application for variation.

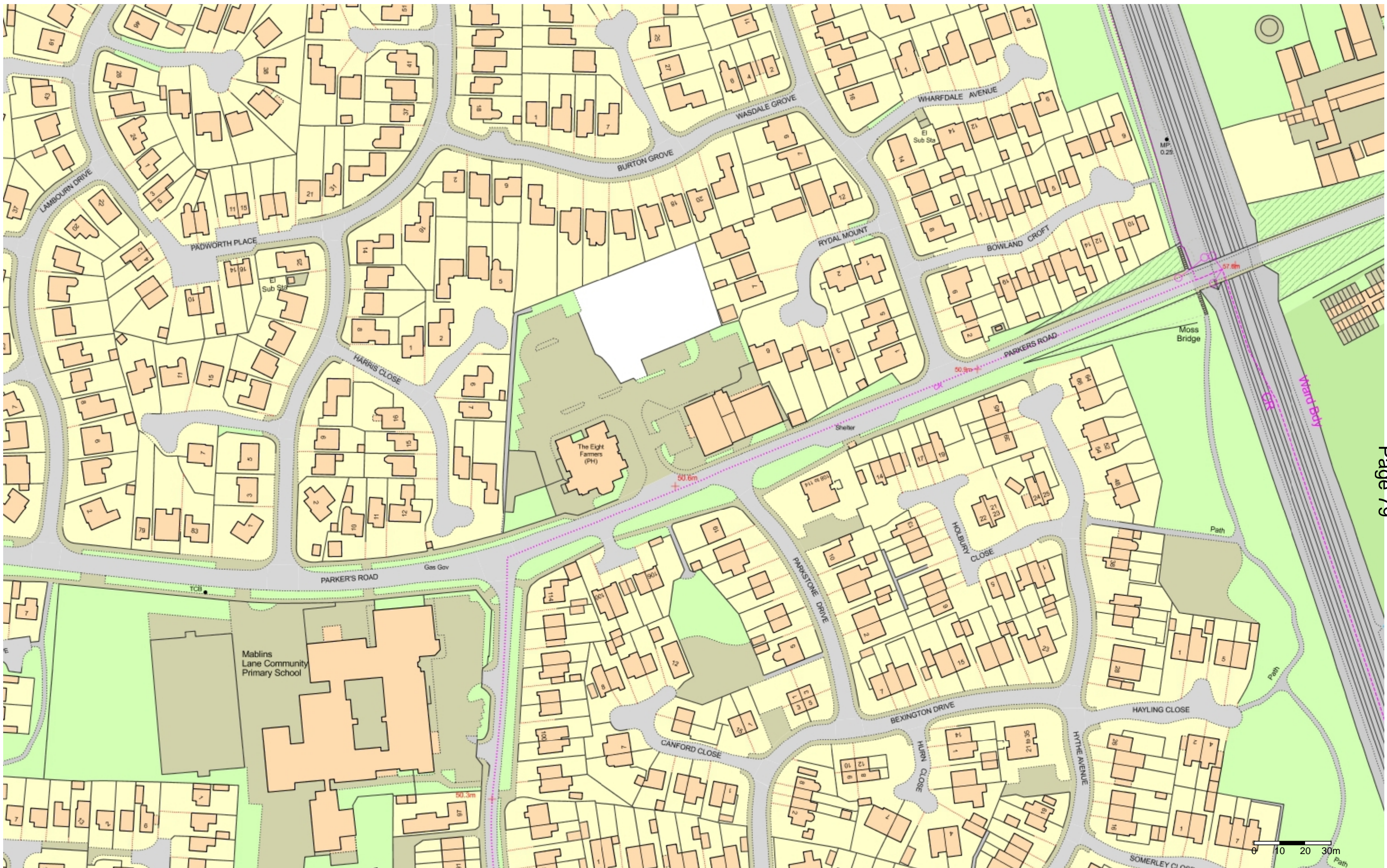
