	<p><b>the following roads will be closed between 09:00 – 22:00 Saturday 30<sup>th</sup> August 2025</b></p> <p><b><u>Wheelock Street</u></b> From the Junction of The Bull Ring to the Junction of Darlington Street</p> <p><b><u>The Bull Ring</u></b> From the Junction of St Michael's Way to the Junction of Wheelock Street</p> <p><b><u>Hightown</u></b> From the Junction of Hightown to the Junction of Queen Street</p> <p><b>the following parking bays will be suspended between 09:00 – 22:00 Saturday 30<sup>th</sup> August 2025</b></p> <p><b><u>Wheelock Street</u></b> From the Junction of The Bull Ring to the Junction of Darlington Street</p> <p><b><u>Hightown</u></b> From the Junction of Hightown to the Junction of Queen Street</p>
<b>Reasons for the Decision and alternatives considered</b>	<p>Section 21 of the Town Police Clauses Act 1847 provides the power to make orders preventing the obstruction of streets "in all times of public processions, rejoicings, or illuminations, and in any case when the streets are thronged or liable to be obstructed."</p> <p>The decision will enable the annual Middlewich Live 2025 to take place in a safe manner and to enable the police and authorised marshals to manage the event.</p> <p>The Police have been consulted in relation to the event and have confirmed that they have no objection to the proposed order.</p>
