Brief Description of Decision	<p>Being satisfied that traffic should be prohibited to facilitate works, to give public notice of and make a temporary road closure order under s14 of the Road Traffic Regulation Act 1984, as amended, and all other enabling powers to prohibit traffic on Moss Lane, Brereton from the junction of Brereton Heath Lane to the junction of Smethwick Lane for a period of 18 months or until the works have been completed, whichever is the sooner.</p>		
Reasons for the Decision and alternatives considered	<p>For cabling works to be carried out by Scottish Power it is necessary to close Moss Lane, Brereton from the junction of Brereton Heath Lane to the junction of Smethwick Lane.</p>		

	<p>The alternative route will be via Holmes Chapel Road, Brereton Heath Lane and vice versa which is considered the most suitable route.</p> <p>It is anticipated that the works will commence on Friday 26 September 2025 and will be completed by Friday 10 October 2025.</p>
