Brief Description of Decision	<p>Being satisfied that traffic should be prohibited to facilitate works, to give public notice of and make a temporary road closure order under s14 of the Road Traffic Regulation Act 1984, as amended, and all other enabling powers to prohibit traffic on Towers Road, Poynton with Worth from the junction of London Road North to Oakmere for a period of 18 months or until the works have been completed, whichever is the sooner.</p>		
Reasons for the Decision and alternatives considered	<p>For gas mains replacement works to be carried out by Cadent Gas it is necessary to close Towers Road, Poynton with Worth from the junction of London Road North to Oakmere.</p>		

	<p>The alternative route will be via London Road North, London Road South, Park Lane, Towers Road and vice versa which is considered the most suitable route.</p> <p>It is anticipated that the works will commence on Monday 1st September 2025 and will be completed by Friday 14th November 2025.</p>
