Permission was granted on 22nd July 2025 to dispose of the former Mountview Care Home subject to Cheshire East Borough Council and entering into a Development Agreement. The terms of the Development Agreement were issued with the further competition invitation to tender. Entry into the Development Agreement will allow the Council to dispose of the former Mountview Care Home and ensure develop specialist housing in accordance with their tender response. Not entering into the Development Agreement would mean that the former Mountview Care Home would not be disposed of or developed in accordance with response. Member N/A consultation and interests declared NO Significant **Decision** Legal The proposed Development Agreement has been drafted by the Council. It is designed to establish a robust legal structure that **Implications** seeks to ensure successful delivery of the scheme in a viable timescale together with an operation of the scheme that is sustainable in the long-term. In addition, the Development Agreement contains standard anti-embarrassment protections for the Council. Entry into the Development Agreement would minimise and mitigate the various risks to the Council in disposing of the site to to an acceptable commercial level. However it would not fully remove the risks which include but are not limited to the risk of delayed or non-delivery of the scheme and the risk of operational failure or change of the scheme at a later date. Further legal implications relevant to this decision are classed as exempt information as defined in Paragraph 3 (Information relating to the financial or business affairs of any particular person (including the authority holding that information)) and Paragraph 5 of Part 1 of Schedule 12A of the Local Government Act 1972 (Information in respect of which a claim to legal professional privilege could be maintained in legal proceedings) and are set out in Appendix A which is not for publication.
