To whom it may/concern,


Please let it be officially noted that as a resident of Wilmslow, I strongly object to the license of the ST lounge on Grove Street being renewed.

Wilmslow is supposed to be a family-orientated town and a sexual entertainment club has no place on the main shopping street, where many families, young children and teenagers pass by each day and evening. Grove Street, our main shopping area, is near several churches, several primary schools and Wilmslow High School, not to mention the Leisure Centre, several churches and the railway station. A sex club is certainly not appropriate to be placed in the same area as these.

I am aware that the lounge only operates late evening, however, many families/teenagers/children are around the town centre 9pm or later because of visiting friends or relatives, travelling from Manchester, going to evening events at the schools or churches, going out to a restaurant, etc and surely these vulnerable groups should not be exposed to a sex club in the middle of the high street?

As a woman, I used to feel safe going into Manchester and coming back later at 11pm or so, happy to safely walk home. I was also happy to walk through Wilmslow at night after giving custom to one of the many restaurants or bars, however, since the opening of this club, I no longer feel safe to go out at night and if I do venture into Manchester, I have to go to the expense of getting a taxi from the station as I no longer feel safe walking home through the centre of Wilmslow when it is full of testosterone-fuelled males visiting this sex establishment. I object to the fact that my safety feels threatened in my own town because of this club.... I have a right to walk safely without fear in my own town. I was under the impression that Wilmslow had a zero-tolerance to the blatant exposure of such a club in the middle of a family community.

We are writing to ask you to deny the renewal of the SEV Licence to Wilmslow's ST Club


We are also concerned about the general future development of Wilmslow; we note that there are also two betting shops in our small town, one in Grove Street and one in Grove Avenue. How can this be the right way forward? The Local Government Association has produced a report that states shops which prey on customers weaknesses such as Strip clubs are blighting economic recovery on the High Streets. There is economic data available, which states the general public are less likely to visit the area with a strip club and they discourage family centred businesses. If the High Street is to survive the threat of the internet and the recession surely we all should be working together to enhance and protect Grove Street.

Economists' projections show that this kind of entertainment leads to the decline of a town. Shouldn't we all be doing our utmost to protect and enhance our town centre?

The premises next to the ST Club have been vacant for over a year; so is the shop opposite vacant. This seems to indicate that the proximity of a lap-dancing club is off-putting to businesses. Who wants to have their business located next to a Fully Nude Strip Club that attracts the Stag Night Trade?

We absolutely believe that the ST Club is in the wrong location, in the heart of the main street of a small town, close to residents, schools, shops and churches; we feel that it is completely out of character in the area. Dear Licensing Authority,

My eldest sister moved to Wilmslow 15 years ago. We have loved visiting her at her retirement apartment, and many happy family celebrations have been held there. I write to tell you that we are most upset that a strip club opened last year, and that is not going out in the evenings and is reconsidering whether she should stay in Wilmslow. She loves her little apartment and has made many friends and used to have an excellent social life, which if I am honest we all envied. We saw Wilmslow as that 'up market' town, the envy of most of people. Surely you cannot allow this deteriation without something of a conscience.

She has told me that an' ST Lounge' applied for a license to Sexually Entertain last year. She heard about this and rang the Council to say she was very worried. She tells me that she was told by someone in your office that she was too late to object, that she should have seen it in the paper. She has since found out that the advert she **"Should have seen" was in the Manchester Evening News the day before New Years Eve**. My sister was away for New year with family, probably just like most of you. We hear such tales of manipulation of the public and burying news at certain times of the year, yet I cannot believe such practice applies and is condoned by Cheshire East. Surely Not.

Also, because she lives in Cheshire she does not buy the Manchester papers. The lady also informed her that the other way to discover if this sort of thing is happening is by reading notices on the front of the strip club. Perhaps you would allow me to ask you all when you last read notices in front of a strip club? My sister says that she does not like looking in the window of strip clubs, probably just like most of you. Apparently she has discovered that the place has reapplied! We all decided to visit and look at this place, we read the notice this time. It is a discreet notice in white in a lovely frame on the front of the place. Shocking, truly shocking, that the vulnerable elderly, as well as local children, attending the school close to this 'place' should be subjected to such places within their vicinity.

I am writing to tell you there must be a mistake. I think planning notices should be brightly coloured to attract attention. Also, I am informed that the neighbours and residents must be informed in order to allow objection. When my friend wanted to make slight changes to her property she had to have a bright blue notice on the lamppost AND the council wrote to her neighbours. I am sure that your Council must have the same policy, particularly as this type of thing has a massive effect on an area, obviously a detrimental one. Surely you write to members of the community to let them know that such a massive change is going to occur? After all Councils write to residents when they want to be elected, they use electoral registers. Why are the residents not informed? Perhaps you would be kind enough to inform me why has not happened?

May I remind you that the application is for "FULLY NUDE LAP DANCES. TABLE DANCES AND STRIP SHOWS" This is Retirement apartment, yards from the bus stop where she used to get off returning from the Bridgewater Hall, and on the pedestrian way to her local shop. Now she says if she has run out of milk in the evening, she does without, probably just like you.

Please look into this as a matter of urgency. I think some one has made a terrible mistake with some rather tragic consequences.

ST Lounge, Grove Street, Wilmslow – SEV Licence Renewal

I am writing to object to the renewal of the above licence and request that you refuse on the grounds that the club is having a detrimental effect on the character of the town centre and on the many small shops and businesses whose continued existence may be put at risk.

Having worked in Wilmslow for nearly 20 years I have witnessed its steady decline and another "shuttered" shop front during normal shopping hours just adds to the general rundown appearance of Grove Street.

But perhaps of more significance are the comments I hear particularly from our female and more elderly patients who refer to their sense of unease and discomfort when passing the Club when it is open in the evenings, often preferring not to walk past it at all. This is surely not conducive to the Council's stated aim "to foster a vibrant, welcoming and accessible town centre".

I do recognise that there is a market for such venues but they should be located where their presence does not have such a negative effect on their immediate business neighbours and on the very character or the town centre. What message does this send out about Wilmslow and its leadership?

I therefore ask that you consider carefully the wider consequences of a decision to renew the licence and to exercise courage to do what is right, not what is easiest.



Dear Councillors,

Re: ST Lounge in Wilmslow's main street

My husband and I are writing to request that you give very serious consideration to refusing to renew the SEV Licence to the St Club in Grove Street, Wilmslow. We ask you to consider in detail the effect the existence of such a club is having on Wilmslow's town centre. We believe that the first licence was granted without the knowledge of most Wilmslow inhabitants, as the original advert was placed just once, in the Manchester Evening News the day before New Year's Eve! Many people, including us, did not object then, as we did not even know that an application had been made.

We consider that a main family shopping area is the wrong location for a lap dancing club. There are many shops catering specially for children close by, so it does not fit in at all with the local businesses. The building itself has become an eyesore; having the shutters down all day makes it look like yet another failed business. The premises next to the ST Club have been vacant for over a year; so is the shop opposite vacant. This seems to indicate that the proximity of a lap-dancing club is off-putting to businesses.

Grove Street is an area used by all the locals, young and old. Saint Teresa's Church is very close by, in Green Lane; the Methodist Church and St Bartholomew's Church are close by, as is the Leisure Centre and Wilmslow Prep School, which is in Grove Avenue. Teenagers from Wilmslow High School often walk through town, after school and the many evening sporting events. The bus stops to Schools, universities and colleges are situated metres away on Green lane. Many thousands of women and children use these services. Nearby, the train station transports a million passengers from the Wilmslow area per year, at all times of the day and night. This is just not the right place to site a fully nude lap dancing/strip club.

We were also very concerned when we heard about the performer who was attacked by a client from the St Lounge, and left injured by the roadside. This client is not the sort of person we want to have wandering around our fairly small town! Why should people be wary or fearful of strolling along their main street at night? The Council should be striving to make the town as safe as possible.

The Wilmslow Vision document, which was endorsed by the Council, wishes to foster "a vibrant, welcoming and accessible town-centre, with a high-quality environment, to draw people into Wilmslow"; it talks of "a community

that is safe and welcoming". The stated purpose of the ST Club is to sexually excite its audience, which seems to be quite at odds with what the Council is seeking to provide for the people of Wilmslow.

According to your policy document on the licensing of SEVs, we understand that "relevant entertainment", even "live strip shows" can be provided for the "financial gain of the organiser". Whilst we accept that such "entertainment" takes place, why does the Council feel that such a venue is acceptable in the main street of a small market town? How can this be justified in our local area?

In your 'Discretionary Grounds for Refusal' of an SEV licence, it is stated that the Sexual Entertainment license is" generally considered inappropriate "where there are schools, places of worship, leisure centres and residential areas. On the Council's own website it says that Wilmslow is a residential town. That means that it is located in an inappropriate area according to the Council's own policy. We would ask you to refuse grant on the grounds that it is "inappropriate to the relevant locality". The policy also states that:

Under s.3.7 of the Council's SEV policy, the Committee "is able to determine the appropriate number of Sexual Entertainment Venues suitable for a locality and is able to determine that the appropriate number for a locality is nil". I would ask the Council to determine that the appropriate number of SEV's in this locality is indeed nil. The fact that the Committee granted the SEV licence for ST Lounge in 2012 should have no bearing on the outcome of the application for renewal. The Committee should consider each application afresh and is entitled to determine on renewal that the grant would be inappropriate having regard to the character of the relevant locality or the use to which any premises in the vicinity are put.

We hope you will refuse to renew the ST Club's licence for its outlet in Wilmslow. To us, it is a travesty of what Wilmslow represents.

As it is such an important issue, we would ask that the matter be dealt with by the full Licensing Committee. Thank you.



I am requesting that you consider seriously this, my letter of complaint and upset at the application for renewal of the SEV licence to the ST Club in Grove Street, Wilmslow. Please consider the following points to be worth noting.

I gather that the application for the licence renewal was "publicly noticed" in the Manchester Evening News last New Year's Eve. Not something widely read by the local resident at that particular date, myself included. This style of behaviour smacks of the underhand.

The ST Club at 16, Grove Street Wilmslow. Cheshire.








Dear Sir/Madam,

We see the ST lounge in Wilmslow has applied to renew their Sexual Entertainment Venue Licence.

We wish to object most strongly on the following grounds:

Grove Street is not a suitable location for this type of business. It is the main pedestrian thoroughfare in Wilmslow; linking schools, churches, public transport, the leisure centre, the library, the 'Carrs', retail outlets and residential areas. It is vital to the town that everyone should feel comfortable using this route at all times of the day.

In addition the club has not adhered to its all its license conditions; namely condition 10, agreeing not to solicit for business. Some months ago, whilst walking past the ST lounge I () was handed a very graphic business card promoting their trade.

We understand the ST Lounge has signed the Archangel Agreement, promoting responsible drinking. Yet despite prompting from the Senior Enforcement Officer (Licensing) to remove the offer, 'shots from a pound' are still being promoted on their website.



When I have been to the theatre or leisure centre, to watch a show at my grandson's school or sporting event we often walk home together down Grove street.

Last summer, I noticed a thick set man standing on his own outside with his arms folded. I felt threatened by his presence. I was curious because there was a purple light coming from the front of a shop. Imagine my horror when I realized that a group of men in front of us were going into a strip club on Grove Street! I clutched my boy's hand and we swerved to avoid them.

Surely this type of entertainment should not be on the pedestrianized area where the over 60's and children walk home from the leisure centre or just between homes. I now will not walk down Grove Street after5p.m.or when it is dark .Nor will I let my grandson and his friends-honestly it upsets me and makes me feel uncomfortable and unsafe.

I feel strongly that this type of "entertainment" should not be situated in a family area next to family shops. In Manchester, I believe they are situated down side streets and in down-market areas. Dear Sir/Madam,

I wish to register my objections to the application for an SEV licence for the above premises.

The grounds of my objections are as follows:

The ST Lounge is within a residential area.

There are many residences within a short distance of the club, in Grove Avenue, in Green Lane and in Hawthorn Lane. Water Lane, with many residential roads off, is close, too.

The lounge is near to schools, nurseries and the Leisure Centre.

Grove Street, a pedestrianised area, is probably the most focal part of the town. During term-time, the lounge is passed many times a day, by children making their way to schools and nurseries, such as Wilmslow Prep, Wilmslow High, the nursery near Ten Little Monkeys, the Leisure Centre, which is used regularly by children.


The ST Lounge is near parks and other recreational areas used by children.

Although it is not a designated recreational area, Grove Street is an area where people sit, on the many benches provided, outside the many cafes located there and it is an area where youngsters meet and stay late into the evening. In addition, many children pass the lounge on the way to access facilities in the Carrs.

The ST Lounge is situated near churches.

The lounge is probably less than 100 yards from St Teresa's Church, and maybe 200 yards to St Bartholomew's and to Wilmslow Methodist Church. Why should parishioners have to pass the lounge on their way to worship? Grove Street provides the most direct route and the safest route, as it is pedestrianised.

For years, residents have been concerned about anti-social behavior that emanates from the existing licensed premises in the town centre. Surely the fact that the ST Lounge is open until very late will encourage excessive alcohol intake? This, added to the fact that the purpose of the club is to "sexually stimulate" its customers, could cause real problems as far as the level of crime and anti-social behaviour is concerned!





I object to the renewal of the licence for the lap dancing club in Wilmslow; many residents of Wilmslow were unaware of the club's application last December and, as a result, were unable to make their views known but, hopefully, now, they will speak up!

This building is in the heart of our town; everyone passes it on the way to work, nursery or school or to go to the shops. Grove Street is the hub of the town. We have seen Scottish dancing here, we have the artisan market here every month, the Rotary Club collects here at Christmas time, with Santa's sleigh and carols. The street is full of regular shops selling shoes, clothes, jewellery, chocolates, phones, books, sportswear, there are banks and charity shops, restaurants and coffee shops, gift shops, hairdressers, all of which have nothing in common at all with a sex venue! It is inappropriately situated.

The venue is about 100 yards from two residential streets, Grove Avenue and Hawthorn Lane and only about 150 yards from the apartments in Green Lane. The ST Lounge is within a residential area.

There are many residences within a short distance of the club, in Grove Avenue, in Green Lane and in Hawthorn Lane. Water Lane, with many residential roads off, is close, too.

The lounge is near to schools, nurseries and the Leisure Centre.

Grove Street, a pedestrianised area, is probably the most focal part of the town. During term-time, the lounge is passed many times a day, by children making their way to schools and nurseries, such as Wilmslow Prep, Wilmslow High, the nursery near Ten Little Monkeys, the Leisure Centre, which is used regularly by children.

The ST Lounge is near parks and other recreational areas used by children.


We object to the application for a Sex Establishment licence, in respect of Grove Street, Wilmslow for the following reasons:


Dear Committee,

I write to you to urge you not to renew the licence for this lap-dancing club.

Unfortunately, I was unable to object to the application for a licence in December 2011, as I do not normally buy the Manchester Evening News, where the notice was placed. In fact, very few people did see the notice, so the granting of a licence in no way reflected the feelings of the residents of Wilmslow.

My objection is based on the inappropriateness of such a venue in the small, pleasant market town of Wilmslow. It is not a city, where such a business could possibly be accommodated. Grove Street itself is a much-used pedestrianised thoroughfare, frequented by people of all ages, with benches for relaxing and a flower stall. Close to it are residential streets, St. Teresa's Catholic Church and Wilmslow Preparatory School. On the street are cafes and shops to which parents take their children. Indeed, Clarks Shoes, Tiny Soles, Foot Asylum and Claire's Accessories are just yards from the club. All in all, it is a family shopping and leisure area.

I feel that the issue of safety should not be overlooked, especially as there was a recent vicious attack on a woman who had been performing in the club. I, for one, would avoid Grove Street in the evening and I believe others feel the same. This avoidance will no nothing to help Wilmslow to be a vibrant centre and could have an adverse effect on its prosperity.

In the light of the fact that the Cheshire East policy on the licensing of sexual entertainment venues is to consider "the character of the relevant locality" I beg you to reconsider and to refuse renewal of the licence for this strip club.


Although I do not live in Wilmslow, I do visit the area for shopping, meeting friends and going to the many family restaurants that are situated there.

I feel strongly that the Council should reconsider the location of a sex club offering sexual entertainment. This club has to be walked past when going to the leisure centre, train station and bus stops, to and from restaurants such as Pizza Express and Gourmet Burger. The Stolen Lamb, Barinda and Ayo Gurkhali are just a few metres from the club.

School facilities and the leisure centre are now open very late in the evening, as are DVD shops, Tesco Express, the BP Garage shop and Morrisons. Also, many Churches have evening Mass and events.

All these events, plus friends simply visiting friends, and children just visiting other children, often necessitate walking past this club. I feel that situating a club so near Churches, residential areas and parks and leisure centres is not only totally inappropriate, but will inevitably lead to businesses closing down as other people boycott the area.

Since I first became aware of what has been happening, all the publicity about Jimmy Saville has come to light, and this has made me feel all the more strongly that this sort of club should not be allowed to operate in Wilmslow. I hope that you agree.

We would like to make the following representations regarding this application. Cheshire East resolved that to adopt the provisions of Schedule 3 of the Local Government (Miscellaneous Provisions) Act 1982, as amended by the Policing and crime Act 2009, and apply them within its borough. This particularly refers to the "character of the relevant locality" and "the use to which premises in the vicinity are put".

The character of the relevant locality.

Residential areas.

The St Lounge is located very near to a large number of residential areas- most of the area within a 100 metre radius is residential. In particular, many elderly residents have no choice but to use Boots' pharmacy, which forces them to walk past the establishment.

Central location.

The establishment is located in an area which people who need to travel from one end of town to the other would be forced to pass, whether they want to or not. Why should we force people to pass something which might distress them?

Women, in particular, returning home from Wilmslow Station may be put under stress and suffer harassment, by having to walk past a queue of customers for the establishment. Patrons of sex establishments are almost exclusively male, often under the influence of alcohol; this would make the likelihood of harassment even greater.

The use to which premises in the vicinity are put.

Churches

St Teresa's, St Bartholomew's and Wilmslow Methodist Church are all within 200 metres of the establishment. The proximity to these places of worship is a gross affront to the sensibilities of religious members of our community and their families.


Establishments used by families, children and the elderly.
