Hi Brenda,

In respect of the objection received in relation to the premises licence application for [88-90 Chestergate, Macclesfield](#), I have discussed with my client and can confirm the following:

- We have applied for licensable activities to take place Sunday to Thursday 08:00 until 23:00 and Friday and Saturday 08:00 until midnight. We would like those hours to remain so that if the later hours are permitted by planning, my client will have the correct hours on both the licensing and planning. My client is aware that the lesser hours out of planning and licensing should be adhered to and so even if these hours are granted now, they cannot and will not be traded unless and until planning has been permitted.
- We are happy to withdraw the provision for live and recorded music and play background music only
- We are happy to amend the emptying of waste into refuse bins outdoors to 09:00 and 19:00 as per the planning condition
- Remove the condition in respect of windows and doors being open until 23:00 – air conditioning has been fitted and therefore we are happy for the windows and doors to be closed at all times safe for access and egress
- There is no proposal to use any external area save for any smokers.

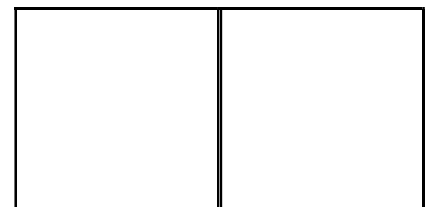
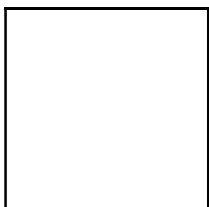
Would you please confirm that based on the above agreements that this satisfies your concerns and would be happy to withdraw your objection?
